CERTIFICATE OF SERVICE

1. I, Leanne V. Rehder Scott, depose and say that I am employed by Kurtzman Carson Consultants LLC (“KCC”), the claims, noticing and administrative agent for the Debtors in the above-captioned case. I submit this Certificate in connection with the service of solicitation materials (the “Solicitation Packages”) for the *Modified Disclosure Statement for Chapter 11 Plan of Liquidation for Pareteum Corporation and Certain of its Affiliates* [Docket No. 300] (the “Disclosure Statement”) and the *Modified Chapter 11 Plan of Liquidation for Pareteum Corporation and Certain of its Affiliates* [Docket No. 299] (the “Plan”). I am over the age of 18 and not a party to this action. Except as otherwise noted, I could and would testify to the following based upon my personal knowledge.

2. On May 19, 2022, the Court entered the *Order (I) Authorizing and Approving the Appointment of Kurtzman Carson Consultants LLC as Claims and Noticing Agent to the Debtors, Effective Nunc Pro Tunc to the Petition Date, and (II) Granting Related Relief* [Docket No. 43].

3. On July 13, 2022, the Court entered the *Order Authorizing Employment and Retention of Kurtzman Carson Consultants LLC as Administrative Advisor to the Debtors, Effective Nunc Pro Tunc to the Petition Date* [Docket No. 218].

4. Consistent with its retention as claims, noticing, and administrative agent, KCC is charged with, among other things, printing and distributing Solicitation Packages to creditors and other interested parties pursuant to the instructions set forth in the *Debtors’ Application for an Order (I) Approving Certain Key Dates Relating to Confirmation of the Debtors’ Plan, Including Scheduling a Combined Hearing to Consider Approval of Debtors’ Disclosure Statement and Plan; (II) Approving the Form and Manner of Combined Hearing Notice; (III) Approving Debtors’ Disclosure Statement on a Provisional Basis; (IV) Approving (A) Procedures for*

The Court entered an *Order (I) Approving Certain Key Dates Relating to Confirmation of the Debtors’ Plan, Including Scheduling a Combined Hearing to Consider Approval of the Debtors’ Disclosure Statement and Plan; (II) Approving the Form and Manner of Combined Hearing Notice; (III) Approving Debtors’ Disclosure Statement on a Provisional Basis; (IV) Approving (A) Procedures for Solicitation, (B) Forms of Ballots, (C) Procedures for Tabulation of Votes, and (D) Procedures for Objections; and (V) Establishing a Bar Date for Filing Administrative Claims Arising from the Petition Date Through and Including August 31, 2022 [Docket No. 296] (the “Solicitation Procedures Order”) on August 22, 2022.**
