



## Schedule to Administrative Claim

In re: iPass, Inc.

**Creditor: Comcast Cable Communications Management, LLC (“Comcast”)**

This Schedule supplements the information stated in the accompanying Administrative Claim and shall constitute part of the Administrative Claim.

### **I. Basis for the Administrative Claim**

On March 15, 2022 (the “Petition Date”), iPass, Inc. (the “Debtor”) and its affiliated debtors each filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code (the “Bankruptcy Code”). Since the Petition Date, Comcast has provided internet, video, voice and other services (the “Services”), as well as the equipment or devices necessary for the Services (the “Comcast Equipment”) pursuant to various service agreements (the “Service Agreements”) governing accounts that are in the Debtor’s name (the “Service Accounts”). The Service Agreements govern the provision of the Services for several hundreds of individual accounts. The individual accounts are billed in the aggregate to the Service Accounts on a monthly basis.

The Debtor believes that the Service Agreements were transferred to a third party as part of a spinoff and sale transaction that was consummated prior to the Petition Date. Since the Service Accounts remain in the Debtor’s name, Comcast files this Administrative Claim in an abundance of caution to preserve its rights.

### **II. Calculation of the Administrative Claim**

As of August 31, 2022, the aggregate unpaid balance of the Service Accounts was \$258,588.75, on account of unpaid charges for Services rendered after the Petition Date. The invoices for the Service Accounts are voluminous, as they include the information for several hundred individual accounts, and will be provided upon request.

Accordingly, Comcast asserts an administrative claim in the amount of \$258,588.75.
