**DECLARATION OF ANDRES A. ESTRADA  
WITH RESPECT TO SOLICITATION AND THE  
TABULATION OF VOTES ON THE DEBTORS' COMBINED  
DISCLOSURE STATEMENT AND CHAPTER 11 PLAN OF LIQUIDATION**

I, Andres A. Estrada, hereby declare under the penalty of perjury:

1. I am a Managing Director of Corporate Restructuring Services employed by Kurtzman Carson Consultants LLC dba Verita Global ("Verita"), whose main business address is 222 N. Pacific Coast Highway, 3<sup>rd</sup> Floor, El Segundo, California 90245.

2. I submit this declaration (this "Declaration") with respect to the solicitation of votes and the tabulation of ballots cast on the *Debtors' Combined Disclosure Statement and Chapter 11 Plan of Liquidation* [Docket No. 1410] (the "Combined Plan and Disclosure Statement").<sup>2</sup> Except as otherwise noted, all facts set forth herein are based on my personal knowledge, knowledge that I acquired from individuals under my supervision, and my review of relevant documents. I am authorized to submit this Declaration on behalf of Verita. If I were called to testify, I could and would testify competently as to the facts set forth herein.

3. The Bankruptcy Court authorized Verita's retention (a) as claims and noticing agent to the Debtors on March 22, 2024 pursuant to the *Order Appointing Kurtzman Carson Consultants LLC as Claims and Noticing Agent Effective as of the Petition Date* [Docket No. 81], and (b) as administrative advisor to the Debtors on April 22, 2024 pursuant to the *Order Authorizing the Debtors to Retain Kurtzman Carson Consultants LLC as Administrative Advisor to the Debtors and Debtors in Possession, Effective as of the Petition Date* [Docket No. 214] (together, the "Retention Orders"). The Retention Orders authorize Verita to assist the Debtors with, among other things, the service of solicitation materials and tabulation of votes cast to accept or reject the Combined Plan and Disclosure Statement. Verita and its employees have considerable experience in soliciting and tabulating votes to accept or reject chapter 11 plans.

**SERVICE AND TRANSMITTAL OF  
SOLICITATION PACKAGES AND THE TABULATION PROCESS**

4. On April 21, 2025, the Bankruptcy Court entered the *Order (I) Approving the Combined Plan and Disclosure Statement on an Interim Basis for Solicitation Purposes Only; (II) Establishing the Deadline for Administrative Expenses Claims; (III) Establishing Solicitation and Voting Procedures; (IV) Approving the Form of Ballots and Solicitation Materials; (V) Establishing the Voting Record Date; (VI) Fixing the Date, Time, and Place for the Combined Hearing and the Deadlines for Filing Objections Thereto; and (VII) Granting Related Relief* [Docket No. 1413] (the "Interim Approval and Procedures Order"), establishing procedures to solicit votes from and tabulate Ballots submitted by Holders of Claims entitled to vote on the Combined Plan and Disclosure Statement. Verita adhered to the procedures outlined in the Interim Approval and Procedures Order and I supervised the solicitation and tabulation performed by Verita's employees.

5. Pursuant to the Interim Approval and Procedures Order, Verita transmitted Solicitation Packages to those Holders of Claims entitled to vote on the Combined Plan and

Disclosure Statement as of the Voting Record Date, pursuant to the Interim Approval and Procedures Order. Only Holders of Claims in Class 1 (Prepetition Lender Claims) and Class 4 (General Unsecured Claims) (the “Voting Classes”) were entitled to vote to accept or reject the Combined Plan and Disclosure Statement. In lieu of Solicitation Packages, all known holders of claims in Classes 2 (Other Secured Claims) and 3 (Priority Claims) (collectively, the “Non-Voting Classes”) received the Combined Hearing Notice, Non-Voting Notice and Opt-In Election Form. Furthermore, Verita caused the Combined Hearing Notice to be served on: (a) all persons or entities that have filed, or are deemed to have filed, a proof of Claim or request for allowance of Claim as of the Voting Record Date (as defined herein); (b) all persons or entities listed on the Schedules as holding a Claim or potential Claim; (c) the Securities and Exchange Commission and any regulatory agencies with oversight authority of the Debtors; (d) the Internal Revenue Service; (e) the United States Attorney’s office for the District of Delaware; (f) other known Holders of Claims(or potential Claims) and Interests; (g) all entities known by the Debtors to hold or assert a lien or other interest in the Debtors’ property; (h) all parties listed on the Debtors’ creditor matrix; and (i) any other parties that have requested notice pursuant to Bankruptcy Rule 2002 (to the extent not otherwise included in the foregoing), pursuant to the Interim Approval and Procedures Order. Per the Combined Hearing Notice, the Combined Plan and Disclosure Statement and the Solicitation and Voting Procedures were made available on the Case Information Website at <https://www.veritaglobal.net/Petersen>.

6. Verita worked closely with counsel to the Debtors to identify the Holders in the Voting Classes entitled to vote on the Combined Plan and Disclosure Statement and to coordinate the distribution of the Solicitation Packages to such Holders. A detailed description of Verita’s distribution of solicitation materials to Holders entitled to vote on the Combined Plan and Disclosure

Statement is set forth in the *Certificate of Service*, which was filed with the Bankruptcy Court of May 15, 2025 [Docket No. 1582].

7. In accordance with the Interim Approval and Procedures Order, Verita received, reviewed, determined the validity of, and tabulated the Ballots submitted to vote on the Combined Plan and Disclosure Statement. Each Ballot submitted to Verita was date-stamped, scanned, assigned a Ballot number, entered into Verita's voting database, and processed. The deadline for Ballots to be received by Verita was May 16, 2025 at 4:00 p.m. (Eastern Time) (the "Voting Deadline").

8. Per the Interim Approval and Procedures Order, to be included in the tabulation results as valid, a Ballot must have been (a) properly completed pursuant to the Interim Approval and Procedures Order, (b) executed by the relevant holder entitled to vote on the Combined Plan and Disclosure Statement (or such holder's representative), (c) returned to Verita via an approved method of delivery set forth in the Interim Approval and Procedures Order, and (d) received by Voting Deadline.

9. Every validly cast Ballot was considered in the tabulation. The final tabulation of votes cast by timely and properly completed Ballots received by Verita is attached hereto as **Exhibit A**. The detailed Ballot reports for the Voting Classes are attached hereto as **Exhibit A-1** and **Exhibit A-2**. It is my understanding that pursuant to stipulations between the Debtors and Berkadia and Wells Fargo, their votes to reject the Plan will be deemed votes to accept the Plan upon the Court's approval of the stipulations. A report of Ballots excluded from the final tabulation, and the reasons for exclusion of such Ballots is attached hereto as **Exhibit B**. All such Ballots were not counted because they did not satisfy the requirements for a valid Ballot set forth in the Interim Approval and Procedures Order.

10. Verita also reviewed and documented elections recorded on the Ballots and Opt-In Election Forms from creditors in the Voting Classes and Non-Voting Classes that checked the box on such Ballot or Opt-In Election Form to opt in to the releases by Holders of Claims and Interests. A report of all Holders of Claims and Interests who opted into the releases is attached hereto as **Exhibit C**. For avoidance of doubt, this Declaration does not certify the validity or enforceability of any opt in elections received, including those reported on Exhibit C, but rather is providing these opt in election results for reporting and information purposes only.

### CONCLUSION

To the best of my knowledge, information and belief, the foregoing information concerning the distribution, submission, and tabulation of Ballots in connection with the Combined Plan and Disclosure Statement is true.
