1. On April 23, 2024, the United States Bankruptcy Court for the District of Delaware (the “**Court**”) entered the *Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Retained Professionals* [Docket No. 235] (the “**Interim Compensation Order**”).

2. In accordance with the Interim Compensation Order, on August 22, 2025, Greenberg Traurig, LLP, (“**Greenberg**”) filed and served its *Combined Sixteenth Monthly Fee Application of Greenberg Traurig, LLP, Counsel to the Official Committee of Unsecured Creditors*

*of SC Healthcare Holdings, LLC, et al., for Allowance of Compensation and Reimbursement of Expenses for the Period from July 1, 2025 through August 7, 2025* [Docket No. 1772] (the “**Application**”).

3. Pursuant to the *Notice of Application* [Docket No. 1772-2], objections were due by 4:00 p.m. (Eastern Prevailing Time) on September 5, 2025. As of the date hereof, personnel at Greenberg have not received any responses or objections to the Application.

4. Accordingly, pursuant to the Interim Compensation Order and the Application, the Debtors are authorized to pay Greenberg 80% of the fees requested in the Application, or \$7,095.80, and 100% of the expenses requested in the Application, or \$4,011.99 for a total of \$11,107.79, on an interim basis without further Court order.
