**FOURTH NOTICE OF REVISED DATES RELATING TO  
BIDDING PROCEDURES DEADLINES**

**PLEASE TAKE NOTICE** that, on May 1, 2024, the above-captioned debtors and debtors in possession (collectively, the “Debtors”) in these chapter 11 cases, filed with the United States Bankruptcy Court for the District of Delaware (the “Court”) a motion [Docket No. 264] (the “Motion”) for the entry of an order (the “Bid Procedures Order”)<sup>2</sup> (i) approving (a) the Bidding Procedures, substantially in the form attached to the Bid Procedures Order as Exhibit 1; (b) authorizing the Debtors to designate one or more stalking horse bidders (the “Stalking Horse Bidders”); (c) setting the deadline for potential bidders to submit a proposal to purchase the Assets (as defined below) (the “Bid Deadline”), authorizing and scheduling an auction (the “Auction”), and authorizing and scheduling hearings with respect to the approval of a proposed sale transaction (the applicable “Sale Hearing”); (d) authorizing and approving the form and manner of the Sale Notice; (e) authorizing and approving the Notice of Assumption, Assignment, and Sale regarding the Debtors’ potential assumption and assignment of the Assigned Contracts and of the Debtors’ calculation of the amount necessary to cure any defaults thereunder (the “Cure Costs”); and (f) authorizing and approving procedures for the assumption and assignment of the Assigned Contracts and the determination of Cure Costs with respect thereto; (ii) authorizing the sale of all or substantially all of the Debtors’ assets (the “Assets”), free and clear of all liens, claims, encumbrances, and other interests pursuant to section 363(f) of the Bankruptcy Code (collectively, the “Sale Transactions”); and (iii) granting related relief.

**PLEASE TAKE FURTHER NOTICE** that, on May 21, 2024 the Court entered the Bid Procedures Order authorizing the Debtors to solicit bids for the purchase of the Assets and, if one

or more Qualified Bids are received within the requirements and timeframe specified by the Bidding Procedures, conduct the Auction to select the Successful Bidder. If held, the Auction will be governed by the Bidding Procedures approved pursuant to the Bid Procedures Order.

**PLEASE TAKE FURTHER NOTICE** that, on June 13, 2024, the Debtors filed the *Notice of Revised Dates Relating to Bidding Procedures Deadlines* [Docket No. 519] modifying certain of the important dates and deadlines in connection with the Sale Process.

**PLEASE TAKE FURTHER NOTICE** that, on June 20, 2024, the Debtors filed the *Second Notice of Revised Dates Relating to Bidding Procedures Deadlines* [Docket No. 545], thereby modifying the deadline to designate Stalking Horse Bidders (the “Stalking Horse Bidder Deadline”).

**PLEASE TAKE FURTHER NOTICE** that, on June 24, 2024, the Debtors filed the *Third Notice of Revised Dates Relating to Bidding Procedures Deadlines* [Docket No. 555], thereby further extending the Stalking Horse Bidder Deadline.

**PLEASE TAKE FURTHER NOTICE** that, pursuant to the Bidding Procedures and Bid Procedures Order, in consultation with the Consultation Parties, the Debtors hereby modify certain of the important dates and deadlines in connection with the Sale Process as follows:
