PLEASE TAKE FURTHER NOTICE that, on May 23, 2023, the Debtors filed their motion [Docket No. 23] (the "**Motion**")² for entry of (a) an order (i) approving bidding procedures, substantially in the form attached as Annex 1 to the Bidding Procedures Order (the "**Bidding Procedures**"), to govern the marketing and sale of all or substantially all of the Debtors' assets (the "**Assets**"), (ii) approving bid protections in connection therewith, (iii) authorizing the Debtors to schedule an auction to sell the Assets (the "**Auction**"), (iv) scheduling the hearing to approve a sale of the Assets (the "**Sale Hearing**"), (v) approving the form and manner of notice of the proposed sale transaction, the Bidding Procedures, the Auction, the Sale Hearing, and related dates and deadlines, and (vi) authorizing procedures governing the assumption and assignment of certain

PLEASE TAKE FURTHER NOTICE that, on July 31, 2023, the Court entered the Sale Order [Docket No. 223] authorizing the Debtors to sell substantially all of their Assets to the Purchaser, Plastiq, Powered by Priority, LLC. In accordance with the Sale Order, the Sale closed on a July 31, 2023.

PLEASE TAKE FURTHER NOTICE that, pursuant to \P 26 of the Sale Order, the Debtors intend to assume and assign to the Purchaser certain executory contracts and unexpired leases (the "Assumed Contracts").
