

Upon the ex parte motion (the "Motion")<sup>2</sup> filed by the above-captioned debtors and debtors in possession (the "Debtors") seeking entry of an order authorizing the joint administration and procedural consolidation of the Debtors' Chapter 11 Cases and related relief; and the Court, having reviewed the Motion and having heard the statements of counsel in support of the relief requested in the Motion at the hearing (the "Hearing"), and having granted interim relief on the Motion, and upon the Declaration of Richard Hague in Support of Chapter 11 Petition and First Day Motions, and for cause shown, finds that the Court has jurisdiction over this matter under 28 U.S.C. §§ 157 and 1334, that this is a core matter under 28 U.S.C. § 157(b)(2), that notice of the Motion and the Hearing were sufficient under the circumstances and that no further notice need be given; and the legal and factual bases set forth in the Motion and at the Hearing establish just cause for the relief granted herein,

### IT IS HEREBY ORDERED AS FOLLOWS:

- 1. The Motion is GRANTED as provided herein on a final basis.
- 2. The Chapter 11 Cases filed by the three Debtors, PolarityTE MD, Inc. (1555) ("PTE MD") (Case No. 23-bk-22360); and PolarityTE, Inc. (6882) ("PTE NV") (Case No. 23-bk-22361); and PolarityTE, Inc. (9524) ("PTE") (Case No. 23-bk-22358-KRA) shall be procedurally consolidated and jointly administered under the docket for PolarityTE Inc., Case No. 23-bk-22358-KRA.
