

# FINAL ORDER AUTHORIZING PAYMENT OF CERTAIN PREPETITION WAGES, SALARIES, EMPLOYEE BENEFIT PROGRAMS, AND OTHER COMPENSATION AND RELATED RELIEF

Upon the motion (the "Motion")<sup>2</sup> filed by the above-captioned debtors and debtors in possession (the "Debtors") seeking entry of an order authorizing the Debtors to honor certain prepetition obligations to its Employees, including its Payroll Obligation; and the Court, having reviewed the Motion and having heard the statements of counsel in support of the relief requested in the Motion at the hearing before the Court (the "Hearing"), and the Court having granted Interim Relief on the Motion, finds that the Court has jurisdiction over this matter under 28 U.S.C. §§ 157 and 1334, that this is a core matter under 28 U.S.C. § 157(b)(2), that notice of the Motion and the Hearing were sufficient under the circumstances and that no further notice need be given; and the legal and factual bases set forth in the Motion and at the Hearing establish just cause for the relief granted herein and that such relief is necessary to avoid immediate and irreparable harm to the Debtors' estates,

#### THEREFORE, IT IS HEREBY ORDERED AS FOLLOWS:

1. The Motion is GRANTED as provided herein on a final basis.

- 2. The Debtors are authorized, but not required, on a final basis to pay prepetition wages, salaries, payroll taxes, and related expenses for their Employees in accordance with its existing policies. These prepetition obligations may include, without limitation, (a) amounts owed to the Employees for wages and salaries; (b) benefit claims of Employees (including, without limitation, medical, dental, or life insurance); and (c) federal and state payroll-related taxes, deductions, and withholdings in respect to various benefits and fees due to third-party payroll and benefits administrators; provided, however, that no payments on account of prepetition employee wages shall exceed the amount of \$15,150 provided for in 11 U.S.C. § 507(a)(4).
- 3. Notwithstanding Bankruptcy Rules 6004, 7062, or 9014, the terms and conditions of this Final Order shall be immediately effective upon its entry.
- 4. Nothing in this Final Order constitutes a waiver of any defense or right, admission of liability of the Debtors on any claim. or the assumption of any executory contract.
- 5. The Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Final Order.
