Summary of Relief Requested. At the Hearing, the Court will consider relief requested in the Motions including allowance and payment of compensation for services rendered to the Debtors as follows:

- **Parsons Behle & Latimer**, (i) fees earned in the amount of \$15,156.00 and (ii) for reimbursement for actual and necessary expenses for expenses incurred in the amount of \$120.00, for a total allowed administrative priority expense claim in the amount of \$15,276.00 for the period of time between November 1, 2024 through February 26, 2025.
- **Rocky Mountain Advisory**, (i) fees earned in the amount of \$14,831.00 and (ii) reimbursement for actual and necessary expenses for expenses incurred in the amount of \$631.30, for a total allowed administrative priority claim in the amount of \$15,462.30 for the period of time between November 1, 2024 through February 26, 2025.
