**Summary of Relief Requested.** At the Hearing, the Court will consider relief requested in the Objection that Dr. Lough's Claim No. 2 should be disallowed under 11 U.S.C. § 502(b)(1) as Dr. Lough's claim is not enforceable against the Debtors or property of the Debtors. The Liquidating Trustee further objects to Dr. Lough's claim on the basis that his claim for indemnification is disallowed under 11 U.S.C. § 502(e)(1)(B).
