

ORDER SUSTAINING OBJECTION TO PROOF OF CLAIM NO. 7-2 OF MATTHEW ROBERT RIGNELL

Upon the objection (the "Objection")² John Curtis, as the Liquidating Trustee of the bankruptcy estate for debtors PolarityTE, Inc. ("PTE"), PolarityTE, MD Inc. ("PTE MD"), and PolarityTE, Inc. ("PTE NV") (together, the "Debtors"), moved the Court for entry of an order disallowing and reducing to \$0 proof of claim no. 7-2 filed by Matthew Robert Rignell (the "Claimant") in Case No. 23-22360 as duplicative [Dkt. No. 236] and the Court, having reviewed the Objection, no opposition having been filed, and the Court finding that it has jurisdiction over this matter under 28 U.S.C. §§ 157 and 1334, that this is a core matter under 28 U.S.C. § 157(b)(2), that notice of the Objection [Dkt. No. 238] were sufficient and proper, and that no further notice is necessary, and just cause is found,

THEREFORE, IT IS HEREBY OREDERED:

- 1. The Objection is SUSTAINED.
- 2. Claim No. 7-2 in Case No. 23-22360 is disallowed.
- 3. This Order shall be immediately effective upon its entry.
