

<u>AMENDED</u> ORDER APPROVING THE STIPULATION RESOLVING PROOFS OF CLAIM NOS. 3-1, 10-2, 4-1, and 6-2 OF RICHARD HAGUE

Upon consideration of the *Stipulation Resolving Proofs of Claim Nos. 3-1 and 10-2 (in Case No. 23-22358) and 4-1 and 6-2 (in Case No. 23-22360) Filed by Richard Hague* (the "**Stipulation**")² [Dkt. No. 243] submitted by John Curtis, as the Liquidating Trustee of the bankruptcy estate for debtors PolarityTE, Inc. ("PTE"), PolarityTE, MD Inc. ("PTE MD"), and PolarityTE, Inc. ("PTE NV") (together, the "Debtors"); and no opposition having been filed; and the Court finding that it has jurisdiction over this matter under 28 U.S.C. §§ 157 and 1334, that this is a core matter under 28 U.S.C. § 157(b)(2), that notice of the Objection [Dkt. No. 245] was sufficient and proper, and that no further notice is necessary; and the Court having found and determined that the relief sought in the Stipulation is in the best interests of the Debtors, its estates, creditors, and all parties-in-interest, and just cause is found,

THEREFORE, IT IS HEREBY OREDERED:

- 1. The Stipulation is APPROVED.
- 2. Claim No. 3-1 in Case No. 23-22358 shall be reduced to an unsecured claim of \$450,000.00, of which \$15,150.00 is allowed as a priority unsecured claim.

² Capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Stipulation.

- 3. Claim No. 10-2 in Case No. 23-22358 shall be allowed as an priority unsecured claim of \$50,192.32, which includes a priority unsecured claim of \$15,150.00.
- 4. The Debtors' post-petition payment of \$6,923.08 shall be treated as a partial payment of the allowed priority unsecured claim.
 - 5. Claim No. 4-1 in Case No. 23-22360 shall be disallowed and reduced to \$0.
 - 6. Claim No. 6-2 in Case No. 23-22360 shall be disallowed and reduced to \$0.
- 7. The Parties are authorized to take all actions necessary to effectuate the agreement reached pursuant to the Stipulation and authorized by this Order.
 - 8. This Order shall be immediately effective upon its entry.
- 9. The Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order.
