ORDER SUSTAINING OBJECTION TO PROOF OF CLAIM NO. 16-1 OF COURTNEY LISA CUSHNIR

Upon the objection (the “**Objection**”)² John Curtis, as the Liquidating Trustee of the bankruptcy estate for debtors PolarityTE, Inc. (“**PTE**”), PolarityTE, MD Inc. (“**PTE MD**”), and PolarityTE, Inc. (“**PTE NV**”) (together, the “**Debtors**”), moved the Court for entry of an order disallowing and reducing to \$0 proof of claim no. 16-1 filed by Courtney Lisa Cushnir (the “**Claimant**”) in Case No. 23-22358 as duplicative [Dkt. No. 237] and the Court, having reviewed the Objection, no opposition having been filed, and the Court finding that it has jurisdiction over this matter under 28 U.S.C. §§ 157 and 1334, that this is a core matter under 28 U.S.C. § 157(b)(2), that notice of the Objection [Dkt. No. 238] were sufficient and proper, and that no further notice is necessary, and just cause is found,

THEREFORE, IT IS HEREBY ORDERED:

1. The Objection is SUSTAINED.
2. Claim No. 16-1 in Case No. 23-22358 is disallowed.
3. Claim No. 8-2 in Case No. 23-22358 is allowed in the priority unsecured amount of \$15,150 and the nonpriority unsecured amount of \$2,430.94.
4. This Order shall be immediately effective upon its entry.
