LIQUIDATING TRUSTEE'S MOTION TO APPROVE FINAL DISTRIBUTION, AUTHORIZE DESTRUCTION OF DEBTORS' REMAINING RECORDS, AND FOR A FINAL DECREE AND ORDER CLOSING CASE

¹ The Debtors in these jointly administered chapter 11 cases, along with the last four digits of each Debtor's federal tax identification number, are PolarityTE, Inc. (9524); PolarityTE MD, Inc. (1555); and PolarityTE, Inc. (6882). The location of the Debtors' service address is 1960 S. 4250 W., Salt Lake City, UT 84104.

John Curtis, as the Liquidating Trustee ("Liquidating Trustee") for the combined debtors PolarityTE, Inc. ("PTE"), PolarityTE, MD Inc. ("PTE MD"), and PolarityTE, Inc. ("PTE NV") (together, the "Debtors") hereby submits this *Motion to Approve Final Distribution and For A Final Decree and Order Closing Case* (this "Motion"), seeking an order from this Court approving the final distribution as set forth herein, authorizing the Trustee to destroy the remaining business records of the Debtors, for a final decree and order closing case pursuant to 11 U.S.C. § 350 and Fed. R. Bank. P. 3002 and Local Rule 3002-1, and discharging the Trustee. In support hereof, the Debtor states as follows:

JURISDICTION AND BASES FOR RELIEF

- 1. The Court has jurisdiction over this matter under 28 U.S.C. §§ 157 and 1334.
- 2. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2).
- 3. Venue is proper in this District under 28 U.S.C. §§ 1408(1) and 1409.

BACKGROUND

- 4. The Debtors were a clinical stage biotechnology company that marketed and sold a product to treat complex wounds.
- 5. Due to U.S. Food and Drug Administration's ("FDA") guidance, the Debtors were unable to continue to sell their product without FDA approval which required expensive clinical trials.
- 6. Without sales revenue the Debtors were unable to continue to fund the clinical trials.
- 7. Rather than abandon the clinical trials and their promising product, on June 6, 2023 (the "Petition Date"), each Debtor filed a petition for relief under its Chapter 11 Case in the Bankruptcy Court.

- 8. On July 31, 2023, the Court approved the sale of substantially all the Debtors' operating assets to Grander Acquisition LLC ("**Grander**" and the "**Grander Sale**") (ECF 107) for the price of \$6,500,000.
- 9. The deadline for parties other than governmental entities to file proofs of claim against the Debtors expired on October 4, 2023 (the "General Bar Date") (ECF 26).
- 10. The deadline for governmental entities to file proofs of claim against the Debtors expired on December 4, 2023 (the "Governmental Bar Date", together with the General Bar Date, the "Bar Dates"). Id.
- 11. As of the filing of this Motion, 25 proofs of claim have been filed against the Debtors (the "**Proofs of Claim**").
- 12. On January 27, 2025, the Court confirmed (the "Confirmation Order") (ECF 190)

 Debtors' liquidating plan of reorganization (the "Plan").
- 13. Under the Plan the Effective Date occurred on February 26, 2025, at which time John Curtis was appointed as the Liquidating Trustee. (See Notice of Occurrence of Effective Date of Debtors' Plan of Liquidation Dated August 15, 2024 Under Chapter 11 of the Bankruptcy Code, ECF 194).
- 14. The Liquidating Trustee has resolved all outstanding objections to the Proofs of Claim.
- 15. The Liquidating Trustee has completed the steps necessary to complete the wind down as set forth in the Plan.
- 16. The Liquidating Trustee hereby seeks authority to make a final distribution to equity holders as set forth below.

Proposed Distributions

Pursuant to the Plan, the Liquidating Trustee has completed its claims resolution process and has resolved any outstanding issues related to the dissolution of the Debtors. As such, the Liquidating Trustee is prepared to make a final distribution in the case. The Liquidating Trustee's proposed distribution is set forth in the attached **Exhibit A**.

All allowed Proofs of Claim have been or will be paid in full. After payment of all allowed Proofs of Claim, outstanding fees, expenses, and costs of administering the estate, there will be approximately \$3.2 million available for distribution to equity holders.

On or about August 25, 2025 the Liquidating Trustee entered into a Paying Agent Agreement with Equity Stock Transfer, LLC ("EST") wherein EST will maintain, administer and dispose of the remaining funds distributable to equity holders.

The remaining funds will be paid on a pro rata basis, as set forth in the Plan, to equity holders as set forth in the attached **Exhibit B**. All payments to equity holders shall be paid to the holder of the stock certificate. The majority of Equity holder distributions are being paid to by EST to Cede & Co., as nominee for the Depository Trust Company ("Cede & Co"), which is the named holder of the stock certificates held in "street name" for a large number of equity holders. Cede & Co will be responsible for distributing funds to the brokerage houses or individual equity holders and brokerage houses may ultimately deliver the distribution to individual equity interests. However, the Liquidating Trustee is providing notice of the Motion to all equity holders listed in this case and all persons on the mailing matrix. Any objections to the proposed distributions to equity holders must include a copy of the stock certificate listing the objecting party's name to ensure the objecting party is the proper party to assert any such objection.

Upon completion of the final distribution, the Debtors' bankruptcy estate will be fully administered. As such, the Debtors hereby requests that the Bankruptcy Court enter an order 1) approving the final distribution, authorizing the destruction of the Debtor's remaining business records, 3) enter a Final Decree pursuant to 11 U.S.C. § 350 and Fed. R. Bank. P. 3002 and Local Rule 3002-1 closing the case, and 4) discharging the Trustee.
