**FINAL ORDER (I) APPROVING THE ADEQUATE  
ASSURANCE OF PAYMENT FOR FUTURE UTILITY SERVICES  
PROPOSED BY THE DEBTORS, (II) PROHIBITING UTILITY COMPANIES  
FROM ALTERING, REFUSING, OR DISCONTINUING SERVICES, AND  
(III) APPROVING PROCEDURES BY THE DEBTORS FOR RESOLVING  
ADDITIONAL ASSURANCE REQUESTS**

Upon consideration of the motion (the “Motion”)<sup>2</sup> of the Debtors for entry of an order (i) approving the Debtors’ proposed form of adequate assurance of postpetition payment to the Utility Companies, (ii) establishing Adequate-Assurance Procedures for resolving any objection by the Utility Companies relating to the Proposed Adequate Assurance, and (iii) prohibiting the Utility Companies from altering, refusing or discontinuing service to, or otherwise discriminating against, the Debtors on the basis of the commencement of the Chapter 11 Cases or a debt owed by the Debtors for services rendered prior to the Petition Date, or on account of any perceived inadequacy of the Debtors’ Proposed Adequate Assurance, all as more fully described in the Motion; and upon consideration of the Baker Declaration; and the Court having jurisdiction to consider the Motion and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334; and the matter being a core

proceeding within the meaning of 28 U.S.C. § 157(b)(2); and the venue of this proceeding and this Motion being proper pursuant to 28 U.S.C. §§ 1408 and 1409; and due and sufficient notice of the Motion having been given under the particular circumstances; and it appearing that the relief requested in the Motion is in the best interests of the Debtors, their estates, and their creditors; and after due deliberation thereon; and good and sufficient cause appearing therefor;

**IT IS HEREBY ORDERED THAT, ADJUDGED, AND DECREED THAT:**

1. The Motion is GRANTED on a final basis as set forth herein.

The Debtors are authorized, but not directed to deliver the Ordinary Course Payments to Utility Companies (identified on **Schedule I** hereto) providing postpetition Utility Services, with said payments authorized to begin or continue upon entry of this Order, following any Interim Order that was entered by the Court, as the case may be. The payments authorized by this Order shall not exceed the amounts provided for on **Schedule I**. In the absence of an Adequate Assurance Request (as defined below) delivery of the Ordinary Course Payments, along with any prepetition deposits, shall be deemed sufficient and satisfactory adequate assurance pursuant to section 366 of the Bankruptcy Code.

The following procedures (the “Adequate Assurance Procedures”) are hereby approved with respect to all Utility Companies, including any Subsequently Identified Utility Company:

- a) Except as provided by the Adequate-Assurance Procedures, the Utility Companies will be prohibited from: (i) altering, refusing, or discontinuing services to, or otherwise discriminating against, the Debtors on the basis of the commencement of the Chapter 11 Cases or a debt owed by the Debtors for services rendered prior to the Petition Date, or on account of any perceived inadequacy of the Debtors’ Proposed Adequate Assurance; or (ii) requiring the Debtors to pay a deposit or other security in connection with the provision of postpetition Utility Services, other than any prepetition deposits held by the Utility Companies.
- b) If a Utility Company is not satisfied with the Proposed Adequate Assurance and seeks additional adequate assurance of payment, it

must serve a written request for additional adequate assurance (an “Additional Assurance Request”) upon: (i) the Debtors, c/o David Baker, Aurora Management Partners Inc., 7078 Peachtree Industrial Blvd. Suite #800, Peachtree Corners, GA 30071, dbaker@auroramp.com; (ii) proposed counsel for the Debtors, Cole Schotz P.C., 1201 Wills Street, Suite 320, Baltimore, MD 21231 (Attn: Gary H. Leibowitz (gleibowitz@coleschotz.com) and Holland & Knight LLP, 1901 Sixth Avenue N, Suite 1400, Birmingham, AL 35203 (Attn: Eric T. Ray etray@hklaw.com); (iii) counsel to any statutory committee appointed in the Chapter 11 Cases; and (iv) counsel to Wells Fargo Bank, National Association, as Administrative Agent for the Lender Group (“Pre-Petition Secured Agent”), King & Spalding LLP, 1180 Peachtree Street NE, Suite 1600, Atlanta, GA 30309 (Attn: Jeffrey R. Dutson (jdutson@kslaw.com)) (collectively, the “Adequate Assurance Notice Parties”).

- c) Each Additional Assurance Request must: (i) be made in writing; (ii) set forth the amount and form of additional assurance of payment requested; (iii) set forth the type of Utility Services, any account numbers, and the location(s) for which Utility Services are provided; (iv) include a summary of the Debtors’ payment history to such Utility Company, including whether the Utility Company holds any deposits or other security, and if so, in what amount; (v) set forth why the Utility Company believes the Proposed Adequate Assurance is insufficient; and (vi) provide an email address to which the Debtors may respond to the Additional Assurance Request.
- d) Upon the Debtors’ receipt of an Additional Assurance Request, the Debtors, in consultation with the Pre-Petition Secured Agent, will promptly negotiate with the requesting Utility Company to resolve such Utility Company’s Additional Assurance Request.
- e) Should the Debtors be unable to reach a resolution with respect to an Additional Assurance Request, the Debtors will, upon reasonable notice, calendar the matter (the “Determination Hearing”) for the next regularly scheduled hearing to determine the adequacy of assurance of payment pursuant to section 366(c)(3) of the Bankruptcy Code.
- f) Pending the Determination Hearing, the Utility Company that is the subject of the unresolved Additional Assurance Request is prohibited from altering, refusing, or discontinuing service to the Debtors on account of unpaid charges for prepetition services, the filing of these Chapter 11 Cases, or any objection to the adequacy of the proposed Adequate Assurance.

- g) Any Utility Company that does not serve an Additional Assurance Request in compliance with the procedures herein will be deemed to have received adequate assurance of payment that is satisfactory to such Utility Company within the meaning of Bankruptcy Code section 366(c)(2), subject to each such Utility Company's right to seek a modification of adequate assurance under Bankruptcy Code section 366(c)(3).

The Debtors are authorized, in their sole discretion, to amend the Utility Company List to add or remove any Utility Company, and all provisions of this Order shall apply to any such Subsequently Identified Utility Company that is added to such list; *provided, however*, that if additional Utility Companies are added to the Utility Company List, the Debtors shall: (i) file a copy of any such amendment and serve a copy of the Motion and this Order on any Subsequently Identified Utility Company, along with an amended Utility Company List; and (ii) make all Ordinary Course Payments to such Subsequently Identified Utility Company. Such Subsequently Identified Utility Company shall be permitted to make an Additional Assurance Request in compliance with the Adequate Assurance Procedures after it receives notice of the Motion.

Pending entry of the Final Order and resolution of any Additional Assurance Request, Objection or Determination Hearing, the Utility Companies are prohibited from (a) discriminating against the Debtors, (b) altering, refusing, or discontinuing service to the Debtors, or (c) requiring payment of a deposit or receipt or any other security for continued service other than the Utility Deposit, on the basis of the commencement of the Chapter 11 Cases or a debt owed by the Debtors for services rendered prior to the Petition Date, or on account of any perceived inadequacy of the Debtors' Proposed Adequate Assurance. The Utility Companies are further prohibited from drawing upon any existing security deposit, surety bond, or other form of security to secure future payment for Utility Services, absent further order of this Court.

For the avoidance of doubt, the terms of this Order, including the Adequate Assurance Procedures, shall apply to each Utility Company, notwithstanding any customary business



practices, policies, internal operating procedures, or state or local laws or regulations to the contrary. Any Utility Company that believes its customary business practices, policies, internal operating procedures, or state or local laws or regulations forbid it from accepting the Proposed Adequate Assurance or entitle it to additional adequate assurance shall make an Additional Assurance Request or file an Objection in accordance with this Order.

Nothing herein constitutes a finding that any entity is or is not a Utility Company hereunder or a “utility” within the meaning of Bankruptcy Code section 366, whether or not such entity is listed on the Utility Company List.

The relief granted herein is for all Utility Companies providing Utility Services to the Debtors and is not limited to those parties or entities listed on the Utility Company List.

Nothing in the Motion or this Order or the relief granted (including any actions taken or payments made by the Debtors pursuant thereto) shall be construed as (a) authority to assume or reject any executory contract or unexpired lease of real property, or as a request for the same; (b) an admission as to the validity, priority, or character of any claim or other asserted right or obligation, or a waiver or other limitation on the Debtors’ ability to contest the same on any ground permitted by bankruptcy or applicable non-bankruptcy law; (c) a promise to pay any claim or other obligation; (d) granting third-party-beneficiary status or bestowing any additional rights on any third party; (e) being otherwise enforceable by any third party; or (f) prejudicial to the Debtors’ rights to contest any amounts owed to a Utility Company. Further, nothing contained in this Order shall be deemed to increase, reclassify, elevate to an administrative expense status, or otherwise affect any claim to the extent it is not paid.

Notwithstanding anything to the contrary in the Motion or this Final Order, any payment authorized to be made by the Debtors herein shall be subject to and consistent with the terms and

conditions contained in any orders entered by this Court authorizing the use of cash collateral and any order authorizing postpetition financing (collectively, a “Financing Order”), including compliance with any budget or cash flow forecast in connection therewith. To the extent there is any conflict between this Final Order and a Financing Order, the terms of the Financing Order shall control.

The requirements of Bankruptcy Rule 6003(b) have been satisfied.

The requirements of Bankruptcy Rule 6004(a) are waived.

Notwithstanding Bankruptcy Rule 6004(h), the terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

The Court shall retain jurisdiction to hear and determine all matter arising from the implementation of this Order.
