## FINAL FEE APPLICATION OF AURORA MANAGEMENT PARTNERS FOR COMPENSATION FOR SERVICES AND REIMBURSEMENT OF EXPENSES FOR THE PERIOD FEBRUARY 1, 2024 THROUGH MAY 3, 2024

Pursuant to sections 327, 330, and 331 of chapter 11 of Title 11 of the United States Code (11 U.S.C. §§ 101 et seq., the "Bankruptcy Code"), Rule 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), the Order Authorizing the Retention and Employment of Employ Aurora Management Partners as Financial Advisor to the Debtors and Debtors in Possession Retroactive to the Petition Date, dated November 29, 2023 [Docket No. 269] (the "Retention Order"), and the Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Professionals, dated November 29, 2023 [Docket No. 266] (the "Interim Compensation Order"), Aurora Management Partners ("Aurora"), financial advisor for Premier Kings, Inc., and its debtor affiliates as debtors and debtors in possession in the above-captioned Chapter 11 Cases(each a "Debtor" and collectively, the "Debtors"), hereby submits this Final Fee Application of Aurora Management Partners for Compensation for Services and Reimbursement of Expenses for the Period February 1, 2024 Through May 3, 2024 (the "Fee

<u>Application</u>").<sup>2</sup> Specifically, Aurora seeks (i) final allowance and payment of \$331,448.00 for the reasonable and necessary financial advice that Aurora rendered during the Fee Period to the Debtors; and (ii) final allowance and payment of \$3,236.99 for the actual and necessary expenses that Aurora incurred in connection with such services during the Fee Period, and (iii) final approval of all fees and expenses previously approved in the Interim Fee Order.

#### **BACKGROUND**

1. On October 25, 2023 (the "<u>Petition Date</u>"), Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code, thus commencing the above captioned Chapter 11 Cases(the "<u>Chapter 11 Cases</u>"). The Debtors continue to manage and operate their businesses as debtors in possession under sections 1107 and 1108 of the Bankruptcy Code.

### <u>RELIEF REQUESTED</u>

2. Pursuant to the Retention Order, Aurora is entitled to approval of compensation for fees incurred and reimbursement of expenses. During the Fee Period, Aurora earned fees in the amount of \$331,448.00 and incurred expenses in the amount of \$3,236.99. All services for which compensation is requested by Aurora were performed for or on behalf of the Debtors.

### **ITEMIZATION OF SERVICES RENDERED AND DISBURSEMENTS INCURRED**

3. Attached hereto as **Exhibit "A"** is a schedule of the number of hours expended and fees incurred (on an aggregate basis) by Aurora professionals during the Fee Period with respect to each of the project categories Aurora established in accordance with its internal billing procedures. As reflected in Exhibit "A", Aurora incurred \$331,448.00 in fees during the Fee Period.

4. Attached hereto as **Exhibit "B"** is a schedule of Aurora professionals, including the standard hourly rate for each professional who rendered services to the Debtors in connection with the Chapter 11 Cases during the Fee Period and the title, hourly rate, aggregate hours worked and the amount of fees earned by each professional.

5. Attached hereto as **Exhibit "C"** is a schedule for the Fee Period setting forth the total amount of payment sought with respect to each category of expenses for which Aurora is seeking payment in this Fee Application. All of these disbursements comprise the requested sum for Aurora's out-of-pocket expenses, which total \$3,236.99.

6. Attached hereto as **Exhibit "D"** are the time records of Aurora, which provide a daily summary of the time spent by each Aurora professional during the Fee Period as well as an itemization of expenses by project category.

#### VALUATION OF SERVICES

7. Aurora professionals have expended a total of 787.50 hours in connection with the Chapter 11 Cases during the Fee Period.

8. The amount of time spent by each professional providing services to the Debtors for the Fee Period is fully set forth in detail in attached Exhibits "A" and "B". The enumerated hourly rates are Aurora's normal hourly rates for work of this character. The reasonable value of the necessary services rendered and reasonable expenses incurred by Aurora as financial advisor for the Debtors in the Chapter 11 Cases during the Fee Period is \$331,448.00.

9. Aurora believes that the time entries and expense breakdown included in Exhibit "A" are in compliance with the requirements of Local Rule 2016-1.

10. In accordance with the factors enumerated in 11 U.S.C. § 330, the amount requested is fair and reasonable given (a) the complexity of this case, (b) the time expended, (c) the nature

and extent of the services rendered, (d) the value of such services, and (e) the costs of comparable services other than in a case under this title.

11. This Fee Application covers the period from February 1, 2024 through and including May 3, 2024.

#### SUMMARY OF SERVICES

12. The compensation Aurora seeks is appropriate for the time spent in connection with representing the Debtors in the Chapter 11 Cases and set forth below are brief narrative descriptions of the services rendered for, or on behalf of, the Debtors:

A. <u>Case Administration (B110)</u> - Among other services provided to the Debtors in this category during the Fee Period, Aurora reviewed various pleadings filed in the Chapter 11 Cases to ensure compliance therewith; communicated with various creditors concerning questions and requests for information in connection with the s; drafted, edited, and filed various documents in connection with the Bankruptcy Court's orders or the requirements of the Bankruptcy Administrator; attended and participated in various hearings; and communicated with Debtors' legal counsel, the Committee counsel and the counsel for various creditors regarding multiple issues in connection with the Chapter 11 Cases. Aurora spent a total of 58.80 hours during the Fee Period providing services in this category.

B. <u>Asset Disposition (B130)</u> - Among other services provided in this category during the Fee Period, Aurora advisors engaged in numerous communications with the Debtors and counsel, potential buyers and prospective bidders with respect to a sale process and facilitated the closing of the transaction. During the Fee Period, Aurora provided services in the total amount of 34.10 hours on tasks within this category.

C. <u>Meetings of and Communications with Creditors</u> (B150) – Among other services provided to the Debtors in this category during the Fee Period, Aurora engaged in numerous communications with creditors regarding various aspects of the Chapter 11 Cases. Aurora spent a total of 15.60 hours during the Fee Period providing services in this category.

D. <u>Fee Employment Applications (B160)</u> - Among other services provided to the Debtors in this category during the Fee Period, Aurora advisors reviewed and prepared information and entries identifying Aurora's necessary services and reasonable expenses in connection with the preparation of its fee statements. During the Fee Period, Aurora provided services in the total amount of 5.40 hours on tasks within this category.

E. <u>Assumption/Rejection of Leases and Contracts (B185)</u> - Among other services provided to the Debtors in this category during the Fee Period, Aurora advisors communicated with the Debtors and counsel, counsel for contract counterparties to analyze the treatment of executory contracts and unexpired leases through the sale processes. During the Fee Period, Aurora provided services in the total amount of 3.20 hours on tasks within this category.

F. <u>Other Contested Matters</u> (B190) - Among other services provided in this category during the Fee Period, Aurora addressed contested matters that did not fall squarely into other categories. During the Fee Period, Aurora provided services in the total amount of 0.40 hours on tasks within this category.

G. <u>Nonworking Travel (B195)</u> - Aurora advisors regularly traveled from their respective home offices to the Debtors' facilities for the purposes of performing their daily financial advising services on behalf of the Debtors. Aurora advisors have been a consistent presence at the Debtors' facilities as well as numerous Court proceedings during the course of the Chapter 11 Cases Aurora spent a total of 76.30 hours during the Fee Period on activities in his category. Per its normal billing practices, Aurora only charges one half of its normal hourly rate when engaged in nonworking travel.

H. <u>Business Operations (B210)</u> - Among other services provided to the Debtors in this category during the Fee Period, Aurora advisors provided on-site and offsite daily services such as vendor negotiations, customer contracts and bids analyses and negotiations, preparation of profitability analyses, financial reporting, and strategic business analysis and forecasting. Also included in this category are the voluminous communications by Aurora in connection with updates provided to, and negotiations with, the prepetition agent and the committee. Aurora spent a total of 517.70 hours during the Fee Period providing services in this category.

I. <u>Financing/Cash Collections</u> (B230) – Among other services provided to the Debtors in this category during the Fee Period, Aurora advisors provided regular, if not daily, services such as cash flow monitoring, budgeting, liquidity management and accounts receivable and accounts payable management. Aurora spent a total of 24.70 hours during the Fee Period providing services in this category.

J. <u>Tax Issues (B240)</u> – Among other services provided to the Debtors in this category during the Fee Period, Aurora advisors addressed various tax related issues incurred by or related to the Debtors and these Chapter 11 cases. Aurora spent a total of 32.50 hours during the Fee Period providing services in this category.

K. <u>Real Estate (B250)</u> - Among other services provided to the Debtors in this category during the Fee Period, Aurora advisors communicated with the Debtors' counsel and certain landlords regarding a variety of issues related to the many locations of the Debtors. Aurora spent a total of 0.50 hours during the Fee Period providing services in this category.

L. <u>Board of Directors Matters</u> (B260) – Among other services provided to the Debtors in this category during the Fee Period, Aurora advisors continuously communicated with the Debtors' corporate leadership and respective agents throughout the Fee Period providing updates and advice on the status of the Chapter 11 Cases and business operations. Aurora spent a total of 7.60 hours during the Fee Period providing services in this category.

M. <u>Claims Administration and Objections</u> (B310) - Among other services provided to the Debtors in this category during the Fee Period, Aurora advisors communicated with various vendors and creditors regarding their respective claims in the Chapter 11 Cases. Aurora spent a total of 7.00 hours during the Fee Period providing services in this category.

N. <u>Plan and Disclosure Statement</u> (B320) Among other services provided in this category during the Fee Period, Aurora participated in various communications with Debtors' legal counsel and counsel for the Administrative Agent regarding the plan and disclosure statement. Aurora spent a total of 3.80 hours during the Fee Period providing services in this category.

13. In *Grant v. George Schumann Tire & Battery Co.*, 908 F.2d 874, 877 (11th Cir.1990), the United States Court of Appeals for the Eleventh Circuit held that in determining the

allowance of professionals' fees and the reimbursement of expenses in a bankruptcy case, the bankruptcy court must consider:

- a. the nature and extent of the services rendered;
- b. the value of such services; and
- c. the factors set forth in *Johnson v. Ga. Hwy. Exp., Inc.*, 488 F.2d 714 (5th Cir. 1974).

14. Based on the Eleventh Circuit's criteria, Aurora respectfully submits that the Court should approve and allow Aurora's fees and the reimbursement of Aurora's expenses in the amounts requested.

15. The twelve *Johnson* factors are: (a) the time and labor expended; (b) the novelty and difficulty of the questions raised; (c) the skill required to properly perform the services rendered; (d) the advisor's opportunity costs in pressing the instant case; (e) the customary fee for like work; (f) the advisor's expectations at the outset of the case; (g) the time limitations imposed by the client or circumstances; (h) the amount in controversy and the results obtained; (i) the experience, reputation and ability of the advisor; (j) the undesirability of the case within the legal community in which the case arose; (k) the nature and length of the professional relationship between the advisor and client; and (l) advisors' fee awards in similar cases.

16. The hours Aurora has devoted to its representation of the Debtors meet the above-stated criteria. As the time reports included in Exhibit "A" demonstrate, the individual financial advisors involved in Aurora's representation of the Debtors were materially involved with the Debtors on a daily basis and kept detailed, contemporaneous records of the time devoted to the Chapter 11 Cases. The time spent on each particular task is reasonable and comparable to the time Aurora's professionals would have expended on behalf of a non-bankruptcy client. Aurora seeks payment only for such documented and reasonable services. Based on all applicable criteria,

Aurora submits that the rates set forth herein are reasonable and are consistent with prevailing market rates in the relevant financial advisor community for similar services by advisors of comparable skill, experience and reputation.

17. Further, Aurora advisors' specialized skills, experience and knowledge were required to efficiently steer the Debtors through the difficult reorganization process in the limited amount of available time within which the Debtors were provided to achieve its goals. Prior to the filing of the Debtors' petition, the Debtors' fate was largely uncertain.

### **NOTICE**

18. Notice of this Fee Application will be provided in accordance with the Orders of this Court and applicable law. The Debtors submits that no other or further notice be given.
