## NYEISHA BRYANT'S MOTION FOR RELIEF FROM AUTOMATIC STAY

Comes now, Nyeisha Bryant (hereinafter referred to as "Movant"), by and through counsel, Brent McIntosh of W. Calvin Smith, II, P.C., and moves this Honorable Court for relief from the automatic stay for limited purpose as discussed as follows:

- 1. This is a Motion under Section 362(d) of the US Bankruptcy Code for relief from the automatic stay for all purposes allowed by law and to allow the Movant to continue her litigation against the Premier Kings of Georgia, Inc./Premier Kings, Inc. (hereinafter referred to as "Defendants/Debtors.")
- 2. Movant is the Plaintiff and Debtor is the Defendant in an action now pending styled as follows: *Nyeisha Bryant v. Premier Kings of Georgia, Inc.*, Magistrate Court of Fulton County,

In the state court litigation, Movant seeks damages against the Debtor for damages relating to a food poisoning incident that occurred on October 7, 2022. In the state court litigation, the Premier Kings of Georgia, Inc. was served and moved for a stay in the state court litigation due to the bankruptcy. The Magistrate Court of Fulton County ordered the state court litigation be stayed on January 11, 2024. A copy of this Order is attached as Exhibit A.

3. In the underlying state court action, the Defendants/Debtors are represented by Sean W. Martin and Stephen A. Swanson with Carr Allison and they will receive a service copy of this Motion.

4. Movant's state court litigation has a jurisdictional limit of \$15,000.00, which is the maximum number of monetary compensation that Movant could be awarded.

5. Based on information learned prior to filing the state court litigation, the Defendants/Debtors maintained an insurance policy on the subject Burger King restaurant where the incident occurred through Trisura Specialty Insurance Company.

6. Movant asserts that due to the relatively small amount of damages that could be awarded and the existence of insurance which would cover any damages award, the Defendants/Debtors will suffer no monetary consequences from a finding of liability on their part. Movant respectfully asserts that the existence of this bankruptcy proceeding should not allow Movant's claims to be unresolved for an indefinite period of time when resolution of her claims would likely only come from Defendants/Debtors' insurer.

- 1) Lifts the automatic stay in her case of: Nyeisha Bryant v. Premier Kings of Georgia, Inc. pending in the Magistrate Court of Fulton County, Georgia, Case Number 23MS193706;
- 2) Authorizes Movant to continue her state court litigation, referenced above, against the Defendants/Debtors; and
- 3) For other and further relief as is just and equitable.
