THE DISTRIBUTION TRUSTEE'S SECOND OMNIBUS (NON-SUBSTANTIVE) OBJECTION TO CERTAIN EQUITY CLAIMS THAT SHOULD INSTEAD BE CLASSIFIED AS EQUITY INTERESTS AND EXPUNGED

THIS OBJECTION SEEKS TO DISALLOW CERTAIN FILED PROOFS OF CLAIM. CLAIMANTS SHOULD CAREFULLY REVIEW THIS OBJECTION AND THE SCHEDULES ATTACHED TO THIS OBJECTION TO DETERMINE WHETHER THIS OBJECTION AFFECTS THEIR CLAIMS. CLAIMANTS RECEIVING THIS OBJECTION SHOULD LOCATE THEIR NAMES AND CLAIMS ON SCHEDULES 1 THROUGH 8 TO EXHIBIT A ATTACHED HERETO.

Steven Balasiano, in his capacity as the distribution trustee (the "<u>Distribution Trustee</u>") of the PTRA Distribution Trust (the "<u>Distribution Trust</u>") established in the above-captioned chapter 11 case (the "<u>Chapter 11 Case</u>") of the reorganized debtor ("<u>Prodigy</u>" or the "<u>Reorganized Debtor</u>"), by and through its undersigned counsel, hereby files this omnibus objection (the "<u>Objection</u>"), for entry of an order, substantially in the form attached hereto as <u>Exhibit A</u> (the "<u>Proposed Order</u>"), disallowing and expunging certain proofs of claim that should be reclassified as equity interests and expunged (the "<u>Equity Claims</u>") filed by the claimants (the "<u>Claimants</u>") as set forth on <u>Schedules 1 - 8</u> to the Proposed Order.

In support of this Objection, the Distribution Trustee submits the *Declaration of Steven*Balasiano in Support of the Distribution Trustee's Second Omnibus (Non-Substantive) Objection

to Certain Equity Claims (the "Balasiano Declaration"), attached hereto as **Exhibit B**, and respectfully states as follows:

JURISDICTION AND VENUE

- 1. This Court has jurisdiction to consider this Objection pursuant to 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference* from the United States District Court for the District of Delaware dated as of February 29, 2012. This is a core proceeding pursuant to 28 U.S.C. § 157(b). Pursuant to rule 9013-(f) of the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for the District of Delaware (the "Local Rules"), the Distribution Trustee consents to the entry of a final order by this Court in connection with this Objection to the extent that it is later determined that the Court, absent consent of the parties, cannot enter final orders or judgments in connection herewith consistent with Article III of the United States Constitution. Venue of the Chapter 11 Case and this Objection in this Court is proper under 28 U.S.C. §§ 1408 and 1409.
- 2. The statutory and legal predicates for the relief requested herein are section 502 of title 11 of the United States Code (the "Bankruptcy Code"), Rules 3003 and 3007 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), and Local Rule 3007-1.

BACKGROUND²

I. THE CHAPTER 11 CASE

3. On August 7, 2023, Proterra Inc ("<u>Proterra</u>") and its affiliate, Proterra Operating Company, Inc. (together with Proterra, the "<u>Debtors</u>") filed voluntary petitions for relief in the United States Bankruptcy Court for the District of Delaware (the "<u>Court</u>"), commencing the

Chapter 11 Cases.³ Additional details regarding the Debtors and the facts and circumstances supporting the relief requested herein are set forth in the *Declaration of Gareth T. Joyce in Support of First Day Relief* [D.I. 16].

- 4. On October 6, 2023, the Debtors filed their schedules of assets and liabilities and statements of affairs [D.I. 336–339] and on January 9, 2024, the Debtors filed their amended schedules of assets [D.I. 839] (collectively, the "Schedules").
- 5. On November 29, 2023, the Court entered the *Order (A) Authorizing and Approving the Debtors' Entry into the Asset Purchase Agreement, (B) Authorizing the Sale of the Debtors' Powered Assets Free and Clear of all Liens, Claims, Interests, and Encumbrances, (C) Approving the Assumption and Assignment of the Assumed Executory Contracts and Unexpired Leases, and (D) Granting Related Relief [D.I. 664] (the "Powered Sale Order"). Following entry of the Powered Sale Order, the related sale transaction closed on February 1, 2024. See Notice of Proterra Powered Sale Closing [D.I. 968].*
- 6. On January 9, 2024, the Court entered the Order (A) Authorizing and Approving the Debtors' Entry into the Asset Purchase Agreements, (B) Authorizing the Sale of the Debtors' Transit and Battery Lease Assets Free and Clear of all Liens, Claims, Interests, and Encumbrances, (C) Approving the Assumption and Assignment of the Assumed Executory Contracts and Unexpired Leases, and (D) Granting Related Relief [D.I. 833] (the "Transit and Battery Leases Sale Order"). The sale of the Transit Assets (as defined in the Sale Closing Notice, defined herein) related to the Transit and Battery Leases Sale Order closed on January 11, 2024. See Notice of Proterra Battery Lease Sale Closing [D.I. 1010] (the "Sale Closing Notice"); see

For the avoidance of doubt, references to the Debtors and the Chapter 11 Cases pertain to the time before the entry of the Case Closing Order, as referenced herein, while references to the Reorganized Debtor and the Chapter 11 Case pertain to the period after the Effective Date and entry of the Case Closing Order, as applicable.

also Notice of (I) Proterra Transit Sale Closing and (II) Third Amendment to Battery Lease Asset Purchase Agreement by and Among the Debtors and Phoenix Motor, Inc. [D.I. 879]. The sale of the Battery Assets (as defined in the Sale Closing Notice) subject to the terms of the Battery Leases APA (defined below) closed on February 7, 2024. See Sale Closing Notice; see also Notice of Filing of Second Amendment to (I) Battery Lease Asset Purchase Agreement and (II) Transit Asset Purchase Agreement, Each by and Among the Debtors and Phoenix Motor, Inc. and Rescheduling Sale Hearing with Respect to Proterra Transit [D.I. 743] (the "Battery Leases APA").

- 7. On March 1, 2024, the Debtors filed the *Fifth Amended Joint Chapter 11 Plan of Reorganization for Proterra Inc and its Debtor Affiliate* [D.I. 1154] (the "Plan").
- 8. On March 6, 2024, the Court entered the *Findings of Fact, Conclusions of Law, and Order Confirming the Fifth Amended Joint Chapter 11 Plan of Reorganization of Proterra Inc and its Debtor Affiliate* [D.I. 1180] (the "Confirmation Order"), confirming the Plan and approving all supplements thereto, including the Distribution Trust Agreement (the "DTA").
- 9. The Plan went effective on March 13, 2024 (the "<u>Effective Date</u>"). See Notice of (I) Entry of Confirmation Order, (II) Occurrence of Effective Date, and (III) Final Deadlines for Filing Certain Claims [D.I. 1208] (the "<u>Notice of Effective Date</u>").
- 10. On March 22, 2024, the Court entered the *Order (I) Amending Case Caption to Reflect Change of Debtors' Names, (II) Closing Proterra Operating Company, Inc's Chapter 11 Case; and (III) Granting Related Relief* [D.I. 1233] (the "Case Closing Order") authorizing the Debtors and Distribution Trust to amend the case caption used in the Chapter 11 Cases to reflect the changes of their respective legal names. As such, Proterra Operating Company, Inc., Case No. 23-11121 (BLS), was closed while the lead case, Proterra Inc, Case No. 23-11120 (BLS), remained

open. Furthermore, the caption was amended to reflect the new name of the Reorganized Debtor in the remaining Chapter 11 Case, Prodigy Investments Holdings, Inc.

11. Pursuant to the Plan, as of the Effective Date, the Distribution Trust was established, for among other reasons, to provide for distributions to the Distribution Trust's Beneficiaries. *See* Plan, Art. IV. The Plan and the DTA also authorize the Distribution Trustee to pursue objections to, and estimation and settlements of, all Disputed Claims in order to make the aforementioned distributions. *See* Plan, Art. IV.C.7.

II. THE CLAIMS RESOLUTION PROCESS

A. Background

- 12. On September 5, 2023, the Court entered the *Order Establishing Bar Dates for Filing Proofs of Claim and Approving the Form and Manner of Notice Thereof* [D.I. 187] (the "Bar Date Order"), setting forth certain dates by which parties holding prepetition claims against the Debtors were required to file proofs of claim.
- 13. On or around October 11, 2023, Verita Global, f/k/a Kurtzman Carson Consultants LLC ("KCC"), the Debtors' claims and noticing agent, mailed the Bar Date Order and proof of claim form to all the Debtors' creditors and other known parties in interest as of the Petition Date (the "Bar Date Notice"). See Certificates of Service [D.I. 467, 1058].
- 14. The Bar Date Order established November 13, 2023, 4:00 p.m. (prevailing ET) as the deadline for all entities (except for governmental units and holders of administrative claims) holding claims against the Debtors that arose, or are deemed to have arisen, prior to the Petition Date to file proofs of claim (the "General Bar Date"). See Bar Date Order at ¶ 4. The deadline for governmental units to file proofs of claim against the Debtors was February 3, 2024 at 4:00 p.m. (ET) (the "Governmental Bar Date") and the deadline for holders of administrative claims to file proofs of claim against the Debtors was fixed as April 12, 2024 (the "Administrative Bar Date,"

and together with the General Bar Date and Governmental Bar Date, the "Bar Dates" and each as applicable, the "Applicable Bar Date"). *See* Notice of Effective Date.

B. **Proofs of Claim and Claims Reconciliation**

- 15. The Debtors' register of claims (the "Claims Register"), as maintained by KCC, includes more than 1400 proofs of claim that were filed against the Debtors.
- 16. In the ordinary course of business, the Debtors maintained books and records (the "Books and Records") that reflect, among other things, the nature and amount of the liabilities the Debtors owed to their creditors and interest holders. The Reorganized Debtor and its professionals began, and the Distribution Trustee and his professionals have continued, reviewing, comparing, and reconciling the proofs of claim (including any supporting documentation) with the Schedules, the Claims Register, and the Books and Records. The claims reconciliation process includes identifying particular categories of claims that may be subject to objection because they were improperly classified in a proof of claim.
- Omnibus (Non-Substantive) Objection to Certain (I) Amended and Superseded Claims, (II) Duplicate Claims, (III) Late Filed Claims, and (IV) Insufficient Documentation Claims [D.I. 1326] (the "First Omnibus Objection"), (ii) The Distribution Trustee's First Notice of Claims Previously Satisfied [D.I. 1327] (the "First Satisfied Claims Notice"), and (iii) The Distribution Trustee's First Notice of Claims Previously Partially Satisfied [D.I. 1328] (the "First Partially Satisfied Claims Notice") and together with the First Satisfied Claims Notice, the "Satisfied Claims Notices").
- 18. On July 10, 2024, the Distribution Trustee filed certifications of counsel in connection with the Satisfied Claims Notices [D.I. 1388 and D.I. 1389].

- 19. On July 10, 2024, the Distribution Trustee filed a certification of counsel with respect to the First Omnibus Objection, entering a revised form of order [D.I. 1387].
- 20. On July 12, 2024, the Court entered an order sustaining the First Omnibus Objection [D.I. 1391].
- 21. This review, analysis, and reconciliation of claims is ongoing, and the Distribution Trustee has now determined that certain additional claims should be disallowed and expunged as they should be classified as equity interests and expunged.
- 22. Accordingly, the Distribution Trustee files this Objection seeking the relief requested below.

RELIEF REQUESTED

23. By this Objection, the Distribution Trustee respectfully requests entry of the Proposed Order disallowing and expunging the Equity Claims in their entirety.

BASIS FOR RELIEF

- 24. Section 502(a) of the Bankruptcy Code provides, in pertinent part, that a "claim or interest, proof of which is filed under section 501 of this title, is deemed allowed, unless a party in interest . . . objects." 11 U.S.C. § 502(a).
- 25. Section 502(b)(1) of the Bankruptcy Code provides that a claim may not be allowed to the extent that it "is unenforceable against the debtor and property of the debtor, under any agreement or applicable law." 11 U.S.C. § 502(b). While a properly filed claim is *prima facie* evidence of the claim's allowed amount, when an objecting party rebuts a claim's *prima facie* validity, the Claimant bears the burden of proving the claim's validity by a preponderance of evidence. *See In re Allegheny Int'l, Inc.*, 954 F.2d 167, 173–74 (3d Cir. 1992) ("The burden of persuasion is always on the claimant."); *see also* 11 U.S.C. § 501; Fed. R. Bankr. P. 3001(f).

26. For the reasons set forth below, there is ample evidence to rebut the *prima facie* validity of each Claim.

A. The Equity Claims

- 27. As set forth in the Balasiano Declaration, based upon a review and analysis of the Equity Claims listed on Schedules 1-8 to the Proposed Order, the Distribution Trustee has determined that each Equity Claim was filed by a shareholder based on the asserted ownership of equity securities in the Debtors.
 - 28. The Bankruptcy Code defines an "equity security" as a:
 - a. share in a corporation, whether or not transferable or denominated "stock," or similar security;
 - b. interest of a limited partner in a limited partnership; or
 - c. warrant or right, other than a right to convert, to purchase, sell, or subscribe to a share, security, or interest of a kind specified in subparagraph (A) or (B) of this paragraph.

11 U.S.C. § 101(16). Holders of equity securities, such as shares of stock, do not have "claims" under section 101(5) of the Bankruptcy Code, but rather equity interests. *See In re Insilco Techs., Inc.*, 480 F.3d 212, 218 (3d Cir. 2007) ("[An equity interest] is not a claim at all"); *In re Hedged-Invs. Assocs.*, 84 F.3d 1267, 1272 (10th Cir. 1996) ("Simply put, an equity interest is not a claim against the debtor....") (quotations omitted). The Equity Claims do not assert any claims for damages, but rather assert claims based only on ownership as an equity interest.⁴ The equity interests asserted by the holders of the Equity Claims are thus not claims against the Debtors.

29. Furthermore, pursuant to the express terms of the Plan, interests in Equity are extinguished ("On the Effective Date, each holder of an Interest in TopCo shall have such Interest

cancelled without distribution or compensation ...[and] Allowed Section 510(b) Claims, if any, shall be canceled and released without any distribution on account of such Section 510(b) Claims." See Plan, Art. III.C). The Plan also provides:

Except as otherwise expressly provided in the Plan, the Confirmation Order, or any agreement, instrument, or other document entered into in connection with or pursuant to this Plan, on the Effective Date, (a) all notes, bonds, indentures, certificates, securities, shares, equity securities, purchase rights, options, warrants, convertible securities or instruments, credit agreements, collateral agreements, subordination agreements, intercreditor agreements, or other instruments or documents directly or indirectly evidencing, creating, or relating to any indebtedness or obligations of, or ownership interest in, the Debtors, or giving rise to any Claims against or Interests in the Debtors or to any rights or obligations relating to any Claims against or Interests in the Debtors ... shall be canceled without any need for a Holder or any Debtors to take any further action with respect thereto, and the duties and obligations of all parties thereto, including the Debtors, thereunder or in any way related thereto shall be discharged, terminated, and of no further force or effect and (b) the obligations of the Debtors pursuant, relating, or pertaining to any agreements, certificates of designation, bylaws, or certificate or articles of incorporation or similar documents governing the notes, bonds, indentures, certificates, securities, shares, purchase rights, options, warrants, or other instruments or documents evidencing or creating any indebtedness or obligation of or Interests in the Debtors ... including, without limitation, ... publicly-traded Interests, shall be released and discharged in exchange for the consideration provided under the Plan.

On the Effective Date, each holder of a certificate or instrument evidencing a Claim that is discharged by the Plan shall be deemed to have surrendered such certificate or instrument in accordance with the applicable indenture or agreement that governs the rights of such holder of such Claim. Such surrendered certificate or instrument shall be deemed canceled as set forth in, and subject to the exceptions set forth in, this Article IV.K.

See Plan, Art. IV.K. (emphasis added).

30. The formal removal of the Equity Claims from the Claims Register will enable the Distribution Trustee to maintain a Claims Register that more accurately reflects the valid claims that have been asserted against the Debtor's estate.

31. Therefore, the Liquidating Trustee (i) objects to the allowance of the Equity Claims set forth on Schedules 1-8 to the Proposed Order, and (ii) seeks entry of the Proposed Order disallowing the Equity Claims.

RESPONSES TO THE OBJECTION

- 32. Filing and Service of Responses: To contest the Objection, a Claimant must file and serve a written response to the Objection (a "Response") so that it is actually received by the Clerk of the Court and the parties in the following paragraph no later than 4:00 p.m. (ET) on August 21, 2024 (the "Response Deadline"). Claimants should locate their names and Equity Claims on Schedules 1-8 to the Proposed Order, and carefully review the Objection. A Response must address the grounds upon which the Distribution Trustee objects to a particular Equity Claim. A hearing to consider the Objection, if necessary, will be held on August 28, 2024 at 1:00 p.m. (ET), before the Honorable Brendan L. Shannon, United States Bankruptcy Judge, at the United States Bankruptcy Court for the District of Delaware, 824 North Market Street, 6th Floor, Courtroom 1, Wilmington, Delaware 19801 or via telephone and videoconference (the "Hearing").
- 33. Each Response must be filed and served upon the following entities at the following addresses:

- 34. <u>Content of Responses</u>: Every Response to the Objection must contain, at a minimum, the following:
 - 1. a caption setting forth the name of the Court, the above-referenced case number and the title of the Objection to which the Response is directed;
 - 2. the name of the Claimant and description of the basis for the amount of the Equity Claim;
 - 3. a concise statement setting forth the reasons why a particular Equity Claim should not be disallowed and expunged for the reasons set forth in the Objection, including, but not limited to, the specific factual and legal bases upon which the Claimant will rely in opposing the Objection at the Hearing;
 - 4. all documentation or other evidence relating to the Equity Claim in question, to the extent not already included with the Claimant's proof of claim, upon which the Claimant will rely in opposing the Objection at the Hearing;
 - 5. the name, address, telephone number, and fax number of the person(s) (who may be the Claimant or a legal representative thereof) possessing ultimate authority to reconcile, settle, or otherwise resolve the Equity Claim on behalf of the Claimant; and
 - 6. the name, address, telephone number, and fax number of the person(s) (who may be the Claimant or a legal representative thereof) to whom the Distribution Trustee should serve any reply to the Response.

- 35. <u>Timely Response Required; Hearing</u>: If a Response is properly and timely filed and served in accordance with the above procedures, the Distribution Trustee will endeavor to reach a consensual resolution with the Claimant. If no consensual resolution is reached, the Court will conduct a hearing with respect to the Objection and the Response on August 28, 2024 at 1:00 p.m. (ET), or such other date and time as parties filing Responses may be notified. Only those Responses made in writing and timely filed and received will be considered by the Court at any such hearing.
- 36. Adjournment of Hearing: The Distribution Trustee reserves the right to adjourn the Hearing on any Equity Claim included in the Objection. In the event that the Distribution Trustee so adjourns the Hearing, the Distribution Trustee will state that the Hearing on that particular Equity Claim has been adjourned on the agenda for the Hearing on the Objection, which agenda will be served on the person designated by the Claimant in its Response.
- 37. If a Claimant whose Equity Claim is subject to the Objection, and who is served with the Objection, fails to file and serve a timely Response in compliance with the foregoing procedures, the Distribution Trustee will present to the Court an appropriate order disallowing and expunging the Equity Claims without further notice to the Claimant.

SEPARATE CONTESTED MATTER

38. To the extent a Response is filed regarding any individual claim listed in this Objection and the Distribution Trustee is unable to resolve the Response, the Objection by the Distribution Trustee to such claim shall constitute a separate contested matter as contemplated by

Bankruptcy Rule 9014. Any order entered by the Court regarding an objection asserted in this Objection shall be deemed a separate order with respect to each claim subject thereto.

RESERVATION OF RIGHTS

- 39. The Distribution Trustee expressly reserves the right to amend, modify, or supplement this Objection, and to file additional objections to any other claims (filed or not) that may be asserted against the Reorganized Debtor and the Distribution Trust. Should one or more of the grounds for objection stated in the Objection be withdrawn or overruled, the Distribution Trustee reserves the right to object to each of the Equity Claims or any other proofs of claim on any other grounds.
- 40. Notwithstanding anything contained in the Objection, or the exhibits and schedules attached hereto, nothing herein will be construed as a waiver of any rights that the Reorganized Debtor, the Distribution Trustee or any successors thereto, may have to enforce any other rights, including but not limited to the right of setoff against the Claimants.
- 41. Nothing in this Objection shall be deemed: (a) an admission as to the amount of, basis for, or validity of any claim against the Reorganized Debtor or the Distribution Trustee under the Bankruptcy Code or other applicable nonbankruptcy law; (b) a waiver of the Reorganized Debtor's, the Distribution Trustee's, or any other party in interest's right to dispute any claim; (c) a promise or requirement to pay any particular claim; (d) an implication or admission that any particular claim is of a type specified or defined in this Objection; (e) an admission as to the validity, priority, enforceability, or perfection of any lien on, security interest in, or other encumbrance on property of the Reorganized Debtor's estate or the Distribution Trust; or (f) a waiver of any claims or causes of action which may exist against any entity under the Bankruptcy Code or any other applicable law.

light of the nature of the relief requested herein, the Distribution Trustee submits that no other or

further notice is required.
