Dear Honorable Brendan L. Shannon,

I am a creditor and filed my claim as a governmental unit. I represent KPMG Peat Marwick (the name was subsequently changed to KPMG Consulting) and my own entity, Amyr Naeem LLP. My claim remains classified as Priority.

In our previous hearing on 11/20/2024, I made an argument to highlight the advancements Stellantis N.V. and Factorial Inc. have made to accelerate the future of electric vehicles with solid-state battery technology. This was an article published in BusinessWire on 10/23/2024.

I also made the argument that Proterra's assets were split into three divisions and sold off. The Proterra Powered powertrain manufacturing business line would operate as an independent company within the Volvo Group. The transit bus manufacturing business line was sold to Phoenix Motorcars. The Proterra Energy business line which built charging systems for fleets of heavy-duty vehicles was purchased by Cowen Equity. These actions would be an advantage to me as creditor.

According to 11 U.S. Code §501 - Filing of proofs of claims or interest,

(a) A creditor or an indenture trustee may file a proof of claim. An equity security holder may file a proof of interest.

and/or

(e) A claim arising from the liability of a debtor (the Reorganized Debtors or others) for fuel use tax assessed consistent with the requirements of section 31705 of title 49 may be filed by the base jurisdiction designated pursuant to the International Fuel Tax Agreement (as defined in section 31701 of title 49) and, if so filed, shall be allowed as a single claim.

Delaware law permits the garnishment of up to 15% of a debtor's net income. This would extend to the contents of the PTRA Distribution Trust.
