- 3. The current Bishop of the Debtor is The Most Reverend Michael C. Barber, SJ (the "Bishop"), who was appointed in 2013.
- 4. Additional information regarding the Debtor, its mission and operations, and the events and circumstances preceding the Petition Date is set forth in the *Declaration of Charles Moore, Managing Director of Alvarez & Marsal North America, LLC, Proposed Restructuring Advisor to the Roman Catholic Bishop of Oakland, in Support of Chapter 11 Petition and First Day Pleadings* (the "First Day Declaration") filed on the Petition Date.
- 5. Bankruptcy Local Rule 4002-1 requires appointment of a natural person to be responsible for the duties and obligations of the debtor-in-possession under the Bankruptcy Code, as the "Responsible Individual." As the incumbent Bishop of the Debtor, responsible for the management and operations of the Debtor, the Bishop is the appropriate person to be designated as the Responsible Individual.
