9 party, Verita may (i) file a certificate of partial objection with the Court after which the Debtors, without
10 further order of the Court, may pay Verita an amount equal to 80% of the fees and 100% of the expenses
11 to which there was no objection, or (ii) forego payment of such amounts until the next hearing to
12 consider interim or final fee applications.
