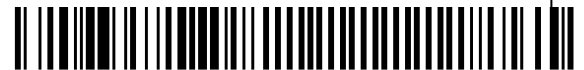

**PLEASE TAKE NOTICE THAT** a hearing will be held on **Wednesday, April 23, 2025, at 10:30 a.m.** (the "Hearing"), and will take place at the United States Bankruptcy Court, 1300 Clay Street, Oakland, California, before the Honorable William J. Lafferty, United States Bankruptcy Judge, to consider the *Debtor's Motion for Entry of Order Approving Settlement with Ruben Galindo, as Trustee of the Edward J. Bennett Trust, Pursuant to Fed. R. Bankr. P. 9019* (the "Motion"), filed concurrently herewith by The Roman Catholic Bishop of Oakland, a California corporation sole, and the debtor and



1 debtor in possession (the “Debtor”) in the above-captioned chapter 11 bankruptcy case (the “Bankruptcy  
2 Case”).

3 The Motion seeks an order approving a settlement agreement between Rubin Galindo (“Mr.  
4 Galindo”), as trustee of the Edward J. Bennett Trust dated December 17, 2014 (the “Bennett Trust”), and  
5 the Debtor, concerning claims the Debtor filed against Mr. Galindo in the Contra Costa County Probate  
6 Court regarding Mr. Galindo’s administration of the Bennett Trust.

7 The Motion is based upon this Notice; the Motion and the memorandum of points and authorities  
8 set forth therein; the declarations filed in support thereof; any and all supplemental papers that may be  
9 filed by the Debtor; the papers on file in this bankruptcy case; and on such arguments or evidence as may  
10 be presented at the hearing. Copies of the Motion and papers filed in support thereof, and all pleadings  
11 and papers filed in this Bankruptcy Case, can be obtained from the website maintained by the Debtor’s

18 the hearing by Zoom Webinar/AT&T Teleconference will be included with each calendar posted under  
19 Judge Lafferty’s Calendar on the court’s website.

20 **PLEASE TAKE FURTHER NOTICE THAT opposition, if any, to the granting of the relief**  
21 **sought in the Motion must be in writing, filed with the Bankruptcy Court not later than seven (7)**  
22 **days before the date set for the Hearing.** Any opposition must be filed in writing with Clerk of the  
23 Bankruptcy Court at 1300 Clay Street, Suite 300, Oakland, California, 94612 (mailing address: P.O. Box  
24 2070, Oakland, California, 94604) and must be served on counsel for the Debtor at the address listed  
25 above. Unless a timely objection is filed, the Court may grant the relief requested in the Motion without  
26 a hearing. **Failure to file and serve a timely objection may result in the waiver of any objection.**
