26 Pursuant to Rule 8009 of the Federal Rules of Bankruptcy Procedure, Appellant submits the
27 following: (i) statement of issues to be considered on appeal from the *Order Granting Renewed*
28 *Motion of the Official Committee of Unsecured Creditors to Lift the Automatic Stay to Permit*

1 *Certain Plaintiffs' Personal Injury Claims to Proceed in State Court* [Bankr. Dkt. 2168], and all
2 other subsumed judgments, orders, and decrees brought up for review in the appeal; and (ii)
3 designation of items to be included in the record on appeal.

4 **I. Statement of Issues to be Presented on Appeal**

5 Appellant presents the following statement of issues to be considered on appeal:

- 6 1. Whether the bankruptcy court erred in granting the *Renewed Motion of the Official*
7 *Committee of Unsecured Creditors to Lift the Automatic Stay to Permit Certain*
8 *Plaintiffs' Personal Injury Claims to Proceed in State Court* (the "Motion") and
9 lifting the automatic stay (11 U.S.C. § 362(a)) so that six, unspecified personal
10 injury claims can proceed against the Debtor in Judicial Council Coordinated
11 Proceeding No. 5108 (Alameda Super. Ct.) (the "JCCP"), when: (a) hundreds of
12 personal injury claims are pending against the Debtor in the JCCP (each, an
13 "Underlying Claim"); and (b) the bankruptcy court not only failed to identify which
14 of the Underlying Claims it was releasing from the automatic stay but also
15 delegated to the JCCP court the authority to make that decision.

- 18 3. Whether the bankruptcy court erred in granting the Motion without competent
19 record evidence demonstrating cause for such relief.
- 20 4. Whether the bankruptcy court erred in granting the Motion without determining
21 whether the released Underlying Claims are representative of the pool of
22 Underlying Claims.
- 23 5. Whether the bankruptcy court otherwise erred or abused its discretion in granting
24 the Motion.
