**APPELLANTS PACIFIC INSURERS'

Pursuant to Rule 8009 of the Federal Rules of Bankruptcy Procedure, made applicable by rule 6(c)(2)(A) of the Federal Rules of Appellate Procedure, Pacific Indemnity Company, Pacific Employers Insurance Company, Insurance Company of North America, and Westchester Fire Insurance Company (collectively, “Pacific Insurers”), by and through their undersigned counsel, submit the following: (i) statement of issues to be considered on appeal, (ii) designation of items to be included in the record on appeal, and (iii) certificate regarding transcripts. The Appellants appeal from the Order Granting Renewed Motion of the Official Committee of Unsecured Creditors to Lift the Automatic Stay to Permit Certain Plaintiffs’ Personal Injury Claims to Proceed in State Court, Docket No. 2168.

### **STATEMENT OF ISSUES TO BE PRESENTED ON APPEAL**

Appellants present the following statement of issues to be considered on appeal:

1. Whether the bankruptcy court erred in granting the *Renewed Motion of the Official Committee of Unsecured Creditors to Lift the Automatic Stay to Permit Certain Plaintiffs’ Personal Injury Claims to Proceed in State Court* (the “Motion”) and lifting the automatic stay (11 U.S.C. § 362(a)) so that six, unspecified personal injury claims can proceed against the Diocese allowing those six claimants’ cases to advance to verdict, while discriminating against the remaining 358 similarly situated claimants whose cases remain subject to the automatic stay contrary to fundamental principles of bankruptcy law.
2. Whether the bankruptcy court erred in granting the Motion when the Motion did not identify the cases for which the stay will be lifted and delegated to the state court the bankruptcy court’s jurisdiction over stay relief.
3. Whether the bankruptcy court erred in granting the Motion by the Committee to lift the stay when the Committee does not represent individual claimants.
4. Whether the bankruptcy court erred in granting the Motion because the Committee failed to demonstrate cause for relief from the stay under *In re Curtis*, 40 B.R. 795, 802 (Bankr. D. Utah 1984) and, instead, relied on speculative assertions that lifting the stay would pressure insurers to resolve the bankruptcy case.



Pacific Insurers reserve the right to modify, restate, or supplement the foregoing issues to the fullest extent permitted by the Bankruptcy Code and Rules.
