3 debtor in possession (the “Debtor” or “RCBO”) in the above-captioned chapter 11 bankruptcy case (the
4 “Chapter 11 Case” or the “Bankruptcy Case”), filed its *Twenty Sixth Monthly Fee Statement of Foley &*
5 *Lardner LLP, as General Bankruptcy Counsel to the Debtor, for Allowance and Payment of Compensation*
6 *and Reimbursement of Expenses for the Period of July 1, 2025 through July 31, 2025* [Docket No. 2269]
7 (the “Monthly Fee Statement”), pursuant to the *Order Authorizing Procedures for Interim Compensation*

13 The Monthly Fee Statement was filed and served on September 2, 2025 via email pursuant to the
14 terms of the Compensation Procedures Orders, on the Notice Parties (as defined therein).

15 The deadline for each Notice Party to file any objection to the Monthly Fee Statement was
16 September 12, 2025 under the Compensation Procedures Orders. No objections to the Monthly Fee
17 Statement have been filed with the Court or received by the Applicant as of the date hereof. Pursuant to
18 the Compensation Procedures Orders, the Debtor is authorized to pay the Applicant seventy percent (70%)
19 of the fees and one hundred percent (100%) of the expenses requested in the Monthly Fee Statement
20 without the need of a further order of the Court.
