2	Dismiss Chapter 11 Case Pursuant to 11 U.S.C. §1112(b) [Docket No. 2393] (the "Motion"), filed by

16	understand in basic terms the treatment of claims, and (b) is signed by the Debtor and any party who is in
17	support of the term sheet.
18	4. This Court shall retain jurisdiction with respect to all matters arising from or related to the
19	implementation of or interpretation of this Order.
