PLEASE TAKE NOTICE that on November 5, 2025, Scroggins, Williamson & Ray, P.C., f/k/a Scroggins & Williamson, P.C. (“**SWR**”), filed its *First and Final Application of Scroggins, Williamson & Ray, P.C. for Compensation and Reimbursement of Expenses* [Dkt. PLEASE TAKE FURTHER NOTICE that on November 5, 2025, GGG Partners, LLC (“**GGG**”), filed its *First and Final Application of GGG Partners, LLC for Compensation and Reimbursement of Expenses* [Dkt. No. 402] (the “**GGG Application**”) (collectively, the “**Applications**”) as Chief Restructuring Officer of the Debtors. In the GGG Application, GGG seeks a final award of compensation in the amount of \$725,437.00 and reimbursement of expenses in the amount of \$5,703.57 for the period from August 27, 2021, through and including the Dismissal Effective Date which is anticipated to occur on or before December 31, 2025. If you oppose the relief requested in the Applications, you must timely file your response in opposition to the Applications with the Bankruptcy Clerk at Clerk, U.S. Bankruptcy Court, 600 East First Street, Room 339, Rome Georgia 30161, and serve a copy on the Debtors' attorney, Ashley R. Ray, Scroggins, Williamson & Ray, P.C., 4401 Northside Parkway, Suite 230, Atlanta, GA 30327 by the response deadline. The response must explain your position and be actually received by the Bankruptcy Clerk within the required time.

PLEASE TAKE FURTHER NOTICE that the Court will hold a hearing on the Applications and any objections thereto at **11:00 a.m. on December 3, 2025, in Courtroom 342, U.S. Courthouse, 600 East First Street, Rome, Georgia 30161 (the "Hearing")**. The hearing may be attended in person or via the Court's Virtual Hearing Room. A party may join Judge Bonapfel's Virtual Hearing Room through the link on the Court's website located at <https://www.ganb.uscourts.gov/dial-and-virtual-bankruptcy-hearing-information> or the link on Judge Bonapfel's webpage under the tab "Virtual Hearings" which can also be found on the Court's website. Parties and counsel should be prepared to appear at the hearing via video but may leave the camera in the off position until the Court instructs otherwise. Unrepresented persons who do not have video capability may use the telephone dial-in information on the judge's webpage. Please join the virtual room 10 minutes prior to the hearing. If a response is timely filed and served, the Hearing will proceed as scheduled. **If you do not file a response within the time permitted, the Court may grant the relief requested without further notice or a hearing provided that an order approving the relief requested is entered at least one business day prior to the scheduled hearing.** If no response is timely filed, but no order is entered granting the relief requested at least one business day prior to the hearing, the hearing will be held at the time and place as scheduled.

Your rights may be affected. You should read these papers carefully and discuss with your attorney, if you have one in this bankruptcy case. If you do not have an attorney, you may wish to consult one.
