SECURITY AGREEMENT

THIS SECURITY AGREEMENT (this "Security Agreement") is made and entered 01 / 21 / 2021 2021, by RHODIUM 2.0 LLC, a Delaware limited liability company (hereinafter, the "Grantor" or "Borrower"), in favor of CHRISTOPHER BLACKERBY, an individual (hereinafter, the "Creditor"), in consideration of Creditor extending credit to the Grantor pursuant to and subject to the terms and conditions set forth in that certain Secured Promissory Note of even date herewith in the original principal amount of FIVE HUNDRED TWENTY-FIVE THOUSAND AND 00/100S DOLLARS (\$525,000.00) executed by the Borrower and delivered to the Creditor, together with any modifications, extensions, renewals, additions, substitutions, or replacements thereof (collectively, the "Note"). In consideration therefor, the Grantor grants the Creditor as security for the indebtedness evidenced by the Note and any other obligations of the Grantor to the Creditor thereunder (collectively, the "Indebtedness") a security interest in and a lien upon all property of Grantor's property described in Exhibit A attached hereto, whether now existing or owned or hereafter arising or acquired (collectively, the "Collateral"). All capitalized terms not defined in this Security Agreement shall have their respective meanings ascribed to them in the Note.

Grantor represents and warrants to the Creditor that it is the owner of each of the items comprising the Collateral, and that the security interests granted therein to the Creditor constitute valid and enforceable liens thereupon. Except for those certain liens on Collateral specified in Exhibit B attached hereto (but excluding the lien created by this Security Agreement, which is also listed on **Exhibit B** attached hereto) (collectively, and exclusive of the lien created by this Security Agreement, the "Existing Liens"), no other or additional security interests in the Collateral or any portion thereof exist, nor shall any security interests in the Collateral be sold, assigned, or granted for so long as any Indebtedness is owed.
