ORDER GRANTING PLAN ADMINISTRATOR'S FIRST OMNIBUS (NON-SUBSTANTIVE) OBJECTION TO CERTAIN PROOFS OF CLAIM

Upon the Plan Administrator's first omnibus (non-substantive) objection (the "Objection")² seeking to disallow and expunge the postpetition administrative expense portions of certain proofs of claim pursuant to Bankruptcy Code Section 502; and the Court having jurisdiction over this matter pursuant to 28 U.S.C. 157 and §§ 1334(b); and the Court having found that this matter is a core proceeding pursuant to 28 U.S.C. § 157(b)(2), and that the Plan Administrator consents to entry of a final order under Article III of the United States Constitution; and the Court having found that venue of this proceeding and the Objection in this District is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court having determined that the relief requested in the Objection is in the best interests of the Wind-Down Debtors, their estates, their creditors, and other parties in interest; and it appearing that proper and adequate notice of the Objection has been given, under the circumstances, and that no other or further notice is necessary; and upon the record herein; and after due deliberation thereon; and good and sufficient

cause appearing therefore,

IT IS ORDERED, ADJUDGED AND DECREED THAT:

- 1. The Objection is SUSTAINED as set forth herein.
- 2. Pursuant to Bankruptcy Code section 502, the Improper Form Claims listed on Schedule 1 attached hereto are hereby disallowed and expunged in their entirety.
- 3. Notwithstanding anything to the contrary contained herein, nothing herein shall affect the validity, nature, amount, allowability, priority, or otherwise seek to reclassify, disallow, or expunge any prepetition claim, including a 503(B)(9) Claim, that may have been asserted by the claimants of the Improper Form Claims, including those amounts set forth in the "Modified Claims" column on <u>Schedule 1</u> hereto. All parties' rights are reserved with respect to the prepetition portions of the Modified Claims on <u>Schedule 1</u>, including the Plan Administrator's right to file a further objection and seek disallowance thereof.
- 4. The claims on <u>Schedule 2</u> and <u>Schedule 3</u> are not Improper Form Claims. Rather, the Plan Administrator and respective claimants have agreed to the treatment specified on <u>Schedule 2</u> and <u>Schedule 3</u> as the appropriate treatment of such claims.
- 5. The claims listed on <u>Schedule 2</u> attached hereto were amended and superseded, and are hereby disallowed and expunged in their entirety solely on that basis.
- 6. The administrative portions of the claims listed on <u>Schedule 3</u> have been satisfied by the Wind-Down Debtors' Estates and are hereby disallowed and expunged in their entirety solely on that basis.
- 7. Notwithstanding anything to the contrary contained herein, nothing herein shall affect the validity, nature, amount, allowability, priority, or otherwise seek to reclassify, disallow, or expunge any prepetition claim that may have been asserted by the claimants of the Satisfied

Claims, including those amounts set forth in the "Modified Claims" column on <u>Schedule 3</u> hereto.

All parties' rights are reserved with respect to the prepetition portions of the Modified Claims on

Schedule 3, including the Plan Administrator's right to file a further objection and seek

disallowance thereof.

8. The Wind-Down Debtors' claims, noticing, and solicitation agent, Kurtzman

Carson Consultants LLC, is authorized and directed to update the claims register maintained in

these chapter 11 cases to reflect the relief granted in the Order.

9. The Plan Administrator's rights to amend, modify, or supplement the Objection,

to file additional objections to any claims (filed or not) asserted against the Wind-Down Debtors,

and to seek further reduction of any claim to the extent such claim has not been paid, are

preserved. Additionally, should one or more grounds of objection stated in the Objection be

overruled, the Plan Administrator's rights to object on other stated grounds or on any other

grounds that the Plan Administrator discovers are further preserved.

10. Notwithstanding any Bankruptcy Rule or Local Rule to the contrary, this Order

shall be immediately effective and enforceable upon its entry.

11. This Court shall retain jurisdiction over any and all matters arising from the

interpretation, implementation, or enforcement of this Order.
