# ORDER GRANTING PLAN ADMINISTRATOR'S SIXTH (NON-SUBSTANTIVE) OMNIBUS OBJECTION TO CERTAIN PROOFS OF CLAIM

(Satisfied Claims)

#### IT IS ORDERED, ADJUDGED AND DECREED THAT:

- 1. The Objection is SUSTAINED as set forth herein.
- 2. Pursuant to Bankruptcy Code section 502, the Satisfied Claims listed on <u>Schedule</u>

  1 attached hereto are hereby disallowed and expunged.
- 3. The Debtors' claims, noticing, and solicitation agent, Kurtzman Carson Consultants LLC, is authorized and directed to update the claims register maintained in these chapter 11 cases to reflect the updated claims amount in the "Modified Claims" column and the relief granted in the Order.
- 4. The Plan Administrator's rights to amend, modify, or supplement the Objection, to file additional objections to any claims (filed or not) asserted against the Debtors, including the Modified Claims, and to seek further reduction of any claim to the extent such claim has been paid, are preserved. Additionally, should one or more grounds of objection stated in the Objection be overruled, the Plan Administrator's rights to object on other stated grounds or on any other grounds that the Plan Administrator discovers are further preserved.
- 5. Notwithstanding any Bankruptcy Rule or Local Rule to the contrary, this Order shall be immediately effective and enforceable upon its entry.

6. This Court shall retain jurisdiction over any and all matters arising from the interpretation, implementation, or enforcement of this Order.
