#### PLAN ADMINISTRATOR'S ELEVENTH OMNIBUS OBJECTION TO CERTAIN PROOFS OF CLAIM

(Insufficient Documentation Claims, Late-Filed Claims, Amended and Superseded Claims, and Wrong Debtor Claims)

THIS IS AN OBJECTION TO YOUR CLAIM. THIS OBJECTION ASKS THE COURT TO DISALLOW THE CLAIM THAT YOU FILED IN THIS BANKRUPTCY CASE. IF YOU DO NOT FILE A RESPONSE WITHIN 30 DAYS AFTER THE OBJECTION WAS SERVED ON YOU, YOUR CLAIM MAY BE DISALLOWED WITHOUT A HEARING.

# **REPRESENTED PARTIES SHOULD ACT THROUGH THEIR ATTORNEY.**

Steven Balasiano, in his capacity as Plan Administrator of Stage Stores, Inc. and Specialty Retailers, Inc. (together, the "<u>Debtors</u>"), hereby files this eleventh omnibus (nonsubstantive) objection (this "<u>Objection</u>") to certain proofs of claim pursuant to Section 502 of Title 11 of the United States Code (the "<u>Bankruptcy Code</u>"), Rules 3001 and 3007 of the Federal Rules of Bankruptcy Procedures (the "<u>Bankruptcy Rules</u>"), and Rule 3007-1 of the Local Bankruptcy Rules of the United States Bankruptcy Court for the Southern District of Texas (the "<u>Local Rules</u>") for entry of an order substantially in the form attached hereto as <u>Exhibit B</u> (the

"<u>Proposed Order</u>") disallowing and expunging certain proofs of claim (the "<u>Proofs of Claim</u>"). In support of the Objection, the Plan Administrator submits the Declaration of Douglas W. Squasoni of Saccullo Business Consulting, LLC attached hereto as <u>Exhibit A</u> (the "<u>Squasoni</u> <u>Declaration</u>"), and respectfully represents as follows:

#### JURISDICTION AND VENUE

1. This Court has jurisdiction to consider this Motion under 28 U.S.C. §§ 157 and 1334. This is a core proceeding under 28 U.S.C. § 157(b). The Plan Administrator consents to entry of a final order under Article III of the United States Constitution.

2. Venue is proper in this district under 28 U.S.C. §§ 1408 and 1409.

#### BACKGROUND

3. On May 10, 2020 (the "<u>Petition Date</u>"), each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code with this Court.

4. Additional information about the Debtors' business and the events leading up to the Petition Date can be found in the *Disclosure Statement for the Amended Joint Chapter 11 Plan of Stage Stores, Inc. and Specialty Retailers, Inc.* [Docket No. 535].

5. On June 18, 2020, the Court entered the Order (I) Setting Bar Dates for Filing Proofs of Claim, Including Request for Payment Under Section 503(b)(9), (II) Establishing Amended Schedules Bar Date and Rejection Damages Bar Date, (III) Approving the Form of and Manner for Filing Proofs of Claim, Including Section 503(b)(9) Requests, (IV) Approving Notice of Bar Date, and (V) Granting Related Relief [Docket No. 478] (the "Bar Date Order"). Among other things, the Bar Date Order established (i) July 24, 2020 at 5:00 p.m. (CT) as the general deadline for all persons and entities, other than governmental units, to file prepetition claims against the Debtors' estates (the "<u>General Bar Date</u>") and (ii) November 6, 2020 at 5:00

Debtors' estates (the "<u>Governmental Bar Date</u>", and together with the General Bar Date, the "<u>Bar Dates</u>").

6. On August 13, 2020, the Debtors filed the *Joint Second Amended Chapter 11 Plan of Stage Stores, Inc. and Specialty Retailers, Inc.* [Docket No. 694] (the "<u>Plan</u>").

7. On August 14, 2020, the Court entered the Order Confirming the Joint Second Amended Chapter 11 Plan of Stage Stores, Inc. and Specialty Retailers, Inc. [Docket No. 705] (the "<u>Confirmation Order</u>").

8. The effective date of the Plan occurred on October 30, 2020 [Docket No. 898] (the "<u>Effective Date</u>"). On the Effective Date, Steven Balasiano, in his capacity as Plan Administrator, became the sole representative of the Debtors' estates for the purpose of, *inter alia*, making or facilitating distributions contemplated under the Plan. *See* Plan Art.IV.D.

9. The Confirmation Order established (i) September 14, 2020 as the initial bar date for Administrative Claims<sup>2</sup> arising after the Petition Date through the date the Confirmation Order was entered (the "<u>First Administrative Bar Date</u>") and (ii) November 30, 2020 as the final bar date for Administrative Claims arising on or after the date the Confirmation Order was entered but prior to the Effective Date (the "<u>Final Administrative Bar Date</u>", and together with the First Administrative Bar Date, the "<u>Administrative Bar Dates</u>"). Both the Plan and Confirmation Order expressly provide that "requests for payment of Allowed Administrative Claims must be Filed and served on the Debtors or the Wind-Down Debtors no later than the Administrative Claims Bar Date. Holders of Administrative Claims that are required to, but do

not, File and serve a request for payment of such Administrative Claims by such date shall be forever barred, estopped, and enjoined from asserting such Administrative Claims against the Debtors or their property, and such Administrative Claims shall be deemed satisfied, settled, and released as of the Effective Date." *See* Plan Art. II.A; Confirmation Order ¶ 119.

10. As of the date hereof, the Plan Administrator has filed ten (10) omnibus claims objections to certain Proofs of Claim to date, all of which have been approved by the Court. *See* Docket Nos. 1124, 1125, 1138, 1139, 1141, 1142, 1143, 1144, 1185, 1186.

11. In addition, on July 7, 2022, the Court entered the Order (A) Approving Omnibus Claims Objection Procedures and Filing of Substantive Omnibus Claims Objections, (B) Waiving the Requirement of Bankruptcy Rule 3007(E)(6), and (C) Granting Related Relief [Docket No. 1161] (the "<u>Claims Objection Procedures Order</u>").

12. Pursuant to the Claims Objection Procedures Order, the Plan Administrator may, among other things:

(a) file omnibus objections that include objections to claims on any basis provided for in Bankruptcy Rule 3007(d), Bankruptcy Local Rule 3007-1, and/or the Additional Grounds;<sup>3</sup> and

(b) object to more than 100 claims in a single omnibus objection on any of the bases set forth in Bankruptcy Rule 3007(d) or the Additional Grounds.

#### **RELIEF REQUESTED**

13. As part of the claims reconciliation process, the Plan Administrator has identified

particular Proofs of Claim that should be disallowed and expunged in their entirety because they

either (i) fail to provide sufficient supporting documentation for the Plan Administrator to verify the underlying merits of the claim, (ii) were untimely filed after the applicable Bar Date or Administrative Bar Dates, (iii) amend and supersede subsequently filed claims, or (iv) were filed in the wrong case and against the wrong Debtor entity. For the reasons set forth below, the Plan Administrator objects to each of the Proofs of Claim identified on (i) <u>Schedule 1</u> to the Proposed Order ("<u>Insufficient Documentation Claims</u>"), (ii) <u>Schedule 2</u> to the Proposed Order ("<u>Late-Filed <u>Claims</u>"), (iii) <u>Schedule 3</u> to the Proposed Order ("<u>Amended and Superseded Claims</u>"), and (iv) <u>Schedule 4</u> to the Proposed Order ("<u>Wrong Debtor Claims</u>", and together with the Insufficient Documentation Claims, Late-Filed Claims, and Amended and Superseded Claims, the "<u>Disputed</u> <u>Claims</u>"). Pursuant to section 502 of the Bankruptcy Code, Bankruptcy Rule 3007, and the Claims Objection Procedures Order, the Plan Administrator respectfully seeks entry of the Proposed Order disallowing and expunging the Disputed Claims.</u>

#### **BASIS FOR RELIEF REQUESTED**

14. A filed proof of claim is deemed allowed unless a party in interest objects. *See* 11 U.S.C. § 502(a). Under section 1111(a) of the Bankruptcy Code, scheduled claims are treated as proofs of claim. *See id.* § 1111(a) (stating that a proof of claim is deemed filed under section 501 of the Bankruptcy Code for any claim appearing in the schedules, except those "scheduled as disputed, contingent, or unliquidated"). As such, the Plan Administrator must review all claims, including those appearing in the Schedules and Statements, in these chapter 11 cases as part of the claims reconciliation process.

15. As set forth in Bankruptcy Rule 3001(f), a properly executed and filed proof of claim constitutes *prima facie* evidence of the validity and the amount of the claim under section 502(a) of the Bankruptcy Code. *See, e.g., In re O'Connor*, 153 F.3d 258, 260 (5th Cir. 1998); *In re Tran*, 351 B.R. 440, 444 (Bankr. S.D. Tex. 2006), *aff'd*, 369 B.R. 312 (S.D. Tex. 2007); *In re*

*Texas Rangers Baseball Partners*, No. 10-43400 (DML), 2012 WL 4464550, at \*2 (Bankr. N.D. Tex. Sept. 25, 2012).

16. To receive the benefit of *prima facie* validity, however, a proof of claim must assert factual allegations that would entitle the claimant to recovery. *In re Heritage Org., LLC*, No. 04-35574 (BJH), 2006 WL 6508477, at \*8 (Bankr. N.D. Tex. Jan. 27, 2006). Additionally, a claimant's proof of claim is entitled to the presumption of *prima facie* validity under Bankruptcy Rule 3001(f) only until an objecting party refutes at least one of the allegations that is essential to the claim's legal sufficiency. *See In re Fidelity Holding Co., Ltd.*, 837 F.2d 696, 698 (5th Cir. 1988); *In re Starnes*, 231 B.R. 903, 912 (N.D. Tex. 1998). Once an allegation is refuted, "the burden shifts to the claimant to prove its claim by a preponderance of the evidence." *In re Congress, LLC*, 529 B.R. 213, 219 (Bankr. W.D. Tex. 2015). "The ultimate burden of proof always lies with the claimant." *In re Armstrong*, 347 B.R. 581, 583 (Bankr. N.D. Tex. 2006).

17. Objections may be joined in an omnibus objection if such objections are based on the grounds that the claims should be disallowed, in whole or in part, for any of eight enumerated reasons in Bankruptcy Rule 3007, including when the claims duplicate other claims or were not timely filed. Fed. R. Bankr. P. 3007(d). Further, pursuant to the Claims Objection Procedures Order, the Plan Administrator (i) may file an omnibus objection to claims on the Additional Grounds and (ii) may include more than 100 claims on such omnibus objection.

18. Accordingly, the Disputed Claims are not enforceable and should be disallowed and expunged for the reasons set forth below and in <u>Schedules 1-4</u>.

#### **OMNIBUS OBJECTION**

#### A. Insufficient Documentation Claims

19. With respect to each of the Insufficient Documentation Claims identified on <u>Schedule 1</u> to the Proposed Order, the Plan Administrator has carefully reviewed the Debtors' books and records and the Proofs of Claim, including the supporting documentation provided by the claimants, if any, and has determined that the Proofs of Claim contain insufficient information and/or documentation to allow the Plan Administrator to ascertain the validity of the claim. As such, each of the Insufficient Documentation Claims fails to satisfy the requirements for a proof of claim.

20. For the reasons set forth above and in <u>Schedule 1</u> to the Proposed Order, the Plan Administrator seeks to disallow and expunge the Insufficient Documentation Claims in their entirety. Disallowing and expunging the Insufficient Documentation Claims is necessary to ensure that the claimants ultimately entitled to receive distributions from the Debtors' estates receive the appropriate treatment and distribution.

#### B. Late-Filed Claims

21. With respect to each of the Late-Filed Claims identified on <u>Schedule 2</u> to the Proposed Order, the Plan Administrator has carefully reviewed the Proofs of Claim, including the supporting documentation provided by the claimants, if any, and determined that the Late-Filed Claims were not timely filed. claim in writing. Also, among other things, the Confirmation Order established (i) September 14, 2020 as the First Administrative Bar Date for Administrative Claims arising after the Petition Date through the date the Confirmation Order was entered to be filed and (ii) November 30, 2020 as the Final Administrative Bar Date for Administrative Claims arising on or after the date the Confirmation Order was entered but prior to the Effective Date to be filed.

22. The Plan Administrator objects to the Late-Filed Claims because they (a) were subject to either the General Bar Date, Governmental Bar Date, First Administrative Bar Date or Final Administrative Bar Date, as applicable and (b) were filed after the applicable Bar Date or Administrative Bar Dates. Moreover, the Plan Administrator believes that each claimant asserting a Late-Filed Claim was provided timely and adequate notice of the applicable Bar Date or Administrative Bar Dates.

23. For the reasons set forth above and in <u>Schedule 2</u> to the Proposed Order, the Plan Administrator seeks to disallow and expunge the Late-Filed Claims in their entirety. Disallowing and expunging the Late-Filed Claims is necessary to ensure that the claimants ultimately entitled to receive distributions from the Debtors' estates receive the appropriate treatment and distribution.

#### C. Amended and Superseded Claims

24. With respect to each of the Amended and Superseded Claims identified on <u>Schedule 3</u> to the Proposed Order, the Plan Administrator has carefully reviewed the Debtors' books and records and the Proofs of Claim, including supporting documentation provided by the claimants, if any, and has determined that the Amended and Superseded Claims have been amended by a subsequently filed Proof of Claim against the Debtors (collectively, the "<u>Surviving Claims</u>"), which the Plan Administrator has identified on <u>Schedule 3</u> to the Proposed Order.

25. For the reasons set forth above and in <u>Schedule 3</u> to the Proposed Order, the Plan Administrator seeks to disallow and expunge the Amended and Superseded Claims. Failure to disallow and expunge the Amended and Superseded Claims could result in the applicable claimants receiving an unwarranted recovery to the detriment of other similarly situated creditors.

26. For the avoidance of doubt, this Objection does not affect the Surviving Claims, and the Plan Administrator reserves the right to object to the Surviving Claims, as well as the Amended and Superseded Claims, on any grounds whatsoever.

#### D. <u>Wrong Debtor Claims</u>

27. With respect to each of the Wrong Debtor Claims identified on <u>Schedule 4</u> to the Proposed Order, the Plan Administrator has carefully reviewed the Debtors' books and records and the Proofs of Claim, including supporting documentation provided by the claimants, if any. The Plan Administrator has determined that the claimants identified on <u>Schedule 4</u> to the Proposed Order filed Proofs of Claim against multiple Debtor entities, and the Wrong Debtor Claims were filed in the wrong case and against the wrong Debtor entity. The Proofs of Claim filed by the claimants in the correct case and against the correct Debtor entity (collectively, the "<u>Surviving Claims</u>") are identified on <u>Schedule 4</u> to the Proposed Order.

28. For the reasons set forth above and in <u>Schedule 4</u> to the Proposed Order, the Plan Administrator seeks to disallow and expunge the Wrong Debtor Claims. Failure to disallow and expunge the Wrong Debtor Claims could result in the applicable claimants receiving an unwarranted recovery to the detriment of other similarly situated creditors.

29. For the avoidance of doubt, this Objection does not affect the Surviving Claims, and the Plan Administrator reserves the right to object to the Surviving Claims, as well as the Wrong Debtor Claims, on any grounds whatsoever.

#### SEPARATE CONTESTED MATTER

30. This Objection to the Disputed Claims constitutes a separate contested matter as contemplated by Bankruptcy Rule 9014. The Plan Administrator requests that any order entered by this Court with respect to an objection asserted herein shall be deemed a separate order with respect to each Disputed Claim.

#### **RESERVATION OF RIGHTS**

31. The Plan Administrator expressly reserves the right to amend, modify, or supplement this Objection and to file additional substantive or non-substantive objections to the Disputed Claims, or any other claims (filed or not) which may be asserted against the Debtors. In addition, the Plan Administrator reserves the right to seek further reduction of any claim for any reason including to the extent such claim has been paid, and further reserves the right to raise further objections.

#### **COMPLIANCE WITH LOCAL RULES**

32. This Objection includes citations to the applicable rules and statutory authorities upon which the relief requested herein is predicated, and a discussion of their application to this Objection. The Plan Administrator has served notice of this Objection on those persons whose names appear in the signature blocks on the Disputed Claims, and in accordance with Bankruptcy Rule 7004. Finally, the Plan Administrator submits that this Objection satisfies Local Rule 3007-1.

#### **NO PREVIOUS REQUEST**

33. No previous request for the relief sought herein has been made by the Plan Administrator to this or any other court.

#### **NOTICE**

34. Notice of this Objection has been provided to the parties listed on <u>Schedules 1-4</u> of the Proposed Order on those persons whose names appear in the signature blocks on the Disputed Claims.

**WHEREFORE**, the Plan Administrator respectfully requests that the Court (i) enter an order, substantially in the form attached hereto as <u>Exhibit B</u>, granting the relief requested herein and (ii) grant such other and further relief as it deems just and proper.

<u>Response Contents</u>. Each Response must contain the following (at a minimum):

If a subsequent hearing is determined to be necessary, the Plan Administrator shall file with the Court and serve on the affected claimants a notice of the hearing (the date of which shall be determined in consultation with the affected claimant(s)).
