### ORDER GRANTING PLAN ADMINISTRATOR'S TWELFTH OMNIBUS OBJECTION TO CERTAIN PROOFS OF CLAIM

(Reclassify Claims, Satisfied Claims, and Satisfied Scheduled Claims)

Upon the Plan Administrator's twelfth omnibus objection (the "Objection")<sup>2</sup> seeking to reclassify or disallow and expunge the Disputed Claims pursuant to Bankruptcy Code Section 502; and the Court having jurisdiction over this matter pursuant to 28 U.S.C. 157 and §§ 1334(b); and the Court having found that this matter is a core proceeding pursuant to 28 U.S.C. § 157(b)(2), and that the Plan Administrator consents to entry of a final order under Article III of the United States Constitution; and the Court having found that venue of this proceeding and the Objection in this District is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court having determined that the relief requested in the Objection is in the best interests of the Debtors, their estates, their creditors, and other parties in interest; and it appearing that proper and adequate notice of the Objection has been given, under the circumstances, and that no other or further notice is necessary;

and upon the record herein; and after due deliberation thereon; and good and sufficient cause appearing therefore,

### IT IS ORDERED, ADJUDGED AND DECREED THAT:

- 1. The Objection is SUSTAINED as set forth herein.
- 2. The Reclassify Claims listed on <u>Schedule 1</u> attached hereto are hereby reclassified as set forth in the "Modified Claims" column therein.
- 3. The Satisfied Claims listed on <u>Schedule 2</u> hereto are hereby disallowed and expunged in their entirety.
- 4. The Satisfied Scheduled Claims listed on <u>Schedule 3</u> hereto are hereby disallowed and expunged in their entirety.
- 5. Notwithstanding any prior order of this Court concerning scheduled claims numbered 307660 and 307667 also identified as proofs of claim number 2341 and 2351 (the "NUFIC Claims") filed by National Union Fire Insurance Company of Pittsburgh, Pa. ("NUFIC"), the NUFIC Claims shall be allowed as secured claims in the exact amount of letters of credit, letter of credit proceeds and other cash collateral held by NUFIC (together, the "NUFIC Collateral") on the Petition Date. NUFIC shall not be allowed any further or additional secured or priority claim against the Debtors or their estates. NUFIC may retain and use all the NUFIC Collateral, including applying to the NUFIC Collateral to any and all obligations of the Debtors, without further order of the Court and the secured portions of such NUFIC Claims shall be deemed satisfied. NUFIC may be allowed a general unsecured deficiency claim in such amount as the Plan Administrator and NUFIC shall later agree, or in such amount as the Court shall allow after hearing and notice. This provision is without prejudice to the rights of the Plan Administrator or NUFIC under the AIG Insurance Contracts and Article V(C) of the Plan.

6. Notwithstanding anything to the contrary contained herein, nothing herein shall

affect the validity, nature, amount, allowability, priority, or otherwise seek to reclassify, disallow,

or expunge any Proof of Claim set forth on Schedules 1-3 hereto. All parties' rights are reserved

with respect to the "Modified Claims" set forth on Schedules 1-3 hereto, including the Plan

Administrator's right to file a further objection and seek disallowance thereof.

7. The Plan Administrator's rights to amend, modify, or supplement the Objection, to

file additional objections to any claims (filed or not) asserted against the Debtors, and to seek

further reduction of any claim to the extent such claim has been paid, are preserved. Additionally,

should one or more grounds of objection stated in the Objection be overruled, the Plan

Administrator's rights to object on other stated grounds or on any other grounds that the Plan

Administrator discovers are further preserved.

8. The claims, noticing, and solicitation agent, Kurtzman Carson Consultants LLC, is

authorized and directed to update the claims register maintained in these chapter 11 cases to reflect

the relief granted in the Order.

9. Notwithstanding any Bankruptcy Rule or Local Rule to the contrary, this Order

shall be immediately effective and enforceable upon its entry.

10. This Court shall retain jurisdiction over any and all matters arising from the

interpretation, implementation, or enforcement of this Order.
