# ORDER GRANTING PLAN ADMINISTRATORS' MOTION FOR ENTRY OF AN ORDER (I) APPROVING A STIPULATION PURSUANT TO FEDERAL RULE OF BANKRUPTCY PROCEDURE 9019 AND (II) GRANTING RELATED RELIEF

Upon the motion (the "Motion")<sup>2</sup> of Steven Balasiano, in his capacity as Plan Administrator for the chapter 11 estates of Stage Stores, Inc. and Specialty Retailers, Inc. (collectively, the "Debtors") for entry of an order (this "Order") approving the Settlement, attached hereto as Exhibit 1, pursuant to Rule 9019 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"); and this Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; and this Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2), and that this Court having found that venue of this proceeding and the Motion in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; it is HEREBY ORDERED THAT:

- 1. The Motion is GRANTED as set forth herein.
- 2. The Settlement attached hereto as **Exhibit 1** is approved in its entirety pursuant to section 105(a) of the Bankruptcy Code and Bankruptcy Rules 2002 and 9019.

3. The Settlement Administrator shall make all necessary arrangements to prepare and

file any and all required tax forms and/or tax returns in connection with payments to the Claimants.

4. The Settlement Administrator shall be solely responsible for compliance with any

and all other applicable laws in connection with distributions to individual Claimants, including

federal, state and local taxes (including any employment taxes), any escheat, abandoned or

unclaimed funds laws to the extent distribution checks issued to individual Claimants are not

cashed. For the avoidance of doubt, the Plan Administrator shall have no liability to any federal,

state, or local taxing entity for any payments made in connection with the Wage and Hour Actions,

the Proofs of Claim, or the Settlement.

5. The Parties are hereby authorized to take such additional actions or execute such

additional documents as are necessary or appropriate to implement the terms of the Settlement.

6. Notwithstanding the possible applicability of Rule 6004, 7062, or 9014 of the

Bankruptcy Rules or any other Bankruptcy Rule, this Order shall be immediately effective and

enforceable upon its entry and there shall be no stay of effectiveness or execution of this Order.

7. The Court shall retain exclusive jurisdiction over any and all matters arising from

or related to the implementation, interpretation, or enforcement of the Settlement or this Order.

# STIPULATION AND SETTLEMENT AGREEMENT BY AND AMONG THE PLAN ADMINISTRATOR AND VARIOUS CLAIMANTS ALLEGING VIOLATIONS UNDER CERTAIN WAGE AND HOUR LAWS

This stipulation (the "<u>Stipulation</u>") is entered into by and between Steven Balasiano, in his capacity as the Plan Administrator of the above-captioned debtors and debtors in possession (collectively, the "<u>Debtors</u>") and various claimants alleging violations under certain wage and hour laws (the "<u>Claimants</u>," and together with the Plan Administrator, the "<u>Parties</u>"), by and through their counsel Outten and Golden LLP, Shavitz Law Group, P.A., and Hepworth, Gershbaum & Roth PLLC (collectively, "<u>Claimant Counsel</u>"). This Stipulation is made with reference to the following facts:

## **RECITALS**

WHEREAS, on March 12, 2018, certain Claimants commenced an action captioned *Qazi* v. *Stage Stores, Inc. d/b/a Peebles, Inc.* in the United States District Court for the Southern District of Texas under Case No. 4:18-CV-00780 (the "Qazi Action"). The Qazi Action asserts that the

Debtors violated the rights of certain Claimants under certain wage and hour laws, including the Fair Labor Standards Act ("FLSA");

**WHEREAS**, on May 18, 2018, certain Claimants commenced an action captioned *Crosby*, *et al v. Stage Stores Inc.* in the United States District Court for the Middle District of Tennessee under Case No. 3:18-cv-00503 (the "<u>Crosby Action</u>"). The Crosby Action asserts that the Debtors violated the rights of certain Claimants under certain wage and hour laws, including the FLSA;

WHEREAS, on April 2, 2020, certain Claimants commenced an action captioned *Harris* v. Stage Stores Inc. in the United States District Court for the Western District of New York under Case No. 6:20-cv-06205-CJS (the "Harris Action," and together with the Qazi Action and Crosby Action, the "Wage and Hour Actions"). The Harris Action asserts that the Debtors violated the rights of certain Claimants under certain wage and hour laws, including the New York Labor Law;

**WHEREAS**, on May 10, 2020 (the "<u>Petition Date</u>"), each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Southern District of Texas (the "Court");

WHEREAS, on June 18, 2020, the Court entered the *Order (I) Setting Bar Dates for Filing Proofs of Claim, Including Requests for Payment Under Section 503(b)(9), (II) Establishing Amended Schedules Bar Date and Rejection Damages Bar Date, (III) Approving the Form of and Manner for Filings Proofs of Claim, Including Section 503(b)(9) Requests, (IV) Approving Notice of Bar Dates, and (V) Granting Related Relief [Docket No. 478], which established July 24, 2020, as the general deadline for filing proofs of claim and administrative claims against the Debtors (the "Bar Date");* 

WHEREAS, the Claimants, either on their own behalf or by and through Claimant Counsel, filed certain individual and/or class proofs of claim based on the allegations contained in

the Wage and Hour Actions (each a "<u>Proof of Claim</u>" and collectively the "<u>Proofs of Claim</u>") prior to the Bar Date, a list of which is attached hereto as <u>Schedule 1</u> (each a "<u>Proof of Claim</u>" and collectively the "<u>Proofs of Claim</u>");<sup>3</sup>

**WHEREAS**, the Proofs of Claim collectively assert damages entitled to priority unsecured treatment under section 507(a)(4) of the Bankruptcy Code in an aggregate amount in excess of \$1,800,000.00 (the "507(a)(4) Claims") and damages entitled to general unsecured treatment in an aggregate amount in excess of \$34,000,000.00 (the "GUC Claims");

WHEREAS, on August 14, 2020, the Court entered the *Order Confirming the Joint Second Amended Chapter 11 Plan of Stage Stores, Inc. and Specialty Retailers, Inc.* [Docket No. 705] (the "Confirmation Order"). The effective date of the Plan occurred on October 30, 2020 [Docket No. 898] (the "Effective Date");

WHEREAS, on the Effective Date, Steven Balasiano, in his capacity as the Plan Administrator, became the sole representative of the Debtors' estates for the purpose of, *inter alia*, reviewing, settling, and compromising disputes regarding claims filed against the Debtors' estates and facilitating distributions to creditors pursuant to Articles IV.D and VII.B of the Plan;

**WHEREAS**, a bona fide dispute exists between the Plan Administrator and the Claimants regarding the validity, extent, and priority treatment of the Proofs of Claim; and

**WHEREAS**, the Parties seek to resolve the allowable amount and priority of the Proofs of Claim, whether specifically identified in these recitals or otherwise, through this Stipulation.

#### TERMS AND CONDITIONS

**NOW, THEREFORE,** in consideration of the foregoing and the mutual promises of the Parties herein contained, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby stipulate and agree as follows:

- <u>1.</u> <u>Recitals.</u> The recitals set forth above are incorporated herein by this reference as though set forth herein at length.
- <u>2.</u> <u>Effective Date of Stipulation.</u> This Stipulation shall be effective upon its execution by the Parties in compliance with paragraph 13 herein (the "<u>Stipulation Effective Date</u>").
- 3. Approval by the Court. Within thirty (30) days of the Stipulation Effective Date, the Parties shall jointly move, pursuant to Federal Rule of Bankruptcy Procedure Rule 9019, for approval of this Stipulation by the Court.
- 4. Fixing of Liquidated Claim. The Parties hereby agree that upon the approval of this Stipulation by the Court, the Proofs of Claim shall be consolidated and assigned a new proof of claim number, 9000, which shall have a claim amount of \$1,500,000.00 and shall be allowed as a priority unsecured claim pursuant to section 507(a)(4) of the Bankruptcy Code (the "Liquidated Claim"). The Plan Administrator shall be entitled to cause Kurtzman Carson Consultants, LLC dba Verita Global, the claims and noticing agent (the "Claims Agent"), to adjust the official claims register in this case to reflect (i) the allowed status of the Liquidated Claim, (ii) the disallowed and/or expunged status of all Proofs of Claim listed on Schedule 1 (as may be amended from time to time) and any other proof of claim filed by Claimant Counsel or any of the Claimants other than the Liquidated Claim.
- <u>5.</u> <u>Settlement Payment and Distributions to Claimants.</u> Following allowance of the Liquidated Claim, the Plan Administrator shall make a one-time payment in the amount of

\$1,500,000.00 to a settlement administrator designated by Claimant Counsel (the "Settlement Administrator"), for deposit in a qualified settlement fund established by the Settlement Administrator within the meaning of Treasury Regulation § 1.468B-1 et seq., in full and final satisfaction of the Liquidated Claim (the "Settlement Payment"). The Settlement Payment shall be made by the Plan Administrator at such time the Plan Administrator makes distributions on account of other Allowed Priority Unsecured Claims. Claimant Counsel shall provide notice of the identity of the Settlement Administrator to the Plan Administrator in a letter signed by all Claimant Counsel in advance of such payment. Claimant Counsel, on behalf of themselves and the Claimants, represent, warrant, and agree that neither the Debtors nor Plan Administrator shall have any duty or obligation to make, and that it and they shall not make, any distributions to individual Claimants or to pay the fees and expenses of Claimant Counsel, the Claimants, and any of their respective representatives or agents, all of which shall be paid out of the distributions made to the Settlement Administrator. (The aforesaid fees and expenses, and thereafter the balance of the proceeds of the Liquidated Claim, shall be paid by the Settlement Administrator as more particularly set forth in paragraph 6 hereof.) In accordance therewith, (i) the Settlement Administrator shall make all necessary arrangements to prepare and file any and all required tax forms and/or tax returns in connection with payments to Claimants; (ii) the Settlement Administrator shall be solely responsible for compliance with any and all other applicable laws in connection with distributions to individual Claimants, including federal, state and local taxes (including any employment taxes), any escheat, abandoned or unclaimed funds laws to the extent distribution checks issued to individual Claimants are not cashed; and (iii) neither the Debtors nor the Plan Administrator shall have any responsibility or obligation to identify or locate any Claimant. Without limiting the generality of the foregoing, neither the Debtors nor the Plan Administrator shall have any liability whatsoever for any act or omission on the part of the Settlement Administrator or Claimant Counsel.

- 6. Allocation and Distribution of the Proceeds of the Liquidated Claim. The proceeds of the Liquidated Claim shall be divided into fees, expenses, and net proceeds (being the difference between gross proceeds and fees and expenses), which sums shall be allocated and distributed as follows:
  - a. The Lead Plaintiffs and Claimants shall, to the extent of their respective interests in the 507(a)(4) Claims, irrevocably gift to the Claimants to the extent of the GUC Claims the amount of \$150,000.00 (the "GUC Gift").
  - b. The Settlement Administrator shall pay (a) its own fees and reasonably estimated expenses not to exceed \$60,000, (b) \$500,000.00 in the aggregate to Claimant Counsel as legal fees to be apportioned among them as set forth in **Exhibit**A attached hereto, (c) \$150,000.00 to Dundon Advisers LLC as bankruptcy financial and strategic advisers to Claimant Counsel and the Lead Plaintiffs, (d) reimbursements of reasonable and documented expenses of Claimant Counsel as set forth in **Exhibit A** attached hereto, (e) service awards to each of the Lead Plaintiffs of \$5,000.00, and (f) all costs and expenses associated with tax reporting requirements under applicable federal, state, and local law, including payment of applicable taxes to the appropriate taxing authorities.
  - c. The Settlement Administrator shall distribute \$1,500,000.00 less each of the amounts set forth above, less W-2 tax withholdings, to each Claimant *pro rata* to the calculated 507(a)(4) claim of each Claimant on their respective Proof of Claim.

- d. The Settlement Administrator shall distribute the GUC Gift, less W-2 tax withholdings, to each Claimant *pro rata* to the calculated general unsecured claim of each Claimant on their respective Proof of Claim.
- 7. No Assignment of Claims. Claimant Counsel and Lead Plaintiffs represent and warrant that they have not assigned or transferred, or purported to assign or transfer, to any person or entity, any claim or any portion thereof or interest therein, including, but not limited to, any interest in the Wage and Hour Actions, or any related action.
- 8. <u>Unclaimed Distributions.</u> The Settlement Administrator shall contribute to a charity selected by Claimant Counsel (a) any funds in respect of a check uncashed for one more than one (1) year from its mailing and (b) any funds due a Claimant whose check for such amount was undeliverable after two attempts, a location effort customary and reasonable in the class action settlement administration industry being made between the first and second attempt.
- 9. <u>Dismissal of Wage Actions.</u> Within five (5) days of the Settlement Administrator's receipt of the Settlement Payment from the Plan Administrator, Claimant Counsel shall file a notice of dismissal with prejudice in each of the Wage Actions.
- 10. Binding Effect. This Stipulation and each and every covenant, warranty, release and agreement set forth herein shall be binding upon and inure to the benefit of each of the Parties hereto and their respective agents, subsidiaries, employees, officers, directors, predecessors, successors, and assigns.
- 11. Governing Law. This Stipulation shall be governed by and construed in accordance with the laws of the State of Texas without regard to any law concerning the conflicts of laws. Any disputes arising in connection with this Stipulation shall be adjudicated by the Court.

- 12. Confidentiality. The terms of this Stipulation and all negotiations leading up to the execution of the Stipulation shall be deemed confidential and shall not be further disclosed to any person or entity except as required by applicable law, rule or regulation (including, without limitation, the requirements under any federal or state securities laws, rules or regulations that may require disclosure of the terms of this Stipulation or the fact that this Stipulation has been entered into), unless otherwise agreed in writing by the Plan Administrator.
- Originals and Counterparts. This Stipulation may be executed in separate counterparts, each of which shall constitute an original, and all of which shall constitute a single agreement. It shall not be necessary, in making proof of this Stipulation, to produce or account for more than one (1) complete set of counterparts. Further, this Stipulation may be executed by transfer of a scanned signature by facsimile or e-mail in PDF format, each of which shall be as fully binding as an original document.
- 14. No Waiver. The Parties agree that no breach of any provision hereof can be waived except in writing. The waiver of a breach of any provision hereof shall not be deemed a waiver of any other breach of any provision hereof.
- 15. Severability. Should any provision of this Stipulation be held by a court of competent jurisdiction to be illegal, invalid or unenforceable for any reason, then the remaining portions of this Stipulation will nonetheless remain in full force and effect, unless such portion of the Stipulation is so material that its deletion would violate the obvious purpose and intent of the Parties.
- 16. Entire Agreement. This Stipulation constitutes the entire agreement between the Parties with respect to the subject matter of it. There are no other covenants, promises, agreements, conditions or understandings, either oral or written, expressed or implied, between the

Parties, except for this Stipulation with respect to its subject matter. The terms are contractual and

not merely recitals. No alteration, amendment or modification shall be effective or binding upon

any Party unless in writing and duly executed by all Parties.

<u>17.</u> <u>Acknowledgements.</u> The Parties acknowledge they have carefully read

and fully understand the terms of this Stipulation. They have jointly negotiated and prepared this

Stipulation and are fully satisfied with all of its terms. The individuals executing this Stipulation

are authorized to do so on behalf of the organizations and/or individuals for which they execute

this Stipulation and have had a full opportunity to consult with legal counsel regarding the terms.

Claimant Counsel specifically acknowledges it has the power to settle and resolve the Proofs of

Claim identified on **Schedule 1**. The Parties have entered into this Stipulation knowingly and

voluntarily and agree to all of its provisions.

18. No Admissions. Except with respect to the enforcement of the terms of

this Stipulation, nothing herein and no action taken by any of the Parties hereto shall be construed

as an admission or concession with respect to the merits of the Wage and Hour Actions, or any

other claims or causes of action.


