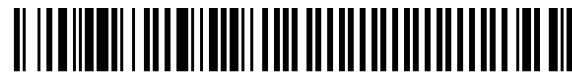

**PLAINTIFFS DEMAND JURY TRIAL**

1 Plaintiffs BRUCE MORRELLI, JOSE ROJAS, JANICE ANDRES, SANDRA CRUZ-  
2 PEREZ, VICTORIA MARTINEZ, VERONICA VIZCARRA, and LAURA PADILLA  
3 (collectively "Plaintiffs") bring this action against Defendants CORIZON HEALTH, INC. and  
4 DOES 1 through 25, inclusive (hereinafter "Defendants"), and hereby allege as follows:

5 **GENERAL ALLEGATIONS COMMON TO EACH CAUSE OF ACTION**

6 1. Plaintiff BRUCE MORRELLI ("MORELLI") is an individual residing in Tulare  
7 County, California, and employed in Tulare County as a licensed vocational nurse by  
8 Defendants, and each of them, between approximately November 2013 and June 2018. Plaintiff  
9 MORRELLI's employment with the Defendant, and each of them, was involuntarily terminated  
10 in June, 2018 when the Defendant, and each of them lost their contract with the County of  
11 Tulare. MORELLI worked inside one of the several facilities ran by and operated in Tulare  
12 County to house inmates. During MORELLI's employment with Defendant, he was paid a  
13 straight time rate of approximately \$22.83 per hour for each 12.5-hour shift worked. Defendant  
14 scheduled MORELLI to work from either 6:00 p.m. to 6:30 a.m. or 6:00 a.m. to 6:30 p.m., three  
15 shifts per week. However, each week he worked, he was required to work past his scheduled  
16 hours to (1) record his care and treatment in prisoner's charts, (2) give report to the employee  
17 who was scheduled to relieve him, and/or (3) work until a relief could be located. Once per  
18 12.5-hour shift, Defendant required MORELLI to clock out for thirty (30) minutes to record a  
19 meal period. However, at the time of hire, Defendant instructed MORELLI that he was  
20 required to remain present on the work site to respond to emergencies and to attend to prisoner  
21 care at all times, even during meal and rest periods. Defendant typically scheduled only one  
22 employee per work shift. Defendant did not provide relief during meal periods and did not  
23 permit MORELLI to leave the work site during meal periods and therefore, on each shift  
24 worked, he remained under the control of the Defendant while he was clocked out and not paid.  
25 When MORELLI was required to work more than 12.5 hours charting, giving report, or waiting  
26 for relief, Defendant did not provide him with a second opportunity to clock out and take a  
27 second meal period. Therefore, MORELLI is entitled to a minimum of four (4) hours of half-  
28 time pay for every 12.5 hour shift worked, ½ hour of double time pay for meal periods deducted

1 from his hours worked, double time pay for time worked in excess of 12 hours, one hour of  
2 premium pay at his regular rate for each off-duty meal period and one hour of premium pay at  
3 his regular rate for each off-duty rest period that Defendant did not provide. The detailed  
4 information concerning MORELLI's compensation, schedule and hours worked is under the  
5 control of the Defendant. Plaintiff MORELLI brings this action in his individual capacity, and  
6 also in a representative capacity on behalf of all other similarly situated California employees of  
7 Defendants, and each of them, during all times relevant to the allegations stated in this  
8 Complaint.

9       2. Plaintiff JOSE ROJAS ("ROJAS") is an individual residing in Tulare County,  
10 California, and employed in Tulare County as a registered nurse by Defendants, and each of  
11 them, between approximately October 2017 and June 2018. Plaintiff ROJAS' employment with  
12 the Defendant, and each of them, was involuntarily terminated in June 2018 when the  
13 Defendant, and each of them lost their contract with the County of Tulare. ROJAS worked  
14 inside one of the several facilities ran by and operated in Tulare County to house and/or house  
15 inmates. During ROJAS' employment with Defendant, he was paid a straight time rate of  
16 approximately \$43.50 per hour for each 12.5-hour shift worked. Defendant scheduled ROJAS  
17 to work from either 6:00 p.m. to 6:30 a.m. or 6:00 a.m. to 6:30 p.m., three shifts per week.  
18 However, each week he worked, he was required to work past his scheduled hours to (1) record  
19 his care and treatment in prisoner's charts, (2) give report to the employee who was scheduled  
20 to relieve him, and/or (3) work until a relief employee could be located. Once per 12.5-hour  
21 shift, Defendant required ROJAS to clock out for thirty (30) minutes to record a meal period.  
22 However, at the time of hire, the Defendant instructed ROJAS that he was required to remain  
23 present on the work site to respond to emergencies and to attend to prisoner care at all times,  
24 even during meal and rest periods. Defendant typically scheduled only one employee per work  
25 shift. Defendant did not provide relief during meal periods and did not permit ROJAS to leave  
26 the work site during meal periods and therefore, each shift worked, he remained under the  
27 control of the Defendant while he was clocked out and not paid. When ROJAS was required to  
28 work more than 12.5-hours charting, giving report, or waiting for relief, Defendant did not

1 provide him with a second opportunity to clock out and take a second meal period. Therefore,  
2 ROJAS is entitled to a minimum of four (4) hours of half-time pay for every 12.5-hour shift  
3 worked, ½ hour of double time pay for meal periods deducted from his hours worked, double  
4 time pay for time worked in excess of 12 hours, one hour of premium pay at his regular rate for  
5 each off-duty meal period and one hour of premium pay at his regular rate for each off-duty rest  
6 period that Defendant did not provide. The detailed information concerning ROJAS’  
7 compensation, schedule and hours worked is under the control of the Defendant. Plaintiff  
8 ROJAS brings this action in his individual capacity, and also in a representative capacity on  
9 behalf of all similarly situated California employees of said Defendants, during all times  
10 relevant to the allegations stated in this Complaint.

11 3. Plaintiff JANICE ANDRES (“ANDRES”) is an individual residing in Tulare  
12 County, California, and employed in Tulare County as a licensed vocational nurse by  
13 Defendants, and each of them, between approximately July 2013 and June 2018. Plaintiff  
14 ANDRES’ employment with the Defendant, and each of them, was involuntarily terminated in  
15 June 2018 when Defendant, and each of them lost their contract with the County of Tulare.  
16 ANDRES worked inside one of the several facilities ran by and operated in Tulare County to  
17 house and/or house inmates. During ANDRES’ employment with the Defendant, she was paid a  
18 straight time rate of approximately \$25.14 per hour for each 12.5-hour shift worked. Defendant  
19 scheduled ANDRES to work from either 6:00 p.m. to 6:30 a.m. or 6:00 a.m. to 6:30 p.m., three  
20 shifts per week. However, each week she worked, she was required to work past her scheduled  
21 hours to (1) record her care and treatment in prisoner’s charts, (2) give report to the employee  
22 who was scheduled to relieve her, and/or (3) work until a relief licensed vocational nurse could  
23 be located. Once per 12.5-hour shift, Defendant required ANDRES to clock out for thirty (30)  
24 minutes to record a meal period. However, the Defendant instructed ANDRES that she was  
25 required to remain present on the work site to respond to emergencies and to attend to patient  
26 care at all times, even during meal and rest periods. Defendant typically scheduled only one  
27 employee per work shift. Defendant did not provide relief during meal periods and did not  
28 permit ANDRES to leave the work site during meal periods and therefore, each shift worked,

1 she remained under the control of the Defendant while she was clocked out and not paid. When  
2 ANDRES was required to work more than 12.5-hours charting, giving report, or waiting for  
3 relief, Defendant did not provide her with a second opportunity to clock out and take a second  
4 meal period. Therefore, ANDRES is entitled to a minimum of four (4) hours of half-time pay  
5 for every 12.5-hour shift worked, ½ hour of double time pay for meal periods deducted from her  
6 hours worked, double time pay for time worked in excess of twelve (12) hours, one hour of  
7 premium pay at her regular rate for each off-duty meal period and one hour of premium pay at  
8 her regular rate for each off-duty rest period that Defendant did not provide. The detailed  
9 information concerning ANDRES' compensation, schedule and hours worked is under the  
10 control of the Defendant. Plaintiff ANDRES brings this action in her individual capacity, and  
11 also in a representative capacity on behalf of all similarly situated California employees of said  
12 Defendants, during all times relevant to the allegations stated in this Complaint.

13 4. Plaintiff SANDRA CRUZ-PEREZ ("CRUZ-PEREZ") is an individual residing  
14 in Kings County, California, and employed in Tulare County as a licensed vocational nurse by  
15 Defendants, and each of them, between approximately July 2013 and June 2018. Plaintiff  
16 CRUZ-PEREZ's employment with the Defendant, and each of them, started approximately July  
17 1, 2013 and was involuntarily terminated in June 2018 when Defendant, and each of them lost  
18 their contract with the County of Tulare. CRUZ-PEREZ worked inside one of the several  
19 facilities ran by and operated in Tulare County to house and/or house inmates. During CRUZ-  
20 PEREZ's employment with the Defendant, she was paid a straight time rate of approximately  
21 \$24.75 per hour for each 12.5-hour shift worked. Defendant scheduled CRUZ-PEREZ to work  
22 from 6:00 a.m. to 6:30 p.m. three shifts per week. However, each week she worked, she was  
23 required to work past her scheduled hours to (1) record her care and treatment in prisoner's  
24 charts, (2) give report to the employee who was scheduled to relieve her, and/or (3) work until a  
25 relief could be located. Once per twelve (12) hour shift, Defendant required CRUZ-PEREZ to  
26 clock out for thirty (30) minutes to record a meal period. However, the Defendant instructed  
27 CRUZ-PEREZ that she was required to remain present on the work site to respond to  
28 emergencies and to attend to patient care at all times, even during meal and rest periods.

1 Defendant typically scheduled only one employee per work shift. Defendant did not provide  
2 relief during meal periods and did not permit CRUZ-PEREZ to leave the work site during meal  
3 periods and therefore, each shift worked, she remained under the control of the Defendant while  
4 she was clocked out and not paid. When CRUZ-PEREZ was required to work more than 12.5-  
5 hours charting, giving report, or waiting for relief, Defendant did not provide her with a second  
6 opportunity to clock out and take a second meal period. Therefore, CRUZ-PEREZ is entitled to  
7 a minimum of four (4) hours of half-time pay for every 12.5-hour shift worked, ½ hour of  
8 double time pay for meal periods deducted from her hours worked, double time pay for time  
9 worked in excess of twelve (12) hours, one hour of premium pay at her regular rate for each off-  
10 duty meal period and one hour of premium pay at her regular rate for each off-duty rest period  
11 that Defendant did not provide. The detailed information concerning CRUZ-PEREZ  
12 compensation, schedule and hours worked is under the control of the Defendant. Plaintiff  
13 CRUZ-PEREZ brings this action in her individual capacity, and also in a representative capacity  
14 on behalf of all similarly situated California employees of said Defendants, during all times  
15 relevant to the allegations stated in this Complaint.

16 5. Plaintiff VICTORIA MARTINEZ (“MARTINEZ”) is an individual residing in  
17 Tulare County, California, and employed in Tulare County as a licensed vocational nurse by  
18 Defendants, and each of them, between approximately July 2013 and June 2018. Plaintiff  
19 MARTINEZ’s employment with the Defendant, and each of them, was involuntarily terminated  
20 in June 2018 when Defendant, and each of them lost their contract with the County of Tulare.  
21 MARTINEZ worked inside one of the several facilities ran by and operated in Tulare County to  
22 house and/or house inmates. During MARTINEZ’s employment with the Defendant, she was  
23 paid a straight time rate of approximately \$25.75 per hour for each 12.5-hour shift worked.  
24 Defendant scheduled MARTINEZ to work from either 6:00 p.m. to 6:30 a.m. or 6:00 a.m. to  
25 6:30 p.m., three shifts per week. However, each week she worked, she was required to work  
26 past her scheduled hours to (1) record her care and treatment in prisoner’s charts, (2) give report  
27 to the employee who was scheduled to relieve her, and/or (3) work until a relief could be  
28 located. Once per 12.5-hour shift, Defendant required MARTINEZ to clock out for thirty (30)

1 minutes to record a meal period. However, the Defendant instructed MARTINEZ that she was  
2 required to remain present on the work site to respond to emergencies and to attend to patient  
3 care at all times, even during meal and rest periods. Defendant typically scheduled only one  
4 employee per work shift. Defendant did not provide relief during meal periods and did not  
5 permit MARTINEZ to leave the work site during meal periods and therefore, each shift worked,  
6 she remained under the control of the Defendant while she was clocked out and not paid. When  
7 MARTINEZ was required to work more than 12.5-hours charting, giving report, or waiting for  
8 relief, Defendant did not provide her with a second opportunity to clock out and take a second  
9 meal period. Therefore, MARTINEZ is entitled to a minimum of four (4) hours of half-time  
10 pay for every 12.5-hour shift worked, ½ hour of double time pay for meal periods deducted  
11 from her hours worked, double time pay for time worked in excess of 12 hours, one hour of  
12 premium pay at her regular rate for each off-duty meal period and one hour of premium pay at  
13 her regular rate for each off-duty rest period that Defendant did not provide. The detailed  
14 information concerning MARTINEZ compensation, schedule and hours worked is under the  
15 control of the Defendant. Plaintiff MARTINEZ brings this action in her individual capacity, and  
16 also in a representative capacity on behalf of all similarly situated California employees of said  
17 Defendants, during all times relevant to the allegations stated in this Complaint.

18           6. Plaintiff VERONICA VIZCARRA (“VIZCARRA”) is an individual residing in  
19 Fresno County, California, and employed in Tulare County as a registered nurse by Defendants,  
20 and each of them, between approximately July 2013 and June 2018. Plaintiff VIZCARRA’s  
21 employment with the Defendant, and each of them, was involuntarily terminated in June 2018  
22 when the Defendant, and each of them lost their contract with the County of Tulare.  
23 VIZCARRA worked inside one of the several facilities ran by and operated in Tulare County to  
24 house and/or house inmates. During VIZCARRA’s employment with the Defendant, she was  
25 paid a straight time rate of approximately \$49.90 per hour for each 12.5-hour shift worked.  
26 Defendant scheduled VIZCARRA to work from either 6:00 p.m. to 6:30 a.m. or 6:00 a.m. to  
27 6:30 p.m., three shifts per week. However, each week she worked, she was required to (1) work  
28 past her scheduled hours to record her care and treatment in prisoner’s charts, (2) give report to



1 the employee who was scheduled to relieve her, and/or (3) work until a relief licensed  
2 vocational nurse could be located. Once 12.5-hour shift, Defendant required VIZCARRA to  
3 clock out for thirty (30) minutes to record a meal period. However, the Defendant instructed  
4 VIZCARRA that she was required to remain present on the work site to respond to emergencies  
5 and to attend to prisoner care at all times, even during meal and rest periods. Defendant  
6 typically scheduled only one employee per work shift. Defendant did not provide relief during  
7 meal periods and did not permit VIZCARRA to leave the work site during meal periods and  
8 therefore, each shift worked, she remained under the control of the Defendant while she was  
9 clocked out and not paid. When VIZCARRA was required to work more than 12 hours charting,  
10 giving report, or waiting for relief, Defendant did not provide her with a second opportunity to  
11 clock out and take a second meal period. Therefore, VIZCARRA is entitled to a minimum of  
12 four (4) hours of half-time pay for every 12.5-hour shift worked, ½ hour of double time pay for  
13 meal periods deducted from her hours worked, double time pay for time worked in excess of  
14 twelve (12) hours, one hour of premium pay at her regular rate for each off-duty meal period  
15 and one hour of premium pay at her regular rate for each off-duty rest period for that Defendant  
16 did not provide. The detailed information concerning VIZCARRA's compensation, schedule  
17 and hours worked is under the control of the Defendant. Plaintiff VIZCARRA brings this action  
18 in her individual capacity, and also in a representative capacity on behalf of all similarly  
19 situated California employees of said Defendants, during all times relevant to the allegations  
20 stated in this Complaint.

21 7. Plaintiff LAURA PADILLA ("PADILLA") is an individual residing in Tulare  
22 County, California, and employed in Tulare County as a licensed vocational nurse by  
23 Defendants, and each of them, between approximately July 2014 and June 2018. Plaintiff  
24 PADILLA's employment with the Defendant, and each of them, was involuntarily terminated in  
25 June, 2018 when the Defendant, and each of them lost their contract with the County of Tulare.  
26 PADILLA worked inside one of the several facilities ran by and operated in Tulare County to  
27 house and/or house inmates. During Ms. PADILLA's employment with the Defendant, she was  
28 paid a straight time rate of approximately \$25.75 per hour for each 12.5-hour shift worked.

1 Defendant scheduled PADILLA to work from either 6:00 p.m. to 6:30 a.m. or 6:00 a.m. to 6:30  
2 p.m. three shifts per week. However, each week she worked, she was required to work past her  
3 scheduled hours to (1) record her care and treatment in prisoner's charts, (2) give report to the  
4 employee who was scheduled to relieve her, and/or (3) work until a relief could be located.  
5 Once per twelve (12) hour shift, Defendant required PADILLA to clock out for thirty (30)  
6 minutes to record a meal period. However, the Defendant instructed PADILLA that she was  
7 required to remain present on the work site to respond to emergencies and to attend to patient  
8 care at all times, even during meal and rest periods. Defendant typically scheduled only one  
9 employee per work shift. Defendant did not provide relief during meal periods and did not  
10 permit PADILLA to leave the work site during meal periods and therefore, she remained under  
11 the control of the Defendant while she was clocked out and not paid. When PADILLA was  
12 required to work more than 12 hours charting, giving report, or waiting for relief, Defendant did  
13 not provide her with a second opportunity to clock out and take a second meal period.  
14 Therefore, PADILLA is entitled to a minimum of four (4) hours of half-time pay for every  
15 twelve (12) hour shift worked, ½ hour of pay for meal periods deducted from her hours worked,  
16 double time pay for time worked in excess of twelve (12) hours, one hour of premium pay at her  
17 regular rate for off-duty meal periods and one hour of premium pay at her regular rate for off-  
18 duty rest periods that Defendant did not provide. The detailed information concerning  
19 PADILLA's compensation, schedule and hours worked is under the control of the Defendant.  
20 Plaintiff PADILLA brings this action in her individual capacity, and also in a representative  
21 capacity on behalf of all similarly situated California employees of said Defendants, during all  
22 times relevant to the allegations stated in this Complaint.

23           8. Plaintiffs are informed and believe and, based thereon, allege that Defendant  
24 CORIZON HEALTH, INC. ("CORIZON") is, and at all relevant times was, a Delaware  
25 corporation doing business in the Counties of Fresno, Santa Clara, and Tulare, and in other  
26 counties in California. Defendant CORIZON is a corporation which at all times herein alleged  
27 does or did business regularly and in contact with citizens and entities, public and private,  
28 within the State of California, and maintained business premises and employees within

1 California. At all times alleged herein, Defendants, and each of them employed Plaintiffs and  
2 class members as registered nurses (“RN’s”), and licensed vocational nurses (“LVN’s”), to  
3 provide health care services to individuals incarcerated within the correctional facilities  
4 throughout the State of California. Plaintiffs allege on information and belief that the  
5 Defendant, CORIZON entered into contracts with various counties throughout the State of  
6 California supply its employee RN’s and LVN’s to provide health care services to individuals  
7 incarcerated within correctional facilities throughout the State of California. Defendant,  
8 CORIZON employed more than 50 RN’s and LVN’s in California within the four (4) years  
9 preceding the filing of the initial complaint in this Action.

10 9. The true names and capacities of the Defendants sued herein as DOES 1 through  
11 25, inclusive, whether individual, corporate, associate or otherwise, are unknown to Plaintiffs,  
12 who therefore sue such Defendants by their fictitious names pursuant to California Code of  
13 Civil Procedure section 474. Plaintiffs are informed and believe that each of the DOE  
14 Defendants are liable to Plaintiffs under the same theories and causes of action as set forth in  
15 this complaint. Plaintiffs are informed and believe and thereon allege that the DOE Defendants  
16 are California residents and/or do business regularly and in contact with citizens and entities,  
17 public and private, within the State of California. Plaintiffs will amend this complaint to show  
18 the true names and capacities of the DOE defendants when the same have been ascertained.

19 10. Plaintiffs allege on information and belief that at all relevant times DOES 1  
20 through 25 are and/or were managing agents of Defendants, and each of them, with policy-  
21 making authority to set wages, hire, fire, and discipline employees, and with supervisory control  
22 over Plaintiffs and all other class members.

23 11. Plaintiffs are informed and believe and thereon allege that each of the  
24 Defendants identified herein was at all times relevant hereto the agent, employee, servant,  
25 representative or alter ego of the remaining Defendants, and was acting, at least in part, within  
26 the course a scope of such relationship.

27 12. Plaintiffs are informed and believe, and based thereon allege that at all relevant  
28 times Defendants, and each of them, were members of, and engaged in a joint venture,

1 partnership and common enterprise, and that in acting or making the omissions herein alleged,  
2 were acting within the course and scope of, and in pursuit of, said joint venture, partnership and  
3 common enterprise.

4 13. Plaintiffs are informed and believe, and based thereon allege that at all relevant  
5 times Defendants, and each of them, ratified each and every act or omission alleged herein.  
6 Plaintiffs further allege on information and belief that at all relevant times Defendants, and each  
7 of them, aided and abetted the acts and omissions of each and all of the other Defendants and  
8 proximately caused the damages and shared in the unjust enrichment alleged herein.

9 14.a. Plaintiffs are informed and believe, and based thereon allege that Defendants,  
10 and each of them, through their agents and employees (not including the Plaintiffs and other  
11 class members), established and carried out a policy which violated California's wage and hour  
12 laws cited herein, in that Plaintiffs and class members were not paid wages according to  
13 California law for hours they were required to work, including hours devoted to (1) work during  
14 statutory lunch and break periods; (2) work constituting more than eight (8) hours per day; and  
15 (3) work constituting more than twelve (12) hours per day.

16 14.b. Defendants, and each of them, required Plaintiffs and class members to work a  
17 minimum of three (3) *12.5 hour* shifts per week. Plaintiffs and class members were scheduled  
18 to work, and did work, approximately three (3) *12.5 hour* shifts per week during their  
19 employment. Plaintiffs are informed and believe that the Defendant, and each of them, paid the  
20 Plaintiffs and class members straight time wages for each twelve hour shift worked. However,  
21 Defendant, and each of them, did not pay the Plaintiffs and class members overtime wages for  
22 the hours they worked in excess of eight per day. Therefore, Plaintiffs and class members are  
23 owed at least four hours of one-half time their regular rate of pay for each *12.5 hour* shift  
24 worked.

25 14.c. Plaintiffs occasionally worked more than 12 hours per shift. For example, when  
26 the RN or LVN who was scheduled to relieve the Plaintiffs or class members after their  
27 regularly scheduled twelve (12) hour shift called in sick or did not show up to work, the  
28 Plaintiffs or class members were required to remain at work, continuing their patient care, until

1 a replacement could be found. As a result, Plaintiffs and class members worked more than  
2 twelve (12) hours per day on occasion. However, the Defendants, and each of them did not pay  
3 Plaintiffs and class members double time wages for the shifts during which they were required  
4 to remain at work for more than twelve hours. Therefore, Plaintiffs and class members are owed  
5 double time wages for each shift in which the Plaintiffs or class members were required to  
6 remain at work more than twelve (12) hours.

7 14.d. Plaintiffs are informed and believe that the Defendant, and each of them,  
8 implemented and communicated a policy prohibiting Plaintiffs and class members from leaving  
9 the work site during their scheduled work shifts. Plaintiffs are informed and believe that  
10 Defendant's, and each of their, contract with Tulare County, *Fresno County*, *Santa Clara*  
11 *County* and other counties throughout out California that required Defendant to keep at least one  
12 nursing staff member within the facility at all times to respond to emergencies and inmate  
13 health care needs. Additionally, Defendant, and each of them, carried out a business policy and  
14 practice to staff the county facilities with only one nursing professional. As a result of the  
15 contractual obligations the Defendant owed to the County of Tulare and other counties  
16 throughout California, Defendant, and each of them, implemented a policy and practice  
17 prohibiting the Plaintiffs and class members from leaving the work place during statutorily  
18 required off-duty meal and rest breaks. Accordingly, Plaintiffs and class members remained  
19 under Defendant's control during meal and rest break time. Moreover, Defendant did not  
20 provide Plaintiffs with adequate rest break facilities. Despite being under the Defendant's  
21 control during break time, Defendant required Plaintiffs to clock in and out during meal period  
22 time so the time could be deducted from their total hours worked each shift. The practice of  
23 automatically deducting meal period time from the total hours worked each day resulted in ½ to  
24 1 hours worked per shift for which zero wages were paid. Therefore, Defendant, and each of  
25 them, failed to provide off-duty meal and rest breaks as required by California law, wrongfully  
26 restricted plaintiffs and class members to the work site instead of allowing off-duty meal breaks,  
27 and unlawfully deducted paid time daily for meal breaks it failed to provide.



- 1 (b) Whether Defendants, and each of them, implemented and engaged in a systematic  
2 practice of failing to pay class members all wages required by California law for all  
3 time worked, and whether Defendants automatically deducted time from each class  
4 members' daily hours worked for meal breaks not actually taken;
- 5 (c) Whether Defendant, and each of them, engaged in practices by which they failed to  
6 provide meal breaks to class members as required by California law, including, but  
7 not limited to the systematic practice of scheduling employees such that they could  
8 not leave their work posts unattended to take a meal break, or by failing to relieve  
9 employees of their employer's control by forbidding or preventing them from  
10 leaving the workplace during meal breaks;
- 11 (d) Whether Defendants, and each of them, systematically and pervasively failed to  
12 provide employees with the requisite number of paid rest breaks for the number of  
13 hours in their shifts, pursuant to California law;
- 14 (e) Whether Defendants, and each of them, knew or had reason to know that class  
15 members regularly continued to work through meal periods, while deducting 30  
16 minutes or more of pay each day for meal breaks not actually taken;
- 17 (f) Whether Defendants, and each of them, failed to keep, maintain or furnish accurate  
18 records of the actual hours worked by class members;
- 19 (g) Whether Defendants, and each of them, willfully failed to pay all wages due and  
20 owing to all class members whose employment was terminated; and
- 21 (h) Whether the systematic acts and practices of Defendants constituted unfair business  
22 practices and resulted in the unjust enrichment of Defendants, in violation of  
23 California's Unfair Competition Law (Business & Professions Code sections 17200  
24 *et seq.*)

25 19. Common questions of law and fact predominate over questions affecting only  
26 individual class members in that the policies and practices complained of herein are and have  
27 been applied uniformly to all class members and administered through systematic and uniform  
28 human resources and payroll practices.

29 20. Class treatment will be superior to individual suits in this case because it  
30 involves a corporate employer or employers and many similarly situated individual employees.  
31 If each employee were required to file an individual lawsuit, the corporate Defendants would  
32 necessarily gain an unconscionable advantage, as they would be able to exploit and overwhelm  
33 the limited resources of each individual Plaintiff and class member with their vastly superior  
34 financial and legal resources. The claims of individual class members are not sufficiently large  
35 to warrant vigorous individual prosecution considering all of the concomitant costs and  
36 expenses. Class treatment is also desirable because a common trial of the predominantly  
37 common questions raised by this suit will be comparatively expedient, will conserve judicial  
38

1 and public resources, minimize the number of jurors whose participation will be required, and  
2 minimize the burden on parties and witnesses who otherwise would be required to repeat their  
3 testimony in numerous trials. the claims of individual class members are not sufficiently large to  
4 warrant vigorous individual prosecution considering all of the concomitant costs and expenses.

5 21. Class treatment is also desirable because requiring each class member to pursue  
6 an individual remedy would discourage the assertion of lawful claims by employees who would  
7 be disinclined to file an action against their former and/or current employer for real and  
8 justifiable fear of retaliation and permanent damage to their careers at their current or  
9 subsequent employment.

10 22. The prosecution of separate actions by individual class members, even if  
11 possible, would be undesirable and inferior to class treatment because separate actions would  
12 create a substantial risk of inconsistent or varying adjudications, potentially establishing  
13 incompatible standards of conduct for Defendants, and producing inconsistent outcomes among  
14 individual class members. Such inconsistent results, as a practical matter, could be dispositive  
15 of and harmful to the interests of absent class members, and could substantially impair their  
16 ability to protect their interests.

17 23. As class representatives, Plaintiffs will fairly and adequately represent and  
18 protect the interests of the absent class members, in that Plaintiffs have no conflicts of interest  
19 that would be antagonistic to others class members.

20 24. Plaintiffs have retained and are represented by attorneys who are competent and  
21 experienced in the successful prosecution of wage and hour class action litigation.

22 25. Plaintiffs and class members have all suffered similar irreparable harm and  
23 damages as a result of the unlawful, wrongful, and inequitable conduct of Defendants, and each  
24 of them. This class action suit will provide substantial benefits to the public as well as to class  
25 members because, absent this action, the conduct of Defendants, and each of them, would  
26 continue unremedied and uncorrected. The remedies sought by Plaintiffs include injunctive  
27 relief that would restrain Defendants from further gaining unjust enrichment at the expense of  
28 California employees and would discourage other similarly situated employers from engaging



1 in similar wrongful and unfair practices.

2 26. Plaintiffs intend to move to amend this complaint, when appropriate, to include a  
3 class claim for PAGA penalties.

4  
5 **FIRST CAUSE OF ACTION**  
6 **VIOLATION OF LABOR CODE section 510**  
7 **Failure to Pay Overtime (against all Defendants)**

8 27. Plaintiffs reallege and here incorporate by reference each of the allegations set  
9 forth in Paragraphs 1 through 26, inclusive. California Labor Code section 510 and California  
10 Industrial Welfare Commission (“IWC”) Wage Order No. 4-2001, section 3, require employers  
11 to pay overtime wages at a statutorily prescribed rate for any work in excess of eight hours in a  
12 day or forty hours in a week, and a double time rate for work in excess of twelve hours in a day.  
13 At all relevant times, Defendants, and each of them, assigned Plaintiffs and class members to  
14 work at least three (3) twelve-hour shifts per work week.

15 28. Said Defendants scheduled and supervised Plaintiffs and all class members, and  
16 therefore knew or should have known the hours they worked. Plaintiffs worked openly in the  
17 workplace and did nothing to hide their work from Defendants.

18 29. Plaintiffs and class members regularly worked more than eight hours per day ~~and~~  
19 ~~occasionally more than 40 hours per week~~. In violation of California law, Defendants, and each  
20 of them, failed to pay Plaintiffs and class members the required minimum and overtime wages  
21 for all time worked. Plaintiffs have a private right to sue for unpaid wages pursuant to Labor  
22 Code section 1194 (a) and therefore seek relief from this court.

23 30. As a result of Defendants’ failure to pay lawful minimum and overtime wages,  
24 Plaintiffs and class members have been injured, and Defendants have been unjustly enriched.  
25 Plaintiffs and class members therefore are entitled to relief, including but not limited to  
26 damages and restitution in amounts exceeding the minimum jurisdiction of this court, plus  
27 statutory penalties, interest, reasonable attorneys' fees, costs of suit and other remedies, all as set  
28 forth below in Plaintiffs’ prayer for relief.

///

**SECOND CAUSE OF ACTION**  
**VIOLATION OF LABOR CODE sections 512(a) and 226.7,**  
**and IWC WAGE ORDER NO. 4-2001, section 11**  
**Failure to Provide Compliant Meal Breaks (against all Defendants)**

1  
2  
3 31. Plaintiffs reallege and here incorporate by reference each of the allegations set  
4 forth in Paragraphs 1 through 30, inclusive.

5 32. At all relevant times, Labor Code sections 226.7(b) and 512(a), section 11 of  
6 California IWC Wage Order No. 4-2001, and other California law required Defendant  
7 employers to provide off-duty meal periods to Plaintiffs and class members of not less than 30  
8 minutes for each day worked of five hours or more, and to provide a second meal period of at  
9 least 30 minutes for each day worked of 10 hours or more.

10 33. Defendants, and each of them, required Plaintiffs and class members to work  
11 more than five hours per day without being given the opportunity to take a 30-minute  
12 uninterrupted off-duty meal break, and more than 10 hours per day without being given the  
13 opportunity to take a second 30-minute meal break. Said Defendants deducted 30 minutes or  
14 more per day from the wages paid to Plaintiffs and class members, and failed to relinquish  
15 control over Plaintiffs and class members during meal breaks by failing to relieve them of all  
16 work obligations and by prohibiting them, either expressly or through regulation of their work  
17 requirements, from leaving the work premises during such breaks.

18 34. Defendants, and each of them, failed to pay Plaintiffs and class members an  
19 additional hour of pay at the regular rate for each time a compliant meal break was not  
20 provided, as required by Labor Code Sections 226.7(b) and 512(a), section 11 of IWC Wage  
21 order No. 4-2001, and other California law.

22 35. As a result of said Defendants' failure to provide compliant meal breaks,  
23 Plaintiffs and class members have been injured, and Defendants have been unjustly enriched.  
24 Plaintiffs and class members therefore are entitled to relief, including but not limited to  
25 damages and restitution in the amount of one additional hour of pay at their regular rate of  
26 compensation for each time an off-duty meal period was not provided, plus statutory penalties,  
27 interest, reasonable attorneys' fees, costs of suit and other remedies, all as set forth below in  
28 Plaintiffs' prayer for relief.



**FOURTH CAUSE OF ACTION**  
**VIOLATION OF LABOR CODE sections 223 and 1194, and IWC WAGE**  
**ORDER NO. 4-2001, section 4**  
**Failure to Pay Minimum Wages and Claim for Liquidated Damages,**  
**Labor Code section 1194.2 (Against all Defendants)**

41. Plaintiffs reallege and here incorporate by reference each of the allegations set forth in Paragraphs 1 through 40, inclusive.

42. At all relevant times, Labor Code Section 1194, IWC Wage Order No. 4-2001, Section 4, and other California law required Defendant, and each of them, to pay at least minimum wages for all the time Plaintiffs and class members were suffered or permitted to work, or were under their employer's control. Defendants, and each of them, automatically deducted time from Plaintiffs' and class members' total hours worked for meal periods that were not provided, during which times Plaintiffs and Class Members were working, and/or remained under said Defendants' control, in that they were not permitted to leave the work premises. By making these deductions, said Defendant, and each of them, failed to pay Plaintiffs and class members at least minimum wages as required by law.

43. Defendants, and each of them, knew or had reason to know that Plaintiffs and class members worked during times when wages were deducted for 30 minutes of meal time. Plaintiffs and class members worked during such times openly, at the direction, and under the control and supervision of said Defendants.

44. As a result of said Defendants' failure to pay at least minimum wages, Plaintiffs and class members have been injured, and Defendants have been unjustly enriched. Plaintiffs and class members therefore are entitled to relief, including but not limited to damages and restitution in the amount of the unpaid wages, liquidated damages, pursuant to Labor Code section 1194.2 in an amount equal to the wages unlawfully unpaid and interest thereon, plus statutory penalties, interest, reasonable attorneys' fees, costs of suit and other remedies, all as set forth below in Plaintiffs' prayer for relief.

2 **FIFTH CAUSE OF ACTION**  
3 **VIOLATION OF LABOR CODE section 226**  
4 **Failure to Provide Accurate Wage Statements (Against all Defendants)**

5 45. Plaintiffs reallege and here incorporate by reference each of the allegations set  
6 forth in Paragraphs 1 through 40, inclusive.

7 46. At all relevant times, Defendants, and each of them were required by Labor Code  
8 Section 226(a) and other California law to furnish Plaintiffs and class members accurate  
9 itemized wage statements, in writing, accurately stating such information as as the gross wages  
10 earned, the total hours worked, the net wages earned and all applicable hourly rates during each  
11 pay period.

12 47. Defendants, and each of them, knowingly and intentionally failed to provide  
13 wage statements containing complete and accurate information with respect to the items listed  
14 in California Labor Code 226(a). Among other things, said wage statements do not accurately  
15 set forth the number of overtime hours worked, or the hours worked during times for which  
16 wages were deducted for meal breaks. As a result, of such deficiencies, Plaintiffs and class  
17 members cannot promptly and easily determine from the wage statements alone the total hours  
18 worked each pay period and the applicable hourly rates for each of the regular, overtime, and  
19 double time hours worked each pay period. Accordingly, the Plaintiffs and class members have  
20 suffered injury as defined by California Labor Code Section 226(e)(2).

21 48. As a result of said Defendants' failure to provide compliant wage statements, ay  
22 at least minimum wages, Plaintiffs and class members are entitled to recover from Defendants,  
23 and each of them, the greater of their actual damages or fifty dollars (\$50) for the initial  
24 violation of Labor Code Section 226(a) and one hundred dollars (\$100) for each subsequent  
25 violation, up to a maximum of \$4,000 per person, plus statutory penalties, interest, reasonable  
26 attorneys' fees, costs of suit and other remedies, all as set forth below in Plaintiffs' prayer for  
27 relief.

28 ///

2 **SIXTH CAUSE OF ACTION**  
3 **VIOLATION OF LABOR CODE sections 201, 202 and 203**  
4 **Failure to Pay All Wages Due and Owing at Termination of Employment**  
5 **(Against all Defendants)**

6 49. Plaintiffs reallege and here incorporate by reference each of the allegations set  
7 forth in Paragraphs 1 through 48, inclusive.

8 50. During the class period, the some Plaintiffs and class members terminated their  
9 employment, voluntarily or involuntarily, with Defendant employers. California Labor Code  
10 sections 201, 202, and 203, and other California law require employers to pay all wages due and  
11 owing immediately upon an employee's involuntarily termination of employment, and within  
12 72 hours to employees who quit voluntarily. Defendants, and each of them, failed to pay all  
13 wages due and owing to employees whose employment was terminated, in that no payment ever  
14 has been made to any of such employees for the unpaid minimum wages, overtime wages,  
15 double-time wages, meal and rest break premiums, and other wage claims herein alleged. The  
16 statutory time for payment has expired for all such employees.

17 51. Defendants, and each of them, willfully failed to pay Plaintiffs and class  
18 members all the wages due and owing at the time of discharge in that, among other things, said  
19 Defendants knew or had reason to know that no overtime or double time wages had been paid to  
20 them, and wages had been deducted on a daily basis for off-duty meal breaks that were not  
21 provided, all as hereinabove alleged.

22 52. As a result of said Defendants' failure to make timely payment of wages owed at  
23 the time of separation from employment, Plaintiffs and class members have been injured, and  
24 Defendants have been unjustly enriched. Plaintiffs and class members therefore are entitled to  
25 relief, including but not limited to damages and restitution in the amount of the unpaid wages,  
26 penalties of continuing wages under Labor Code section 203, statutory penalties, interest,  
27 reasonable attorneys' fees, costs of suit and other remedies, all as set forth below in Plaintiffs'  
28 prayer for relief.

**SEVENTH CAUSE OF ACTION**  
**VIOLATION OF BUSINESS AND PROFESSIONS CODE**  
**sections 17200 *et seq.***

**Unfair Competition-Unfair Business Practices (Against all Defendants)**

53. Plaintiffs reallege and here incorporate by reference each of the allegations set forth in Paragraphs 1 through 52, inclusive.

54. By doing the things and making the omissions herein alleged, Defendants, and each of them engaged in unlawful, fraudulent, and unfair business practices which have been and continue to be harmful to Plaintiffs and class members and to the general public. As such, the above-alleged practices constitute violations of Business and Professions Code Sections 17200 *et seq.* Specifically, any business practice that violates any state law or regulation may constitute the basis of a violation of Business and Professions Code Sections 17200 *et seq.*

55. Among other things, the following practices of Defendants, as alleged above, constitute unfair and unlawful business practices in violation of California Business and Professions Code Section 17200 *et seq.*:

- (a) Failure to pay overtime wages;
- (b) Failure to pay minimum wages;
- (c) Failure to provide meal breaks;
- (d) Failure to provide rest breaks;
- (e) Failure to pay premium wages owed for failing to provide compliant meal and rest breaks (*i.e.*, an additional hour of pay at Plaintiff's regular rate of pay);
- (f) Failure to provide statutorily compliant wage statements;
- (g) Failure to pay all wages due and owing upon termination of employment; and
- (h) Failure to pay the appropriate employer share of taxes, social security, state disability insurance, 401K benefits, and other employer-paid obligations.

56. By the herein alleged practices of Defendant employers, Plaintiffs and class members have suffered injuries to their property interests in that they have been deprived, among other things, of wages, benefits, and interest to which they are lawfully entitled.

57. Defendants, and each of them, have been and continue to be unjustly enriched by the practices herein alleged, in that said Defendants have saved all the expenses of lawful payment of wages to their employees, including but not limited to the wages themselves, the various tax and insurance obligations associated with payment of wages. In addition, said Defendants have unjustly gained continuing access to and use of the funds that should have

1 been paid to use such funds. This unjust enrichment was obtained at the expense of Plaintiffs  
2 and class members, such that Plaintiffs and class members are entitled to disgorgement of the  
3 full amount of such unjust enrichment as a just and equitable remedy. Accordingly, Plaintiffs  
4 and class members are entitled to restitution of wages, benefits, and other property and gains  
5 obtained by Defendants, and each of them.

6 58. Plaintiffs, class members, and the general public have been, and will continue to  
7 be irreparably harmed if the practices herein alleged are allowed to continue, in that such  
8 practices are detrimental and contrary to the public policy of the State of California to promote  
9 and protect the interests of employees through enforcement of the State's wage and hour laws.  
10 Accordingly, in addition to all other remedies sought by this suit, Defendants, and each of them,  
11 should be permanently enjoined from such practices, pursuant to the provisions of Business and  
12 Professions Code sections 17200 *et seq.*

13 **PRAYER FOR RELIEF**

14 **PLAINTIFFS DEMAND TRIAL BY JURY**

15 WHEREFORE, Plaintiffs pray for judgment against all Defendants, as follows:

16 1. For unpaid minimum wages, overtime wages, and double time wages, with  
17 interest thereon, as appropriate and available under each cause of action alleged hereinabove,  
18 including but not limited to compensatory and statutory damages of any kind authorized under  
19 the California Labor Code or any other statutory or decisional law, all in amounts according to  
20 proof at trial;

21 2. For statutory damages, benefits, penalties and restitution, as appropriate and  
22 available under each cause of action alleged hereinabove, in amounts according to proof at trial,  
23 including, but are not limited to, waiting time penalties pursuant to Labor Code Section 203,  
24 penalties for non-compliant wage statements pursuant to Labor Code Section 226(e), premium  
25 wages for failure to provide meal and rest breaks pursuant to Labor Code 226.7 and Wage  
26 Order No. 4-2001, and liquidated damages pursuant to Labor Code 1194.2.

27 3. For restitution and disgorgement to Plaintiffs and class members, from  
28 Defendants, and each of them, of all funds or the value of all gains or benefits unlawfully



1 acquired or retained by said Defendants, by means of any acts or practices declared by the court  
2 to be violative of the California Labor Code and/or Industrial Welfare Commission Wage  
3 Orders, or found by the court to constitute unfair competition or unfair business practices under  
4 California Business and Professions Code sections 17200 et seq.

5 4. ~~For a permanent injunction, prohibiting defendants, and each of them, from~~  
6 ~~engaging in any and all practices found by the court to constitute unfair competition, unfair~~  
7 ~~business practices, or other violation of California's Unfair Competition Law (Business and~~  
8 ~~Professions Code sections 17200 et seq.).~~

9 5. For interest as allowed by California Labor Code sections, including, but not  
10 limited to, 218.6 and 1194, 1194.2, and California Civil Code sections 3287 and 3289;

11 6. For reasonable attorney's fees, expenses and costs as provided by California  
12 Labor Code sections, including, but not limited to, 218.5, 226, 1194, et seq., the applicable IWC  
13 Wage Order, or California Code of Civil Procedure section 1021.5; and

14 7. For such other and further relief as the Court deems just and proper.
