ORDER (Service Packet) Plaintiff's Application to Proceed In Forma Pauperis (Doc. [2]) is granted. As required by the accompanying Order to the appropriate government agency, Plaintiff must pay the \$350.00 filing fee and is assessed an initial partial filing fee of \$84.88. Count Two is dismissed without prejudice. Defendants Shinn, Hensley, Stickley, Reed. Milburn, and John Does 2-5 are dismissed without prejudice. Defendants Gay, Hughes, and Merriman must answer Count One of the Complaint. The Clerk of Court must send Plaintiff a service packet including the Complaint (Doc. [1]), this Order, and both summons and request for waiver forms for Defendants Gay, Hughes, and Merriman. Plaintiff must complete and return the service packet to the Clerk of Court within 21 days of the date of filing of this Order. The United States Marshal will not provide service of process if Plaintiff fails to comply with this Order. Defendants Gay, Hughes, and Merriman must answer the Complaint or otherwise respond by appropriate motion within the time provided by the applicable provisions of Rule 12(a) of the Federal Rules of Civil Procedure. Plaintiff is granted 120 days from the filing date of this Order in which to discover by subpoena, or otherwise, the actual identity of "John Doe #1," and to file a "notice of substitution" providing that Defendant's actual name. The Clerk of Court must issue a subpoena in blank and send it to Plaintiff. If Plaintiff fails to file a "notice of substitution" within 120 days from the filing date of this Order, the Clerk of Court must dismiss Defendant "John Doe #1" without prejudice and without further notice to Plaintiff. Plaintiff's Motion for Status (Doc. [8]) is granted to the extent this Order informs him of the present status of this case. Plaintiff's Motion for Service (Doc. [5]) is denied as moot.
