So, I had a friend on the outside call for me. She said Rosario Saldana is my Case Manager over my claim against TEHUM CARE SERVICES, INC., the Debtor, case no. 23-90086 (CML). As an Administrative Claim Holder, I filed a claim on May 2, 2025, but it has not been ruled on by Court yet. Which is past the 35 days. I am writing to know the status of this claim. Do you know when the Court may be issuing a ruling? If not, could you please give me some kind of written response stating a time frame, because I have to file a response in the U.S. District of Michigan, Eastern District, Southern Division, Case No. 2:22-cv-12105, by December 2, 2025. And I have already been granted a 45 day extension by Magistrate Judge Anthony P. Patti. Would please let me know whats going?

Please give this letter to Case Manager Ms. Salana. And is there some kind of Local Court Rules for the Bankruptcy District Court and could you send me a copy. When I received Opt-Out Form from Tehum, timely filled it out and sent it back to them. I see the Court on August 7, 2025, Tehum Care Servs., 2025 Bankr. LEXIS 1888, has ruled on their Motion to Enjoin and my name is listed. I have never received a copy the Plan, Disclosure Statement, or the Solicitation Order. I did write Tehum requesting a copy and they never responded. Would you please send me a copy of those materials. I need to know how proceed in this matter.
