I haven't received NOT one payment and the e-mail address doesn't belong to me! Accompanying this letter is an November 21, 2021, which cites this said payment.


I would like a probe into payment pay out? I request any and all present with future payments be immediately hal- and all present with future paym

**RESPONSE BY LIQUIDATING TRUSTEE TO
PARTICIPANT LETTER FILED ON NOVEMBER 19, 2021 [DOCKET NO. 3704]**

Stephen B. Darr, the duly appointed Liquidating Trustee (the "Liquidating Trustee") of the reorganized bankruptcy estates of TelexFree, LLC, TelexFree, Inc., and TelexFree Financial, Inc. (collectively, the "Reorganized Debtors" or "TelexFree") respectfully files this response to the letter received by the Court on July 6, 2021 from Ismael Vasquez respecting the status of his claim and distributions thereon. The Liquidating Trustee can report the following:

1. Although the claimant did not provide a claim number, the Liquidating Trustee was able to locate Claim No. 107485 filed by Gerson Ismael Vasquez, who is presumed to be the claimant.
2. Claim No. 107485 was allowed in the amount filed (\$1,425). An initial distribution was made on the claim on April 2, 2021 via prepaid Amazon card to the electronic mail address buuu1991@hotmail.com.
3. The Liquidating Trustee is unable to match any claim to the address used by the claimant in the letter filed with the Court, nor is he able to locate any other claim having the claimant's name.
