RESPONSE BY LIQUIDATING TRUSTEE TO PARTICIPANT LETTER FILED ON OCTOBER 25, 2022 [DOCKET NO. 3755]

Stephen B. Darr, the duly appointed Liquidating Trustee (the "Liquidating Trustee") of the reorganized bankruptcy estates of TelexFree, LLC, TelexFree, Inc., and TelexFree Financial, Inc. (collectively, the "Reorganized Debtors" or "TelexFree") respectfully files this response to the letter received by the Court on October 25, 2022 from Ismael Vasquez respecting the status of his claim and distributions thereon. The Liquidating Trustee can report the following:

- 1. Mr. Vasquez made a similar inquiry to the Court on November 19, 2021 [docket no. 3704], to which the Liquidating Trustee responded on November 22, 2021 [docket no. 3705].
- 2. Although the claimant did not provide a claim number, the Liquidating Trustee notes that Claim No. 107485 was filed by Gerson Ismael Vasquez, who is presumed to be the movant.
- 3. Claim No. 107485 was allowed in the amount filed (\$1,425). A distribution was made on the claim on April 2, 2021 via prepaid Amazon card to the electronic mail address buuu1991@hotmail.com.
- 4. Mr. Vasquez asserts that the electronic mail address noted above does not belong to him. According to the Liquidating Trustee's claims agent, however, this electronic mail

address was used in the filing of the claim and the request for payment and is the only authorized

electronic mail account for this claim. Upon information and belief, the claimant is presently

incarcerated.

5. Mr. Vasquez further requests that any future distributions be directed to another

address. Mr. Vasquez, however, elected to be treated as a Class 2 Participant Convenience

Claim, which was only entitled to a single distribution which was made in April 2021. No

further distributions will be made on this claim.

6. The Liquidating Trustee is unable to match any claim to the address used by the

claimant in the letter filed with the Court, nor is he able to locate any other claim having the

claimant's name.

7. Based upon the foregoing, the Liquidating Trustee does not believe that any

further action is required of the Court.
