(“GXO”), by counsel, hereby gives notice of the amount required to cure the defaults under the Warehouse Agreement effective as of April 1, 2021, as amended on May 24, 2021 (collectively, with all amendments thereto and as amended, modified, and supplemented from time to time, the “Warehouse Agreement”) is \$4,611,866.69

as of June 1, 2024, which consists of \$3,536,826.69 for prepetition charges and \$1,950,258.15 for postpetition charges incurred through June 1, 2024, plus additional postpetition charges that continue to be incurred under the terms of the Warehouse Agreement. The indebtedness is secured by a possessory warehouseman's lien on all of the Debtors' property stored at GXO's warehouse facility in San Bernadino, California.
