 - (a) **Internal Coordination:** Telephone calls, emails, virtual meetings and in-person meetings between members of the Centerview team throughout the case to coordinate, discuss and review various matters. This includes, but is not limited to, frequent discussions to review responses to various diligence questions and requests of other stakeholders, coordinate on the syndication and rating agency processes for the DIP and exit financings, detailed review of new money funding and valuation analyses and other coordination calls and emails related to these cases;
 - (b) **Analysis / Materials Preparation:** Created numerous analyses and presentations, with the input from the Debtors and their other advisors. This includes, but is not limited to, presentations to the rating agencies, lenders and their advisors on bankruptcy and performance related matters as well as materials for the Board of Directors summarizing developments in these cases. In addition, Centerview performed extensive analysis to support their valuation exhibit as well as various analyses on the new money funding and stakeholder claims;

Upon consideration of the application (the “Application”)² of the Debtors for entry of an order (this “Order”) authorizing the Debtors to retain and employ Centerview Partners LLC (“Centerview”) as their investment banker and financial advisor, pursuant to sections 327(a) and 328(a) of the Bankruptcy Code, Bankruptcy Rules 2014(a) and 2016, and Local Rules 2014-1 and 2016-1, effective as of the February 28, 2024 (the “Petition Date”), pursuant to the terms of the Engagement Letter, all as more fully described in the Application; and the Court being satisfied, based on the representations made in the Application and the Greene Declaration, that Centerview does not hold or represent any interest adverse to the Debtors’ estates and is a “disinterested person” as that term is defined in section 101(14) of the Bankruptcy Code, as modified by section 1107(b) of the Bankruptcy Code, and as required under section 327(a) of the Bankruptcy Code; and the Court having jurisdiction to consider the Application and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334, and the *Standing Order of Reference to the Bankruptcy Court Under Title 11*, entered July 23, 1984, and amended on September 18, 2012 (Simandle, C.J.); and consideration of the Application and the requested relief being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before the Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Application having been provided pursuant to the Local Rules; and such notice having been adequate and appropriate under the circumstances, and it appearing that no other or further notice need be provided; and the Court having reviewed the Application; and objections (if any) to the Application having been

IT IS HEREBY ORDERED THAT:

1. The Application is **GRANTED** as set forth herein.
2. Pursuant to section 327(a) and 328(a) of the Bankruptcy Code, Bankruptcy Rules 2014(a) and 2016, and Local Rules 2014-1 and 2016-1, the Debtors are authorized to retain and employ Centerview as their investment banker and financial advisor in these chapter 11 cases, pursuant to the terms and subject to the conditions set forth in the Engagement Letter, a copy of which is attached hereto as **Exhibit 1**, to the extent approved herein.
3. Except to the extent set forth herein, the Engagement Letter, including, without limitation, the Fee and Expense Structure, is approved pursuant to section 328(a) of the Bankruptcy Code, and the Debtors are authorized to pay, reimburse, and indemnify Centerview in accordance with the terms and conditions of, and at the times specified in, the Engagement Letter, as modified herein.
4. Notwithstanding anything in the Application, Greene Declaration, or Engagement Letter to the contrary, Centerview shall apply any remaining amounts of any retainers as a credit toward postpetition fees and expenses, after such postpetition fees and expenses are approved

pursuant to the first order of the Court awarding fees and expenses to Centerview. Centerview is authorized without further order of the Court to apply amounts from any prepetition retainer or advance that would otherwise be applied toward payment of postpetition fees and expenses as are necessary and appropriate to compensate and reimburse Centerview for fees or expenses incurred on or prior to the Petition Date consistent with its ordinary course billing practices. At the conclusion of Centerview's engagement by the Debtors, if the amount of any retainer held by Centerview is in excess of the amount of Centerview's outstanding and estimated fees, expenses, and costs, Centerview will pay to the Debtors the amount by which any retainer exceeds such fees, expenses, and costs, in each case in accordance with the Application and Engagement Letter.

5. Centerview shall file applications for allowance of compensation and reimbursement of expenses pursuant to and in accordance with the procedures set forth in sections 330 and 331 of the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, and any other applicable orders and procedures of this Court; *provided* that the fees, expenses and other compensation payable to Centerview pursuant to the Engagement Letter shall be subject to review pursuant to the standards set forth in section 328(a) of the Bankruptcy Code and shall not be subject to the standard of review set forth in section 330 of the Bankruptcy Code, except, notwithstanding any provisions to the contrary in this Order, the U.S. Trustee shall retain the right and be entitled to object to Centerview's fees, expenses and other compensation based on the reasonableness standard provided for in section 330 of the Bankruptcy Code. the record relating to the Court's consideration of the Application shall not prejudice or otherwise affect the rights of the U.S. Trustee to challenge the reasonableness of Centerview's compensation and expense reimbursements under sections 330 and 331 of the Bankruptcy Code; and the Court retains the right to review any such objection by the U.S. Trustee under section 330 of the Bankruptcy Code. Accordingly, nothing in this Order or the record shall constitute a finding of fact or conclusion of law binding on the U.S. Trustee, on appeal or otherwise, with respect to the reasonableness of Centerview's fees, expenses, and other compensation reimbursement requests.

6. In the event that, during the pendency of these chapter 11 cases, Centerview requests reimbursement for any attorneys' fees and/or expenses, the invoices and supporting time records from such attorneys shall be billed in one-tenth hour increments and included in Centerview's fee applications, both interim and final, and such invoices and time records shall be in compliance with the Local Rules, the U.S. Trustee Guidelines, and the standards of section 330 and 331 of the Bankruptcy Code, without regard to whether such attorney has been retained under section 327 of the Bankruptcy Code and without regard to whether such attorney's services satisfy section 330(a)(3)(C) of the Bankruptcy Code. Notwithstanding the foregoing, Centerview shall only be reimbursed for any legal fees incurred in connection with these chapter 11 cases to the extent permitted under applicable law; *provided, however*, that Centerview shall not seek reimbursement from the Debtors' estates for any fees incurred in defending any of Centerview's fee applications in these chapter 11 cases. have the right to respond or object to Centerview's request for reimbursement of expenses, including but not limited to any request for the reimbursement of legal fees of Centerview's independent counsel, based on the reasonableness standard provided in section 330 of the Bankruptcy Code and not section 328(a) of the Bankruptcy Code.

7. Notwithstanding anything to the contrary in the Application, the Engagement Letter, or herein, the requirements of the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, orders of this Court, the U.S. Trustee Guidelines, or any guidelines regarding submission and approval of fee applications, in light of services to be provided by Centerview and the structure of Centerview's compensation pursuant to the Engagement Letter, Centerview and its professionals shall be granted a limited waiver of the information-keeping requirements of Bankruptcy Rule 2016(a), Local Rule 2016-1, the U.S. Trustee Guidelines, and any otherwise applicable orders or procedures of the Court in connection with the services to be rendered pursuant to the Engagement Letter, and shall instead be required only to maintain time records of its services rendered for the Debtors, including summary descriptions of those services and the approximate time expended in providing those services (in half-hour increments) and will submit, with any interim or final fee application, together with the time records, a narrative summary of services rendered and will identify each professional rendering services and the total amount of compensation requested by Centerview. Centerview's non-restructuring professionals and personnel in administrative departments (including legal) shall not be required to keep time records on a "project category" basis, or conform to any schedule of hourly rates, and will

submit, with any interim or final fee application, together with the time records, a narrative summary of services rendered and will identify each professional rendering services, and the total amount of compensation requested by Centerview.

8. Notwithstanding anything to the contrary in the Application or any of its attachments, or herein, no amounts shall be paid to Centerview absent an order of this Court approving a fee statement or application filed on notice to parties in interest in these chapter 11 cases under the procedures set forth in any order entered by the Court in these chapter 11 cases allowing for interim compensation, except that the Debtors are authorized to pay the \$150,000 Monthly Advisory Fee to Centerview each month when required under the Engagement Letter without a prior fee application; *provided*, however, that Centerview shall file interim fee applications and statements pursuant to the deadlines and other procedures specified for interim fee applications and statements set forth in any order entered by the Court in these chapter 11 cases allowing for interim compensation, except as otherwise expressly set forth in this Order.

9. In the event that Centerview learns of any new material facts or relationships bearing on the matters described herein during the pendency of these chapter 11 cases, Centerview will use reasonable efforts to promptly file a supplemental declaration disclosing such new relevant and material facts or relationships, as required by Bankruptcy Rule 2014(a).

10. The indemnification, contribution, and reimbursement provisions included in the Indemnification Provisions annexed to the Engagement Letter are approved, subject during the pendency of these chapter 11 cases to the following modifications:

- a. Centerview shall not be entitled to indemnification, contribution, or reimbursement pursuant to the Engagement Letter, unless the indemnification, contribution or reimbursement is approved by the Court;
- b. Notwithstanding any provision of the Engagement Letter to the contrary, the Debtors shall have no obligation to indemnify or provide contribution or reimbursement to any Centerview Person for any claim or expense to the extent that it is either: (i) judicially determined (the determination having become final) to have arisen from that Centerview Person's gross negligence, bad faith, breach of fiduciary duty (if any), self-dealing to which the Debtors have not consented, or willful misconduct, (ii) for a contractual dispute in which the Debtors allege breach of that Centerview Person's contractual obligations under the Engagement Letter unless this Court determines that indemnification, contribution or reimbursement would be permissible pursuant to *In re United Artists Theatre Co.*, 315 F.3d 217 (3d Cir. 2003), or (iii) settled without the Debtors' consent prior to a judicial determination as to the exclusions set forth in clauses (i) and (ii) above, but determined by this Court, after notice and a hearing, to be a claim or expense for which that Centerview Person should not receive indemnity, contribution, or reimbursement under the terms of the Engagement Letter, as modified by this Order; and;
- c. If, before the earlier of (i) the entry of an order confirming a chapter 11 plan in these chapter 11 cases (that order having become a final order no longer subject to appeal) and (ii) the entry of an order closing these chapter 11 cases, any Centerview Person believes that it is entitled to the payment of any amounts by the Debtors on account of the Debtors' indemnification, contribution, or reimbursement obligations under the Engagement Letter (as modified by this Order), including, without limitation, the advancement of defense costs, such Centerview Person must file an application before this Court and the Debtors may not pay any such amounts before the entry of an order by this Court approving the payment. This subparagraph (c) is intended only to specify the period of time under which this Court shall have jurisdiction over any request for indemnification, contribution, or reimbursement and not a provision limiting the duration of the Debtors' obligation to indemnify or make contributions or reimbursements to Centerview. All parties in interest shall retain the right to object to any demand by Centerview for indemnification, contribution, or reimbursement in accordance with the terms of this Order.

Any limitation of liability pursuant to the terms and conditions set forth in the Application, the Engagement Letter, or the Ancillary Agreement shall not apply as to any losses, claims, damages, or liabilities for which a Centerview Person would not be entitled to indemnification under the provisions of this Order. Notwithstanding any provision in the Engagement Letter or the Ancillary Agreement thereto to the contrary, the contribution obligations of Centerview shall not be limited to the aggregate amount of fees actually received by Centerview pursuant to the Engagement Letter.

12. Centerview shall use its best efforts to avoid any duplication of services provided by any of the Debtors' other retained professionals in these chapter 11 cases.

13. Notwithstanding anything to the contrary in the Application, the Greene Declaration or the Engagement Letter, all fees paid to Centerview by the Debtors pursuant to the Engagement Letter during these chapter 11 cases are subject to disgorgement unless and until they are approved by the Court on a final basis, after submission of Centerview's final fee application.

14. Notwithstanding anything in the Application or the Engagement Letter to the contrary, to the extent Centerview retains the services of independent contractors or subcontractors (collectively, the "Contractors") in these chapter 11 cases to conduct certain of its investment banking services under the Engagement Letter in its stead and Centerview seeks to pass through to the Debtors, and requests to be reimbursed for, the fees and/or costs of the Contractors, Centerview shall (a) pass through the fees of such Contractors to the Debtors at the

same rate that Centerview pays the Contractors; (b) seek reimbursement for actual costs of the Contractors only; (c) ensure that the Contractors perform the conflicts check required by Bankruptcy Rule 2014 and file with the Court such disclosures as required by Bankruptcy Rule 2014; and (d) attach any such Contractor invoices to its monthly fee statements, interim fee applications, and/or final fee applications filed in these cases.

15. None of the fees payable to Centerview under the Engagement Letter shall constitute a “bonus” or fee enhancement under applicable law.

16. To the extent that there may be any inconsistency between the terms of the Engagement Letter, the Application, the Greene Declaration, and this Order, the terms of this Order shall govern.

17. To the extent the Debtors wish to expand the scope of Centerview’s services beyond those services set forth in or contemplated in the Engagement Letter or this Order (and as to which additional compensation would otherwise be payable), the Debtors shall be required to seek further approval from this Court. The Debtors shall file notice of any proposed additional services and any underlying engagement agreement with the Court and serve such notice on the U.S. Trustee, counsel for the Committee, and any party requesting notice under Bankruptcy Rule 2002. If no such party files an objection within fourteen (14) days of the Debtors filing such notice, such additional services and any underlying engagement agreement may be approved by the Court by further order without further notice or hearing.

19. Notwithstanding anything in the Application or any supporting declarations to the contrary, Centerview shall seek reimbursement from the Debtors’ estates for its engagement-related expenses at the firm’s actual cost.

20. Notwithstanding anything to the contrary in the Application and the Engagement Letter, in the event that any Restructuring Fee and/or Financing Fees are earned and paid to Centerview prior to the conclusion of the Debtors’ pending chapter 11 cases, Centerview shall continue to provide services to the Debtors until the conclusion of these chapter 11 cases pursuant to the terms of the Engagement Letter (unless precluded from doing so as a matter of applicable law, rule, or regulation) unless permitted to cease providing such services following notice and approval of this Court, and shall continue to earn and be paid its Monthly Fees pursuant to the Engagement Letter and this Order until the conclusion of these cases.

21. Upon earning any Restructuring Fee and/or Financing Fees or a portion thereof, Centerview will file a related fee application or otherwise provide notice to the Debtors, the Committee, and the U.S. Trustee, and the Debtors will promptly deposit the earned portion of the Restructuring Fee and/or Financing Fees into an escrow account solely for the benefit of

Centerview. Centerview will file a fee application for approval and payment of any Restructuring Fee and/or Financing Fees from the escrow account.

22. Notwithstanding anything to the contrary contained in the Engagement Letter, including section 11 thereof, the Court shall have exclusive jurisdiction over Centerview's engagement during the pendency of these chapter 11 cases.

23. The Debtors and Centerview are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order.

Dear Mr. Burke:

This letter (this “Agreement”) confirms the terms under which Thrasio Holdings, Inc. and its subsidiaries (collectively, the “Company”) have engaged Centerview Partners LLC (“Centerview”) on an exclusive basis as its financial advisor and investment banker with respect to one or more possible Restructurings (as defined below) or Financings (as defined below) (each Restructuring and Financing, a “Transaction”). The Company may engage Centerview as its financial advisor and investment banker with respect to other financial matters as may be agreed separately in writing during the term of this engagement. For purposes hereof, the term “Company” also includes any entity that the Company may form or invest in to consummate a Transaction, and shall also include any successor to or assignee of all or a portion of the assets and/or businesses of the Company. If appropriate in connection with performing its services for the Company hereunder, Centerview may utilize the services of one or more of its affiliates (“Designated Affiliates”), in which case references herein to Centerview shall include, as applicable, such Designated Affiliates; provided that such Designated Affiliates are instructed to abide by the terms of this Agreement and Centerview shall be responsible for any breach of this Agreement by such Designated Affiliates. The terms of this Agreement shall apply to all services provided by Centerview to the Company in connection with the matters contemplated by herein, including those provided prior to the date of this Agreement.

As used herein, the term “Restructuring” shall mean any restructuring, reorganization, repayment, refinancing, rescheduling or recapitalization of all or any material portion of the liabilities of the Company (or its direct or indirect subsidiaries) and obligations owed to the Company (or its direct or indirect subsidiaries) from other parties (or its affiliates), however such result is achieved, whether in one or more transactions or a series of transactions, including, without limitation, through a plan of reorganization (a “Plan”) going effective or conversion to Chapter 7 or any other liquidation of the Debtors confirmed or approved in connection with a case (a “Bankruptcy Case”) commenced by or against the Company or any of its subsidiaries or affiliates under title 11 of the United States Code (the “Bankruptcy Code”), an exchange offer or consent solicitation, a rescheduling of debt maturities, a change in interest rates, a settlement or forgiveness of debt, a conversion of debt into equity, or other material amendments to the Company’s debt instruments, an issuance of new securities, or a sale, disposition or other transfer (regardless of form), including

to existing creditors of the Company, of all or a significant portion of the equity, interests, assets, properties, cash flows or businesses of the Company, it being understood and agreed that consummation of a Plan will be a Restructuring in any event. For the avoidance of doubt, a Restructuring shall not include any amendments to the existing financial covenants, modifications to the interest rate from cash pay to PIK only (provided any changes to the all-in interest rate shall constitute a Restructuring transaction) or amendments to other non-financial covenants that require support from Required Lenders under the existing bank debt and/or existing Series X preferred equity.

As used herein, the term “Equity Financing” shall mean a private issuance, sale or placement by the Company of equity or equity-linked securities of the Company or customary bridge financing of the Company (“Securities”) with one or more Current or New Investors (as defined below), and the term “Debt Financing” shall mean a public or private issuance, sale or placement by the Company of debt securities, instruments or obligations of the Company with one or more lenders and/or Current Investor or New Investors (each term as defined below and collectively, “Investors”). Equity Financing and Debt Financing shall be collectively referred to herein each as a “Financing”. For the avoidance of doubt, a “Financing” shall not include, and no fees shall be payable hereunder with respect to, any sale or issuance of any securities of the Company or debt of the Company (i) pursuant to contractual obligations of the Company in effect as of the date of this Agreement, (ii) to officers, directors, employees or consultants of the Company, or any member of any such director’s, officer’s, employee’s or consultant’s immediate family or any wealth or estate planning vehicle formed by or for any such person, and the affiliates of any of the foregoing, (iii) to partners for services provided (e.g., pursuant to a collaboration or services agreement), or (iv) pursuant to any merger, acquisition or disposition transaction, including any stock-for-stock transaction but excluding any Financing proceeds that are subsequently used as consideration in a merger, acquisition or disposition transaction.

1. Centerview, as exclusive financial advisor and investment banker to the Company only with respect to those services being provided hereunder in connection with a Transaction, will perform the following financial advisory and investment banking services:
 - a. General Financial Advisory and Investment Banking Services. To the extent requested by the Company, Centerview shall:
 - i. familiarize ourselves with the business, operations, properties, financial condition and prospects of the Company;
 - ii. review the Company’s financial condition and outlook;
 - iii. assist in the development of financial data and presentations to the Company’s Board of Directors, various creditors and other parties;
 - iv. evaluate the Company’s debt capacity and capital structures alternatives;
 - v. participate in negotiations among the Company, and related creditors, suppliers, lessors and other interested parties with respect to any of the transactions contemplated by this Agreement; and

- vi. perform such other financial advisory services as may be specifically agreed upon in writing by the Company and Centerview.
- b. Restructuring Services. To the extent requested by the Company, Centerview shall:
 - i. analyze various Restructuring scenarios and the potential impact of these scenarios on the value of the Company; and the recoveries of those stakeholders impacted by the Restructuring;
 - ii. provide financial and valuation advice and assistance to the Company in developing and seeking approval of a Plan;
 - iii. provide financial advice and assistance to the Company in structuring any new securities to be issued pursuant to the Restructuring;
 - iv. assist the Company and/or participate in negotiations with entities or groups affected by the Restructuring; and
 - v. if requested by the Company, participate in hearings before the bankruptcy court with respect to the matters upon which Centerview has provided advice, including, as relevant, coordinating with the Company's counsel with respect to testimony in connection therewith.
- c. Financing Services. To the extent requested by the Company, Centerview shall:
 - i. provide financial advice and assistance to the Company in structuring and effecting a Financing, identifying potential Investors and, at the Company's request, contacting such Investors;
 - ii. assist in the arranging of a Financing, the due diligence process and negotiating the terms of any proposed Financing; and
 - iii. assist in the arranging and negotiations of any amendments to any existing credit facilities, Series X financing or otherwise required to support a Financing.

It is understood and agreed that nothing contained herein shall constitute an expressed or implied commitment by Centerview to underwrite, place or purchase any securities, in a financing or otherwise, which commitment shall only be set forth in a separate underwriting, placement agency or other appropriate agreement relating to a Financing.

The Company represents and agrees that it has not taken and will not take, directly or indirectly, any action if, as a result, the offer and sale of any Securities in any Financing would fail to be entitled to the exemption from the registration requirements of the Securities Act of 1933, as amended (the "Act"), provided for in Section 4(a)(2) thereof. The Company and acknowledges and agrees that to the extent that any such Securities are offered or sold to Excluded Parties (as defined below), then the Company shall provide that any Securities sold to such Excluded Parties are covered under one or more purchase or subscription agreements that do not mention

Centerview by name and are separate from any purchase or subscription agreement to which any investor that is not an Excluded Party is a party to. The Company further agrees that Centerview shall be entitled to (i) rely on any opinion from counsel issued in connection with any Financing, (ii) reasonably request any representations, warranties and/or covenants of the Company or any investors in any definitive purchase agreement with respect to such Financing ("Financing Purchase Agreement") and (iii) rely on the representations, warranties and covenants of the Company and, if and to the extent customary and agreed by such investors, any investors that are set forth in any Financing Purchase Agreement, if any.

Neither Centerview nor any Designated Affiliate will solicit any investors without the Company's prior approval as to each such investor, including, without limitation, in any jurisdiction other than the United States unless the Company has given Centerview prior permission (including by email) to solicit in such jurisdiction. Neither Centerview nor any Designated Affiliate will offer any securities by any form of general solicitation or general advertising, including but not limited to the methods described in Rule 502(c) under the Act or in any manner involving a public offering within the meaning of Section 4(a)(2) of the Act.

The Company hereby acknowledge and agrees, for the avoidance of doubt, in connection with any Financing, that any Financing shall exclude any potential purchasers that are (a) "retail customers", as defined in Regulation Best Interest promulgated under the Exchange Act ("Regulation Best Interest") other than those "retail customers" that satisfy the requirements for the "family office no-action letter" relating to Regulation Best Interest and Form CRS, and/or (b) not "institutional accounts", as defined in FINRA Rule 4512(c) (collectively the "Excluded Parties"), and Centerview shall have no liability or responsibility with respect to, nor receive any fee in connection with the offering and sale of, any of securities that are offered or sold to any Excluded Party (any such offer or sale, an "Excluded Party Transaction"). The Company further hereby acknowledges and agrees to notify any Excluded Parties (including through express written disclosure contained in the subscription agreements to be executed by the Excluded Parties) that (i) Centerview is not participating in such Excluded Party Transaction nor is Centerview making any recommendation to the Excluded Parties in respect of any Excluded Parties Transaction and (ii) the Excluded Parties are not deemed to be "retail investors" or "retail customers" of Centerview for purposes of either Securities and Exchange Commission Form CRS or Regulation Best Interest. The Company acknowledges that it shall be responsible for perfecting any federal and state law exemptions from registration in connection with any Excluded Party Transaction. The Company acknowledges in this regard that, since Centerview is not participating in any manner in any Excluded Party Transaction, Centerview shall not make, and will have no responsibility to make, any such filing or have any other obligation with respect to the Excluded Party Transaction.

d. Intentionally Omitted.

In rendering its services to the Company hereunder, Centerview is not assuming any responsibility for the Company's underlying business decision to pursue any business strategy or to effect any Transaction. The Company shall have absolute discretion to discuss or negotiate a Transaction, approve or reject any and all offers or terms of any offer, and may terminate negotiations with a potential Investor at any time, and for any reason whatsoever. The Company agrees that Centerview shall not have any obligation or responsibility to provide accounting, audit, "crisis management," or business consultant services for the Company, and shall have no responsibility

for designing or implementing operating, organizational, administrative, cash management or liquidity improvements, or to provide any fairness or valuation opinions. The Company acknowledges that Centerview is not providing any advice on tax, legal, regulatory or accounting matters, and the Company agrees that it will seek and rely on the advice of its own professional advisors for such matters, and will make an independent decision with respect to the matters that are the subject of this engagement based on such advice.

In order to coordinate effectively the Company's and Centerview's activities to effect a Transaction, the Company will promptly inform Centerview of any substantive discussions, negotiations or inquiries from a potential counterparty regarding a possible Transaction (including any such substantive discussions, negotiations or inquiries with a potential counterparty that have occurred in the six month period prior to the date of this Agreement).

During the term of this Agreement, the Company shall make available to Centerview all information in its possession concerning the business, assets, operations, financial condition and prospects of the Company that Centerview reasonably requests in connection with the services to be performed for the Company hereunder, and shall provide Centerview with reasonable access to the Company's officers, directors, employees, independent accountants, and counsel, and other advisors, agents and other representatives of the Company as Centerview reasonably requests. To the Company's knowledge, all information furnished by or on its behalf to Centerview pertaining to the Company, when delivered, will be accurate and complete in all material respects. In addition, the Company agrees that it will promptly notify Centerview of any material event or change in the business affairs, condition (financial or otherwise) of the Company that occurs during the term of our engagement hereunder, or if it learns during the term of this Agreement of any material inaccuracy or misstatement in, or material omission from, any information theretofore delivered to Centerview. The Company understands and agrees that, in performing our services hereunder, Centerview (a) will be using and relying on publicly available information and on materials, data and other information furnished to Centerview by the Company and other parties, (b) is entitled to assume and rely upon the accuracy and completeness of such publicly available information and the other information so furnished without having independently verified the same, and (c) does not assume any responsibility for the accuracy or completeness of such information. Centerview will not conduct an independent evaluation or appraisal of the assets or liabilities (including any contingent, derivative or off-balance sheet assets or liabilities) of the Company, or advise or opine on any solvency or viability issues, nor will it make an inspection of the properties or assets of the Company. With respect to any forecasts or projections that may be furnished to Centerview or discussed with the Company, Centerview will assume that they have been reasonably prepared on bases reflecting the best then currently available estimates and judgments of the management of the Company as to the matters covered thereby. In connection with the services described above, the Company authorizes Centerview to transmit any memorandum prepared by the Company describing the Company and its assets, properties or businesses in connection with a Transaction to potential parties to a Transaction approved in advance by the Company. The Company will be solely responsible for the contents of this memorandum.

2. As compensation for our services, the Company agrees to pay Centerview in cash, by wire transfer of immediately available funds when due, the following fees:

- a. A monthly financial advisory fee of \$150,000 (the “Monthly Advisory Fee”), the first of which shall be due and paid by the Company upon execution of this Agreement and thereafter on each monthly anniversary thereof during the term of this engagement (“Term”). After receipt of aggregate Monthly Advisory Fees of \$450,000, 100% of the amount of any subsequent Monthly Advisory Fee paid to Centerview will be credited (but only once) against any Restructuring Fee payable to Centerview pursuant to subparagraph 2(b).
- b. If at any time during the Term of this engagement or within the twelve full months following the termination of this engagement (such twelve month period, the “Tail Period”, and together with the Term, the “Fee Period”), (1) the Company consummates any Restructuring or (2) the Company enters into an agreement in principle, definitive agreement or Plan to effect a Restructuring, and at any time (including following the expiration of the Fee Period), any Restructuring is consummated, Centerview shall be entitled to receive a fee (“Restructuring Fee”), contingent upon the consummation of a Restructuring and payable at the closing thereof equal to \$9,000,000. Notwithstanding anything to the contrary in this subparagraph 2(b), in connection with any Restructuring that is intended to be effected, in whole or in part, as a prepackaged, partial prepackaged or prearranged plan of reorganization anticipated to involve the solicitation of acceptances of such plan in compliance with the Bankruptcy Code, by or on behalf of the Company, from holders of any class of the Company’s securities, indebtedness or obligations (a “Prepackaged Plan”) the Restructuring Fee shall be payable (x) (i) in the case of a Prepackaged Plan that takes the form of prepackaged or partial prepackaged plan or reorganization, 75% upon receipt of votes from the Company’s creditors necessary to confirm such Prepackaged Plan or (ii) in the case of a Prepackaged Plan that takes the form of a prearranged plan of reorganization, 50% upon obtaining indications of support from the Company’s creditors that in the good faith judgment of the Board of Directors of the Company are sufficient to justify filing such Prepackaged Plan, and (y) the balance shall be payable upon consummation of such Restructuring.
- c. If at any time during the Term, (1) the Company, (A) consummates any Financing or (B) enters into a definitive written agreement for any Financing and such Financing is consummated pursuant to the terms of such definitive written agreement at any time (including following the expiration of the Fee Period) (each of (A) or (B) a “Fee Period Financing”) or (2) except as otherwise set forth in this Agreement, at any time during the Tail Period following the termination or expiration of this engagement, (A) the Company consummates any Financing led by a third party financing source (each, a “New Investor”, which for purposes of this Agreement shall not include Current Investors), a “Tail Period Financing”, which, for the avoidance of doubt shall exclude any Financing raised by the Company from Current Investors without engaging an outside investment banker (other than a Fee Period Financing as provided in subsection (1) of this Section 2.c.) (B) the Company enters into a definitive written agreement for any Tail Period Financing, and such Tail Period Financing is consummated pursuant to the terms of such definitive written agreement at any time (including following the expiration

of the Fee Period), in each instance of subsections (1) or (2) of this Section 2.c., the Company will pay to Centerview the following (the fees set forth in Sections 2.c.i and 2.c.ii are collectively referred to herein as the “Debt Financing Fee”, and the fee set forth in Section 2.c.iii is referred to herein as the “Equity Financing Fee”, and collectively with the Debt Financing Fee, the “Financing Fees” and the each a “Financing Fee”):

- i. 1.00% of the aggregate amount of financing commitments of any indebtedness issued that is secured by a first lien, payable upon the Company’s receipt of any portion of the proceeds of any such Debt Financing;
- ii. 2.50% of the aggregate amount of financing commitments of any indebtedness issued that (x) is secured by a second or junior lien, (y) is unsecured and/or (z) is subordinated, payable upon the Company’s receipt of any portion of the proceeds of any such Debt Financing;
- iii. 3.50% of the aggregate amount of financing commitments to purchase Securities that is in the form of any equity or equity-linked securities or obligations issued, payable upon the Company’s receipt of any portion of the proceeds of any such Equity Financing; and
- iv. 1.00% of the aggregate amount of financing commitments of any debtor-in possession financing (a “DIP Financing”).

provided, however, that notwithstanding anything to the contrary contained in this Agreement, if Centerview terminates this Agreement, or if the Company terminates this Agreement for Cause (as defined below), Centerview shall not be entitled to the any fees under this Agreement (other than any such fees that become payable prior to such termination) with respect to any Transaction that is consummated after such termination. As used herein, termination “Cause” shall mean the termination of this Agreement by the Company as a result of Centerview’s or any Designated Affiliate’s gross negligence, bad faith, fraud (as defined below) or willful misconduct, in each case following a 30 day cure period (if capable of cure), in the performance of its services hereunder or a material breach of confidentiality, it being understood and agreed that the Company shall have the burden of proof in any dispute as to whether Centerview acted with bad faith, gross negligence or willful misconduct). For the avoidance of doubt, it is understood and agreed that if the proceeds of any such Financing are to be funded in more than one stage, Centerview shall be paid 100% of its applicable compensation hereunder upon the closing date of the initial stage; provided however if material contingencies exist to the funding of any commitments contemplated by sub-paragraphs (c)(i)-(c)(iv) of this Paragraph 2, the Company and Centerview will discuss in good faith alternative Financing Fees or Financing Fee structures with respect to such commitments in lieu of an upfront payment of 100% of Financing Fees related thereto, but shall not be obligated to agree on any such alternative structures. Any agreement on an

alternative Financing Fee or Financing Fee structure contemplated by the previous sentence shall be set forth in writing signed by the Company and Centerview.

- d. If during the term of the Agreement and in conjunction with a Transaction, the Company, either directly or through any of its subsidiaries, consummates a material amendment out-of-court to its existing bank debt and/or existing Series X preferred equity that requires substantial involvement from Centerview, then the Company will pay Centerview a fee of \$1,000,000 and may, in its sole and absolute discretion, pay Centerview an additional fee of up to \$2,000,000. For clarity, material amendments shall include amendment to existing financial covenants, modifications to the interest rate from cash pay to PIK only or other non-financial covenants that require support from Required Lenders under the existing bank debt and/or existing Series X preferred equity. Any fee payable under this subparagraph 2(d) shall be 100% credited against any fees paid or payable under subparagraph 2(b). Notwithstanding anything in subparagraph 2(c) above to the contrary, any Financing Fee earned by Centerview shall be reduced by 50% to the extent the Financing is provided by any holder(s) of the Company's equity or debt as of the date of this Agreement ("Current Investors").

The Company acknowledges and agrees that Centerview's capital markets/financing knowledge was an important factor in determining the amount of the various fees set forth herein, and that the ultimate benefit to the Company of Centerview's services hereunder could not be measured merely by reference to the number of hours to be expended by Centerview's professionals in the performance of such services. The Company also acknowledges and agrees that the various fees set forth herein have been agreed upon by the parties in anticipation that a substantial commitment of professional time and effort will be required of Centerview and its professionals hereunder over the life of the engagement, and in light of the fact that such commitment may foreclose other opportunities for Centerview and that the actual time and commitment required by Centerview and its professionals to perform its services hereunder may vary substantially from week to week or month to month, creating "peak load" issues for the firm. In addition, given numerous issues which Centerview may be required to address in the performance of its services hereunder, Centerview's commitment to the variable level of time and effort necessary to address all such issues as they arise, and the market prices for Centerview's services for engagements of this nature in an out-of-court context, each party hereto agrees that the fee and expense arrangements hereunder are reasonable under all applicable legal standards.

The Company and Centerview acknowledge and agree that more than one fee may become payable to Centerview under subparagraphs 2(b), 2(c) and/or 2(d) hereof in connection with a Transaction. It is understood and agreed that if more than one fee becomes so payable to Centerview in connection with a Transaction, each such fee, without duplication, shall be paid to Centerview, subject to applicable credits as provided in this paragraph 2. For the avoidance of doubt, Centerview shall not be entitled to and Company shall not be obligated to pay more than one fee under any subparagraph in 2(c) with respect to the same amounts of capital raised in any Financing.

3. In addition to the fees payable by the Company to Centerview hereunder, the Company shall, whether or not any Transaction shall be proposed or consummated, reimburse Centerview upon the earlier of (a) consummation of a Transaction or (b) termination of

this Agreement, for its reasonable, documented travel and other reasonable, documented out-of-pocket expenses (including all fees, disbursements and other charges of counsel to be retained by Centerview, and of other consultants and advisors retained by Centerview with the Company's consent), incurred in connection with, or arising out of Centerview's activities under or contemplated by this engagement; provided, that all such expenses in the aggregate shall not exceed \$50,000 without the Company's prior written consent. The Company shall also reimburse Centerview, at such times as Centerview shall request, for any sales, use or similar taxes (including additions to such taxes, if any) arising in connection with any matter referred to in, or contemplated by, this engagement. Such reimbursements shall be made promptly upon submission by Centerview of statements for such expenses. It is understood and agreed that nothing contained herein shall be deemed to limit in any manner the indemnification, expense reimbursement and other obligations of the parties contained in the Indemnification Agreement attached hereto as Annex A.

4. The Company and Centerview have entered into a separate letter agreement, dated the date hereof and attached hereto as Annex A (the "Indemnification Agreement"), providing for indemnification by the Company of Centerview and certain related persons. Such Indemnification Agreement is an integral part of this Agreement and the terms thereof are incorporated by reference herein. As stated therein, the Indemnification Agreement shall survive any termination or completion of Centerview's engagement hereunder.
5. The Company agrees that neither Centerview nor any of its affiliates, their respective members, directors, officers, employees and controlling persons, and each of their respective successors and assigns (collectively, the "Centerview Persons" and each individually, a "Centerview Person") shall have any liability (whether direct or indirect, in contract, tort or otherwise) to the Company or any person asserting claims on behalf of or in right of the Company for or in connection with this engagement or any transactions or conduct in connection herewith, except to the extent that any losses, claims, damages or liabilities incurred by the Company are finally judicially determined to have resulted directly from the bad faith, fraud, willful misconduct or gross negligence of such Centerview Person. For purposes of this Agreement and the Indemnification Agreement, "fraud" shall mean actual fraud committed willfully and knowingly with the specific intent to deceive and mislead.
6. Centerview agrees that all non-public information concerning the Company and its affiliates and the possible Transaction, including the fact that either discussions or negotiations are taking place concerning the Transaction, including the status thereof as well as the Company's participation in the Transaction, as well as the existence or terms and conditions of this Agreement, which is provided to Centerview in connection with this engagement hereunder, will be treated in accordance with the Unilateral Nondisclosure Agreement, by and between the Company and Centerview, dated March 15, 2023.
7. This Agreement, and Centerview's engagement hereunder will be effective as of the date first written above (the "Effective Date") and will automatically terminate upon the earliest to occur of: (a) on the date that is twelve months after the Effective Date hereof, (b) termination of this Agreement by the Company for Cause; or (c) terminated earlier as set forth in this paragraph 7. This Agreement and Centerview's engagement hereunder may be

terminated by either the Company or Centerview at any time upon 10 days' prior written notice thereof to the other party; provided, however, that (A) termination of Centerview's engagement hereunder shall not affect a party's continuing obligations under the Indemnification Agreement, and its continuing obligations and agreements under paragraphs 6 and 8 hereof, (B) notwithstanding any such termination, Centerview shall be entitled to the full fees in the amounts and at the times subject to and as provided for in paragraph 2 hereof and subject to the last sentence of this Section 7, and (C) other than termination by Centerview or by the Company for Cause termination of Centerview's engagement hereunder shall not affect the Company's obligation to reimburse the expenses accrued prior to such termination to the extent provided in paragraph 3 hereof. [Centerview and the Company agree that the Fee Period with respect to Financings (other than DIP Financings or Financings preceded by a Restructuring (each, an "Excluded Financing") shall terminate upon an automatic termination of this Agreement upon the consummation of a Financing (other than an Excluded Financing) for which Centerview has been paid a Financing Fee pursuant to the terms of this Agreement and no additional Financing Fees shall be payable thereafter, except with respect to (i) any Excluded Financing or (ii) any Transaction for which a fully-executed and delivered term sheet, letter of intent or similar document was in place prior to the time of such automatic termination of this Agreement if such Transaction is consummated within the Tail Period materially in accordance with the terms of such term sheet, letter of intent or similar document and Centerview provides the services set forth Section 1 with respect to such Transaction.]

8. Centerview has been retained under this Agreement as an independent contractor with duties owed solely to the Company, and the Company acknowledges that Centerview is not acting as an agent of the Company or in a fiduciary capacity, whether pursuant to contract or otherwise, with respect to the Company or its stockholders, employees, creditors or any other third party. The advice (oral or written) rendered by Centerview pursuant to this Agreement is intended solely for the benefit and use of the senior management, officers and managers or Board of Directors of the Company (in their capacity as such and not in any individual capacity) in considering the matters to which this Agreement relates, and the Company agrees that such advice may not be relied upon by any other person, used for any other purpose or reproduced, disseminated, quoted or referred to at any time, in any manner or for any purpose, nor shall any public references to Centerview be made by the Company, in each case without Centerview's prior written consent; provided, however, that any advice or information may be disclosed on a strictly confidential non-reliance basis (a) to the employees not covered above of the Company (in their capacities as such) and its subsidiaries and (b) to the outside law firm, tax consultants or accounting firm (but only for review purposes and not for incorporation into any of such accounting firm's work and not for valuation purposes) of the Company who reasonably need to know such information in order to assist the Company's senior management and board of directors in their evaluation of a Transaction. Notwithstanding the foregoing, in the event that the Company is legally required (by interrogatory, request for information or documents, subpoena, deposition, civil investigative demand or otherwise) to disclose any of the foregoing information, the Company will, if legally permissible, provide Centerview with prompt written notice of any such requirement so that Centerview may seek an appropriate protective order or waive the Company's compliance with the provisions of this paragraph. If, failing the entry of a protective order or the receipt of a waiver

hereunder, the Company is, in the opinion of its counsel, compelled to disclose any such information, it may disclose that portion of the information which the Company's counsel advises it that it is compelled to disclose. In any event, the Company will not oppose, and will reasonably cooperate in, any action by Centerview to obtain an appropriate protective order or other reliable assurance that confidential treatment will be accorded any such information. Centerview is not assuming any duties or obligations other than those expressly set forth in this Agreement. The Company may disclose the existence of this Agreement, Centerview's role as advisor and the fees payable hereunder to the counterparties in connection with a Transaction.

Notwithstanding anything to the contrary herein, the Company and each of its employees, representatives and other agents may disclose to any and all persons the U.S. income and franchise tax treatment and the U.S. income and franchise tax structure of the Transaction contemplated hereby and materials (including opinions or other tax analyses, if any) that are provided to the Company relating to such tax treatment and tax structure insofar as such treatment and/or structure relates to a U.S. income or franchise tax strategy, if any provided to the Company by Centerview or its affiliates.

9. The Company agrees that following the public announcement by the Company of the matters that are the subject of this Agreement, Centerview shall have the right to place advertisements in financial and other newspapers and journals and in marketing materials at its own expense describing its services to the Company hereunder, subject to the review and approval of the Company. Notwithstanding the foregoing, upon such public announcement of a Transaction, Centerview shall, without the Company's consent, have the right to include a "tombstone" with respect to such Transaction on its web-site or in any "pitch-book" or similar marketing materials to the extent such tombstone does not include any information not previously publicly disclosed by the Company.
10. Intentionally Omitted.
11. This Agreement shall be deemed made in New York. This Agreement and all controversies arising from or relating to performance hereunder shall be governed by, and construed in accordance with, the laws of the State of New York applicable to agreements made and to be performed entirely in such State, without giving effect to such State's rules concerning conflicts of laws that might provide for any other choice of law. Each of the Company and Centerview agree that any action or proceeding based hereon, or arising out of Centerview's engagement hereunder, shall be brought and maintained in the courts of the State of New York located in the City and County of New York or in the United States District Court for the Southern District of New York. The Company and Centerview each hereby irrevocably submit to the jurisdiction of the courts of the State of New York located in the City and County of New York or in the United States District Court for the Southern District of New York for the purpose of any such action or proceeding as set forth above. Each of the Company and Centerview hereby irrevocably waive, to the fullest extent permitted by law, any objection which it may have or hereafter may have to the laying of venue of any such action or proceeding brought in any such court referred to above and any claim that any such action or proceeding has been brought in an inconvenient forum and agree not to plead or claim the same. THE COMPANY (FOR ITSELF, ANYONE

CLAIMING THROUGH IT OR IN ITS NAME, AND, TO THE EXTENT PERMITTED BY APPLICABLE LAW, ON BEHALF OF ITS EQUITY HOLDERS) AND CENTERVIEW EACH HEREBY IRREVOCABLY WAIVE ANY RIGHT THEY MAY HAVE TO A TRIAL BY JURY IN RESPECT OF ANY CLAIM BASED UPON OR ARISING OUT OF THIS AGREEMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY.

12. This Agreement may be executed in counterparts, each of which together shall be considered a single document. This Agreement may not be assigned by either party without the prior written consent of the other. This Agreement shall be binding upon Centerview and the Company and their respective successors and permitted assigns. This Agreement is not intended to confer any rights upon any shareholder, creditor, owner or partner of the Company, or any other person or entity not a party hereto, other than the Indemnified Persons referenced in the Indemnification Agreement attached hereto as Annex A and the Centerview Persons referenced in paragraph 5 hereof. This Agreement and the Indemnification Agreement constitute the entire agreement of the parties with respect to the subject matter hereof, and may not be amended or otherwise modified or its provisions waived except by a writing executed by Centerview and the Company.
13. Centerview is engaged directly and through its affiliates and related parties in a number of investment banking, financial advisory and merchant banking activities. The Company acknowledges and agrees that in performing its services for the Company hereunder, Centerview shall have no duty to disclose to the Company, or to use for the benefit of the Company, any proprietary or non-public information obtained by Centerview or its affiliates or related parties in the course of providing services to any other entity or person, engaging in any transaction (including as principal) or otherwise conducting its business. Notwithstanding anything to the contrary contained herein, Centerview agrees that during the term of its engagement hereunder, it shall not be engaged to provide financial advisory services to any other party with respect to such party's entering into a Transaction without obtaining the prior written consent of the Company.

We are pleased to accept this engagement and look forward to working with the Company. Please confirm that the foregoing is in accordance with our mutual understanding by signing and returning to Centerview this letter and the Indemnification Agreement attached hereto as Annex A, which shall thereupon constitute binding agreements between Centerview and the Company.

In connection with the engagement (the “Engagement”) of Centerview Partners LLC (“Centerview”) by the undersigned (the “Company”) to render financial advisory services to the Company pursuant to a letter agreement dated the date hereof (the “Engagement Agreement”), the Company hereby agrees as follows:

1. Except as provided in paragraph 3 hereof, the Company agrees to indemnify and hold harmless the Centerview Persons (as defined below) from and against any and all losses, claims, damages, demands and liabilities, joint or several, or actions or proceedings in respect thereof, brought by or against any person, (including, without limitation, by the Company against any Centerview Person and vice versa) but excluding by one Centerview Person against one or more other Centerview Persons (collectively, “Losses”), which are related to or arise out of the Engagement Agreement, the Engagement or any matter or transaction contemplated thereby. 2. The Company, subject to the reimbursement obligation set forth in this paragraph 2 hereof, agrees to reimburse Centerview and each other Centerview Person promptly upon request for all costs and expenses (including fees, disbursements and other charges of legal counsel), as they are incurred in connection with investigating, preparing for, pursuing, defending against or providing evidence in, any pending or threatened action, claim, suit, investigation or other proceeding brought by or against any person, including, without limitation, if Centerview is successful on the merits, by the Company against any Centerview Person and vice versa, in any jurisdiction related to or arising out of the Engagement Agreement, the Engagement or any matter or transaction contemplated thereby (whether or not Centerview or any other Centerview Person is a named party or witness, and whether or not any liability to any person results therefrom), including, without limitation, in connection with enforcing the terms hereof (collectively, “Expenses”), and such Centerview Person shall repay to the Company any costs and expenses theretofore reimbursed by the Company to such Centerview Person pursuant to this paragraph 2 that are reasonably attributable to Losses that are finally judicially determined to have resulted from the bad faith, willful misconduct, fraud or gross negligence of any Centerview Person as specified in paragraph 3 hereof.

3. Notwithstanding the foregoing, the Company shall have no obligation to indemnify and hold harmless any Centerview Person under this letter agreement in respect of any Losses to the extent that such Losses are finally judicially determined to have resulted from the willful misconduct, bad faith, fraud or gross negligence of any Centerview Person or from the material breach of confidentiality.
4. The Company agrees that it will not, without Centerview's prior written consent, which consent, in the case of any action, claim, suit, investigation or proceeding to which a Centerview Person is not a named party, shall not be unreasonably withheld, delayed or conditioned, settle, compromise, consent to the entry of any judgment in or otherwise seek to terminate any pending or threatened action, claim, suit, investigation or proceeding in respect of which indemnification or contribution may be sought hereunder (whether or not Centerview or any other Centerview Person is an actual or potential party thereto) unless such settlement, compromise, consent or termination includes an unconditional release of each Centerview Person from all liability arising out of such action, claim, suit, investigation or proceeding and does not impose any monetary or financial obligation on any Centerview Person or contain any admission of culpability or liability on the part of any Centerview Person. No Centerview Person seeking indemnification, reimbursement or contribution under this letter agreement will, without the Company's prior written consent (which consent, in the case of any action, claim, suit, investigation or proceeding to which the Company or any of its or its affiliates' directors, officers, managers, or employees is not a named party, shall not be unreasonably withheld or delayed), settle, compromise, consent to the entry of any judgment in or otherwise seek to terminate any action, claim, suit, investigation or proceeding referred to herein. Notwithstanding anything herein to the contrary, the Company will not be liable under this letter agreement for any settlement or other compromise that (i) purports to bind the Company or require any action of the Company (other than payment of any fees or expense reimbursement set forth in paragraphs 2 or 3 of this letter agreement) and (ii) is entered into without the Company's prior written consent, it being understood that this sentence shall not apply with respect to any settlement or other compromise for which the Company is finally judicially determined to have unreasonably withheld its consent.
5. Centerview shall provide written notice (an "Indemnity Notice") to the Company as promptly as practicable after receipt of written notice of any claim for which a Centerview Person is seeking indemnification or expense reimbursement under this letter agreement; provided, however, that failure by Centerview to so notify the Company in writing shall not relieve the Company from its obligations hereunder except to the extent the Company is materially prejudiced thereby. If any Centerview Person is entitled to indemnification under this letter agreement with respect to any civil action or proceeding for monetary damages only brought by a third party (other than the Company or its stockholders), the Company shall, upon written notice to Centerview within three business days after receipt by the Company of an Indemnity Notice, be entitled to assume the defense of any such action or proceeding with counsel reasonably satisfactory to Centerview and, upon such election, the Company shall not be liable for any legal costs subsequently incurred by any Centerview Person in connection therewith. For the avoidance of doubt, prior to the Company's assumption of the defense of any such action or proceeding, the Centerview Person shall be entitled to conduct such defense subject to the Company's rights hereunder.

Notwithstanding the foregoing, the Company shall not have the right to assume the defense of such action or proceeding on any Centerview Person's behalf and Centerview will have the right to employ separate counsel for such defense (including local counsel, to the extent required) if: (a) the Company shall have failed to employ counsel reasonably satisfactory to Centerview in a timely manner or to timely provide the written notice described in the immediately preceding sentence; or (b) the Centerview Person shall have been advised by counsel that there are actual or potential conflicting interests between the Company or any of its directors or officers and the Centerview Person, including but not limited to situations in which there are one or more legal defenses available to the Centerview Person that are different from or additional to those available to the Company, where different claims have been brought against a Centerview Person and the Company or any of its directors or officers or where any Centerview Person has been called as a witness against the Company or any of its directors or officers; provided, however, that the Company shall not, in connection with any one such action or proceeding or separate but substantially similar actions or proceedings arising out of the same general allegations, be liable for the fees and expenses of more than one separate firm of attorneys at any time for all Centerview Persons, including Centerview, except to the extent that local counsel, in addition to its regular counsel, is required in order to effectively defend against such action or proceeding.

6. If the foregoing indemnification provided for herein is determined to be unavailable to a Centerview Person for any reason or is insufficient to hold it harmless in respect of any Losses referred to herein, then, in lieu of indemnifying such Centerview Person hereunder, the Company shall contribute to the amount paid or payable by such Centerview Person as a result of such Losses (and expenses related thereto) (i) in such proportion as is appropriate to reflect the relative benefits to the Company, on the one hand, and to Centerview, on the other hand, with respect to the Engagement but also the relative fault of each of the Company, together with its officers, directors, employees, stockholders, affiliates and other advisors, on the one hand, and Centerview or any Centerview Person, on the other hand, and any other relevant and equitable considerations; provided, however, that, except with respect to any Losses that are finally judicially determined to have resulted from the bad faith, willful misconduct, fraud or gross negligence of any Centerview Person, in no event shall the aggregate contribution of the Centerview Persons to the amounts so paid or payable exceed the aggregate amount of all fees actually received by Centerview from the Company in connection with the Engagement (excluding any amounts received by Centerview as reimbursement of expenses pursuant to the Engagement Agreement). For purposes of this letter agreement, the relative benefit to the Company and Centerview of the Engagement shall be deemed to be in the same proportion as (a) the total value paid or contemplated to be paid or received or contemplated to be received by the Company in the transaction or transactions that are the subject of the Engagement, whether or not such transaction is proposed or completed, bears to (b) the fees paid or to be paid to Centerview under the Engagement Agreement.
7. Notwithstanding anything to the contrary contained herein, in any action to enforce the provisions of the Engagement Agreement or this Annex A, all of the reasonable out-of-pocket costs and expenses (including reasonable fees and expenses of counsel) of the prevailing party (it being understood that the determination as to which party prevailed

shall be made by the court in a finally judicially determined action) in such action shall be borne by the non-prevailing party.

8. This letter agreement shall be deemed made in New York. This letter agreement and all controversies arising from or relating to performance hereunder shall be governed by, and construed in accordance with, the laws of the State of New York applicable to agreements made and to be performed entirely in such State, without giving effect to such State's rules concerning conflicts of laws that might provide for any other choice of law. Each of the Company and Centerview agrees that any action or proceeding based on, arising out of or resulting from any matter referred to in this letter agreement, shall be brought and maintained exclusively in the courts of the State of New York located in the City and County of New York or in the United States District Court for the Southern District of New York. The Company and Centerview each hereby irrevocably submits to the jurisdiction of the courts of the State of New York located in the City and County of New York or in the United States District Court for the Southern District of New York for the purpose of any such action or proceeding as set forth above, and irrevocably agrees to be bound by any judgment rendered thereby in connection with such action or proceeding. Each of the Company and Centerview hereby irrevocably waives, to the fullest extent permitted by law, any objection which it may have or hereafter may have to the laying of venue of any such action or proceeding brought in any such court referred to above and any claim that any such action or proceeding has been brought in an inconvenient forum, and agree not to plead or claim the same. ANY RIGHTS OF TRIAL BY JURY WITH RESPECT TO ANY CLAIM, COUNTERCLAIM OR ACTION ARISING OUT OF THIS LETTER AGREEMENT ARE HEREBY WAIVED.
9. The indemnity, contribution, reimbursement and other obligations of the Company hereunder shall be in addition to any liability that the Company may have, at common law or otherwise, and shall be binding on its successors and permitted assigns. The obligations of the Company hereunder cannot be assigned without the prior written consent of Centerview.
10. The terms of this letter agreement shall apply to all services provided by Centerview to the Company in connection with the matters contemplated by the Engagement, including those provided prior to the date of this letter agreement. The provisions of this letter agreement shall apply to any subsequent amendment to or modification of the Engagement Agreement, and shall survive the termination of the Engagement Agreement or completion of any transaction contemplated by the Engagement Agreement. The provisions of paragraph 11 of the Engagement Agreement are incorporated by reference into this letter agreement.
