SUPPLEMENT TO DANIELLE BECK. PROOF OF CLAIM

<u>Basis</u>: Danielle Beck ("<u>Beck</u>") submits this Supplement in support of its prepetition proof of claim (the "<u>Claim</u>") filed in the above-captioned chapter 11 case.

Claim: Beck's Claim against Thrasio, LLC.
