1. On November 14, 2023, the court held a hearing (the “Hearing”) on the *Liquidating Trustee’s First Omnibus Objection to (I) Insufficient Documentation Claims, (II) Amended and Superseded Claims, (III) Equity Claims, and (IV) Late Filed Claims (Non-Substantive)* (the “Objection”) with respect to Claim No. 188 filed by David Bonita and Claim No. 189 filed by Klaus Veitinger. At the conclusion of the Hearing, the Court ruled that it would sustain the Objection with respect to Claim No. 188 filed by David Bonita and Claim No. 189 filed by Klaus Veitinger.

**ORDER SUSTAINING THE LIQUIDATING TRUSTEE’S FIRST OMNIBUS
OBJECTION TO (I) INSUFFICIENT DOCUMENTATION CLAIMS,
(II) AMENDED AND SUPERSEDED CLAIMS, (III) EQUITY CLAIMS, AND
(IV) LATE FILED CLAIMS (NON-SUBSTANTIVE) WITH RESPECT TO CLAIM NO.
188 FILED BY DAVID BONITA AND CLAIM NO. 189 FILED BY KLAUS VEITINGER**

Upon consideration of the *First Omnibus Objection to (I) Insufficient Documentation Claims, (II) Amended and Superseded Claims, (III) Equity Claims, and (IV) Late Filed Claims (Non-Substantive)* (the “Objection”)² with respect to Claim No. 188 filed by David Bonita and Claim No. 189 filed by Klaus Veitinger; and it appearing that notice of the Objection was good and sufficient upon the particular circumstances and that no other or further notice need be given; it is hereby

FOUND AND DETERMINED THAT:

- A. The Objection is a core proceeding under 28 U.S.C. § 157(b)(2).
- B. This Court has authority to enter a final order in this matter consistent with Article III of the United States Constitution.

IT IS THEREFORE ORDERED THAT:

1. The Objection is SUSTAINED for the reasons set forth on the record at the November 14, 2023 hearing in this matter.
2. Claim No. 188 filed by David Bonita is hereby disallowed and expunged.
3. Claim No. 189 filed by Klaus Veitinger is hereby disallowed and expunged.
4. Each Claim and the objections by the Liquidating Trustee to such Claim, as addressed in the Objection, constitutes a separate contested matter as contemplated by Bankruptcy Rule 9014 and Local Rule 3007-1. This Order shall be deemed a separate Order with respect to Claim No. 188 filed by David Bonita and Claim No. 189 filed by Klaus Veitinger.
5. This Court shall retain jurisdiction over any matters related to or arising from the implementation of this Order.
