This Stipulation is entered between the Liquidating Trustee (the "Liquidating Trustee") of the VHS Liquidating Trust, established pursuant to the *Modified Second Amended Joint Chapter 11 Plan of Liquidation (Dated July 2, 2020) of the Debtors, the Prepetition Secured Creditors, and the Committee* [Docket No. 5466], confirmed by the order [Docket No. 5504] entered August 14, 2020, and that certain Liquidating Trust Agreement, dated as of September 5, 2020 [Docket No. 6043], on the one hand, and the California Attorney General, on the other, with respect to the following:

- 1. On December 11, 2024, the Liquidating Trustee filed the *Motion for Authority to Use Restricted Funds* [Docket No. 6817] (the "Motion to Use Restricted Funds").
- 2. The Court set a hearing on the Motion to Use Restricted Funds for January 8, 2025, at 1:00 p.m. (the "<u>Hearing Date</u>"). The deadline to respond to the Motion to Use Restricted Funds is December 26, 2024 (the "<u>Response Deadline</u>").
- 3. The California Attorney General has requested a continuance of the Hearing Date and an extension of the Response Deadline and the Liquidating Trustee has agreed.

NOW THEREFORE all of the parties to this Stipulation hereby stipulate and agree as follows:

- A. The Hearing Date shall be continued from January 8, 2025, to January 29, 2024, at 1:00 p.m.
- B. The California Attorney General's Response Deadline shall be extended from December 26, 2024, to January 15, 2025.
