The Court, having reviewed the *Stipulation Continuing Hearing Date and Extending Deadline for California Attorney General Re Motion for Authority to Use Restricted Funds* (the “Stipulation”), filed as Docket No. 6828, entered between the Liquidating Trustee (the “Liquidating Trustee”) of the VHS Liquidating Trust, established pursuant to the *Modified Second Amended Joint Chapter 11 Plan of Liquidation (Dated July 2, 2020) of the Debtors, the Prepetition Secured Creditors, and the Committee* [Docket No. 5466], confirmed by the order [Docket No. 5504] entered August 14, 2020, and that certain Liquidating Trust Agreement, dated as of September 5, 2020 [Docket No. 6043], on the one hand and the California Attorney General, on the other, and good cause appearing,

IT IS HEREBY ORDERED as follows:

1. The Stipulation is approved;
2. The hearing date to consider the *Motion for Authority to Use Restricted Funds* [Docket No. 6817] (the “Motion to Use Restricted Funds”) shall be continued from January 8, 2025 to January 29, 2025 at 2:00 p.m.; and
3. The California Attorney General’s deadline to respond to the Motion to Use Restricted Funds is extended from December 26, 2024 to January 15, 2025.
