The Court, having reviewed the *Stipulation Continuing Hearing Date and Extending Reply Deadline Re Motion for Authority to Use Restricted Funds* (the “Stipulation”), filed as Docket No. 6850, entered between the Liquidation Trustee (the “Liquidation Trustee”) of the VHS Liquidation Trust, established pursuant to the *Modified Second Amended Joint Chapter 11 Plan of Liquidation (Dated July 2, 2020) of the Debtors, the Prepetition Secured Creditors, and the Committee* [Docket No. 5466], confirmed by the order [Docket No. 5504] entered August 14, 2020, and that certain Liquidation Trust Agreement, dated as of September 5, 2020 [Docket No. 6043], on the one hand and the California Attorney General, on the other, and good cause appearing,
