**ORDER APPROVING
SOLIC INTERIM FEE APPLICATION FOR ALLOWANCE OF
THE SALE TRANSACTION FEE FOR THE LIBRARY ASSETS**

Upon consideration of the interim fee application (the “SOLIC Interim Fee Application”)2 of GBH SOLIC Holdco, LLC and SOLIC Capital, LLC (collectively, the “SOLIC”), a summary of which is attached hereto as **Exhibit A**, for allowance of compensation in the form of the Sale Transaction Fee for the Library Assets on an interim basis, and it appearing to this Court that all of the requirements of sections 327, 328, 330, 331 and 503(b) of title 11 of the United States Code, 11 U.S.C. §§ 101–1532, as well as Rule 2016 of the Federal Rules of Bankruptcy Procedure, and Rule 2016-1 of the Local Rules of the United States Bankruptcy Court for the District of Delaware, have been satisfied; and it further appearing that the compensation earned was reasonable and necessary; and that the notice of the SOLIC Interim Fee Application was appropriate; and after due deliberation and sufficient good cause appearing therefor,

2. SOLIC is granted interim allowance of compensation in the form of the Sale Transaction Fee for the Library Assets in the amount set forth on **Exhibit A** attached hereto.
3. The Debtors are authorized and directed, as provided herein, to remit, or cause to be remitted, payment to SOLIC in the amount set forth on **Exhibit A** hereto, less any and all amounts previously paid on account of such fees.
4. This Court shall retain jurisdiction with respect to all matters relating to the interpretation or implementation of this Order.
