## MOTION TO ALLOW THE TRUSTEE TO FILE AN ABBREVIATED FINAL REPORT

**COMES NOW** Andre M. Toffel (the "Trustee"), duly appointed interim Chapter 7 trustee of the above named bankruptcy estate of the Debtor and as the liquidating trustee of the liquidating trust (the "Liquidating Trust"), created in connection with the October 13, 2017 settlement agreement (the "Settlement Agreement") with Warrior Met Coal, Inc. 4. This case was kept open in this Court to assist the administration by the Liquidating Trust.

5. In the near future, it will no longer be necessary for this case to remain open.

6. Toffel has been administering the assets as part of the Liquidating Trust since 2017 and has diligently managed the Liquidating Trust in the same manner as he has done with bankruptcy and other cases for many years.

7. The Liquidating Trust will administer any remaining assets and pay the balance of funds it has to the remaining 11 U.S.C. section 503(b)(9) claimants after all administrative expenses are paid. Subsequently, the Liquidating Trust will be terminated.

8. It is the best interests of the Court, the Bankruptcy Administrator, the Creditors, and the Liquidating Trust for Toffel to file a short Final Report stating that all assets in the Bankruptcy Estate have been administered and that he be discharged from further duties in this Chapter 7 case.
