paid from the Debtors' estates as an administrative expense under section 503(b)(2) of the

Bankruptcy Code.

2. All services for which compensation is requested by DFR were performed for or on behalf of

the bankruptcy estate and not on behalf of any committee, creditor or other person.

3. There is no agreement or understanding between DFR and any other person other than

members of DFR for sharing of compensation to be received for services in these cases.

SUMMARY OF SERVICES RENDERED

4. Attached hereto as Exhibit A are the DFR billing statements for the Fee Period showing the

amount of \$2,480.00 due for fees and a detailed statement of expenses paid during the Fee
