**ADDENDUM TO PROOF OF CLAIM OF
BEAVER VALLEY SLAG, INC.**

1. Beaver Valley Slag, Inc. (“**BVS**” or “**Claimant**”) asserts the within claim (“**Proof of Claim**”) against Welded Construction, L.P. (the “**Debtor**”).

2. On October 22, 2018 (the “**Petition Date**”), the Debtor commenced the instant bankruptcy case (the “**Bankruptcy Case**”) by filing a voluntary petition for relief under chapter 11 of title 11 of the United States Code (the “**Bankruptcy Code**”) in the United States Bankruptcy Court for the District of Delaware (the “**Court**”).

3. Pursuant to various prepetition contracts (“**Contracts**”) with the Debtor, BVS provided certain equipment used by the Debtor for its operations.

4. The instant claim relates to unpaid prepetition balances on the Contracts and repair costs incurred by BVS as a result of damage caused by the Debtors to the equipment. True and correct copies of invoices related to such unpaid prepetition balances and the repairs are attached to the Proof of Claim.

5. Claimant reserves the right to amend or supplement this proof of claim, and/or file additional proofs of claim for additional claims or interests at any time, either before or after the Bar Date established by the Court.

6. The filing of the Proof of Claim is not (i) a waiver or release of the rights of Claimant against any person, entity or property; (ii) a consent by Claimant to the jurisdiction of the Court with

respect to the subject matter of the Proof of Claim, any objection or other proceeding commenced in this case against or otherwise involving Claimant; (iii) a waiver of the right to move to withdraw the reference, or otherwise to challenge the jurisdiction of the Court, with respect to the subject matter of the Proof of Claim, any objection or other proceeding commenced with respect thereto or any other proceeding commenced in this case against or otherwise involving Claimant, or to assert that the reference has already been withdrawn with respect to the subject matter of the Proof of Claim, any objection or other proceeding commenced with respect thereto or any other proceeding commenced in this case against or otherwise involving Claimant; (iv) an election of remedy; or (v) a waiver of any past, present or future defaults or events of default. Claimant specifically preserves all of its procedural and substantive defenses and rights with respect to any claim that may be asserted against it by the Debtor or by any trustee for the Debtor's estate.
