**SUPPLEMENTAL CERTIFICATE OF SERVICE**

I, Heather Fellows, depose and say:

1. I am employed by Kurtzman Carson Consultants LLC (“**KCC**”), the claims, noticing and administrative agent for the Debtors in the above-captioned cases. I submit this supplemental certificate in connection with the service of solicitation materials (the “**Solicitation Packages**”) for the *Amended Chapter 11 Plan of Welded Construction, L.P. and Welded Construction Michigan, LLC* [Docket No. 1363] (the “**Plan**”). I am over the age of 18 and not a party to this action. Except as otherwise noted, I could and would testify to the following based upon my personal knowledge.

2. On October 23, 2018, the Court entered the *Order Authorizing the Debtors to Employ and Retain Kurtzman Carson Consultants LLC as Claims and Noticing Agent Effective Nunc Pro Tunc to the Petition Date* [Docket No. 39].

3. On November 15, 2018, the Court entered the *Order Authorizing Employment and Retention of Kurtzman Carson Consultants LLC as Administrative Advisor to the Debtors Effective Nunc Pro Tunc to Petition Date* [Docket No. 233].

4. Consistent with its retention as claims, noticing and administrative agent, KCC is charged with, among other things, the duty of printing and distributing Solicitation Packages to creditors and other interested parties pursuant to the instructions set forth in the *Debtors’ Motion for an Order (I) Approving the Disclosure Statement; (II) Approving Solicitation and Voting Procedures, Including (A) Fixing the Record Date, (B) Approving the Solicitation Packages and Procedures for Distribution, (C) Approving the Form of Ballots and Establishing Procedures for Voting, and (D) Approving Procedures for Vote Tabulation; (III) Scheduling a Confirmation Hearing and Establishing Notice and Objection Procedures; and (IV) Granting Related Relief* [Docket No. 1284] (the “**Motion**”) filed by the Debtors on March 18, 2020 and the *Order (I) Approving the Disclosure Statement; (II) Approving Solicitation and Voting Procedures, Including (A) Fixing the Record Date, (B) Approving the Solicitation Packages and Procedures for Distribution, (C) Approving the Form of Ballots*

*and Establishing Procedures for Voting, and (D) Approving Procedures for Vote Tabulation; (III) Scheduling a Confirmation Hearing and Establishing Notice and Objection Procedures; and (IV) Granting Related Relief* [Docket No. 1362] (the “**Disclosure Statement Order**”), as entered by the Court on May 7, 2020.

5. The Solicitation Packages consist of the following documents:

- a. if applicable, a flash drive (the “**Flash Drive**”) containing the following documents:
  - i. the *Amended Disclosure Statement for the Amended Chapter 11 Plan of Welded Construction, L.P. and Welded Construction Michigan, LLC* (with all exhibits and attachments thereto) [Docket No. 1364];
  - ii. the Plan; and
  - iii. the Disclosure Statement Order (excluding the exhibits thereto);
- b. either a printed copy of the appropriate Ballot(s) and voting instructions for the voting class in which the creditor is entitled to vote:
  - i. *Class 3 – Surety Bond Claims Ballot* (the “**Class 3 Ballot**”) (substantially in the form attached as Exhibit 3-A to the Disclosure Statement Order);
  - ii. *Class 4 – General Unsecured Claims Ballot* (the “**Class 4 Ballot**”) (substantially in the form attached as Exhibit 3-B to the Disclosure Statement Order);
  - iii. *Class 5 – Convenience Claims Ballot* (the “**Class 5 Ballot**”) (substantially in the form attached as Exhibit 3-C to the Disclosure Statement Order);
- c. or in lieu of a Ballot, the following notice:
  - i. *Notice of Non-Voting Status* (the “**Notice of Non-Voting Status**”) (substantially in the form attached as Exhibit 4 to the Disclosure Statement Order);
- d. the *Notice of Order (I) Approving the Disclosure Statement; (II) Approving Solicitation and Voting Procedures, Including (A) Fixing the Record Date, (B) Approving the Solicitation Packages and Procedures for Distribution, (C) Approving the Form of Ballots and Establishing Procedures for Voting, and (D) Approving Procedures for Vote Tabulation; (III) Scheduling a Confirmation Hearing and Establishing Notice and Objection Procedures; and (IV) Granting Related Relief* [Docket No. 1365] (the “**Confirmation Hearing Notice**”);

- e. if applicable, a *Letter from the Committee* (the “**Committee Support Letter**”) (substantially in the form attached as Exhibit 5 to the Disclosure Statement Order);
- f. if applicable, a pre-addressed, postage prepaid return envelope (the “**Return Envelope**”).
